My thoughts are based on a review of 3 major goals, and a summary of the means of implementation for what I propose to be the most advantageous of the 3.

Potential Districting Goals

A) Maintain equal representation

Advantage: "Fairness"

Problem: Outcomes potentially determined by whims or weather.

B) Consolidate majorities

Advantage: Democracy depends on the will of the majority

Problem: Disenfranchised minorities

C) Seek geographical, cultural, and economic commonality/interdependence

Advantage: Avoiding the problems of A and B

Problem: Complex application

Means of Implementation

C) Districting
331 million ÷ 435 = 760,920
Michigan population est. 2020
10,300,000
÷ 760,920
= 13.5
13 or 14 districts

The aim is to create mostly contiguous districts, centered in population centers, which share cultural and economic bonds, despite possible political diversity, and cooperate locally on infrastructure, education, and welfare. Natural majorities may exist, and will be empowered.

As a counterweight to the urban majorities, large areas of minimal non-urban population will be assembled outside the urban districts, mirroring the same goals, empowering non-urban residents to advocate for shared interests, across party lines.

For example: a 7/6 or 7/7 split, 7 districts based on population centers, working from the center outward, and 6 or 7 working from the outside in.

Greetings. I attended by Zoom this meeting and paid close attention to the discussion on the candidates for the outreach position. My comments stem from my involvement with VNP to help pass Prop 2 and

then prop 3. For me this was nearly a full time job for over a year. My stomping grounds was the U.P. I canvassed areas that I normally would not frequent. What I discovered was neither do politicians nor those running for political office. These communities have been excluded from the process for decades.

While district maps do identify voting districts for representation in state house and senate races as well as congressional house races, the criteria for developing the district maps should be devoid of political party affiliation avoiding partisanship. An outreach person should be that person who can move into communities learning what holds communities together, common needs, encouraging representation not perpetuating differences and under representation. This person should help the commission be seen as inclusive and yet be able to gain an audience in our diverse communities. I would think being bilingual or having success working in Native communities might be HUGE. I believe the commission must be very careful who it hires or this process will be doomed from the start. May I suggest rank choice voting for this outreach person among the commissioners. Sometimes the first tier candidates are the most well known leading to the exclusion of second tier candidates who might actually be a better fit. Rank choice voting encourages consensus as it will allow the commission to identify and select the most favorable candidate over all.

Lastly but most importantly I wish to thank the commissioners for coming together to do this job. I was impressed at the level of commitment to actually hear each other and work together.

To Michigan's Redistricting Commissioners:

As one of the founding members of Voters Not Politicians who (as a volunteer myself) organized volunteers to collect over 425,000 signatures to get Proposal 2 on the ballot, it was a thrill to watch your meeting yesterday. Thank you all so much, not just for your service to all of us in the state of Michigan, but also for your dedication to fairness and democracy. It's amazing to me that the work of thousands of volunteers led to this, and it's heartening that the random selection produced such a thoughtful group of commissioners.

I'd like to comment on the conflict of interest issues that were discussed during the meeting. I absolutely agree that any employee of the commission must have the ability to be impartial. VNP worked hard to develop a policy that would remove partisan bias from the redistricting process. In fact, it was the entire

point of the constitutional amendment. While it's challenging to find professionals who have no partisan affiliation, public confidence in the commission requires that the commission is balanced and that its employees are as unbiased as possible.

However, I don't understand why any prior association with Voters Not Politicians presents a conflict of interest. Should the founding fathers have been disqualified from serving in government because they wrote the constitution? Obviously I don't mean to compare any of us who worked with VNP to the founding fathers, but the point is that we do not have a conflict simply by virtue of working to establish independent redistricting in our state. In fact, it's just the opposite. No one could be more invested in the success of the commission, and in truly fair maps for Michigan, than the more than 6,000 volunteers across the state who spent two years working so hard to make it happen.

Thank you for considering my views. I look forward to witnessing the historic work you will do to bring fairness, impartiality, and transparency to our redistricting process!
