I was a strong supporter of Proposition 2, enthusiastic to see the Michigan constitution amended in 2018 to create the Commission and the new redistricting process. After the 2018 election, I became a member of the board of Voters Not Politicians, joining due to my interest in seeing that Proposition 2 is implemented well. So, I am very concerned about the news this evening that the Commission is preparing to hire Amna Seibold as its Executive Director.

In my opinion, Ms. Seibold does not have the leadership skills required to be a successful Executive Director. The description of the position -- focusing on management, collaboration, and facilitation -- is contrary to what she demonstrated when she was the mayor of East Grand Rapids. As mayor, her leadership style was considered to be top-down and autocratic, and by the end of her second term, she had driven away the support of city commissioners and school board members that she had worked with, leading to her defeat in the 2019 election.
