In addition to the completed application, the following information must be submitted prior to being approved to rent or sell bingo or millionaire party equipment or to sell charity game tickets:

1. A cover letter detailing the business experience, past and present, of the applicant, each owner, shareholder, and officer listed on the application.
2. Proof of authority to conduct business in Michigan.

Michigan Based Entities:

- a. If incorporated, a copy of your filed Articles of Incorporation.
- b. If a partnership, your Limited Partnership Registration.
- c. If doing business under other than your individual name, a copy of the filed Certificate of Persons Conducting Business Under Assumed Name.
- d. If a Limited Liability Company, your filed LLC paperwork and operating agreement.
- e. A copy of your Michigan Sales Tax License.
- f. Fingerprint cards completed by and for each of the owners, shareholders, and officers. These can be completed at your local law enforcement office.

Out of State Entities:

- a. A copy of your Use Tax Registration.
 - b. Articles of Incorporation, partnership agreement, or other legal document that allows your company to do business in its home state.
 - c. If incorporated, a copy of your Certificate of Authority to Transact Business in Michigan, issued by the Michigan Department of Commerce.
3. If your business intends to rent or sell millionaire party equipment, submit an itemized price list, with an effective date, for all millionaire party equipment and services you intend to provide that is in compliance with Supplier Rule 805(2).
