RULES AND GUIDELINES

- Alcohol permits are only issued if you have rented a shelter or obtained permission for a designated event space on department managed lands where alcohol is prohibited.
- This permit will only be issued at department facilities with ban on alcohol, to the occupant of a department shelter/event space. The organization/person renting the shelter/event space shall have ultimate responsibility for the actions and conduct of their guests. No permits will be issued for general use of the park unless approved by Park Supervisor or Park Manager.
- Persons under the age of 21 shall not be permitted to possess or consume alcoholic beverages. Anyone under the age of 21 found in possession of an alcoholic beverage will be ticketed and be subject to prosecution. The Permittee shall be responsible for making sure persons under the age of 21 are neither in possession of nor consuming alcoholic beverages.
- Alcoholic beverages must be kept within 25 feet of the rented shelter/event space and are not permitted in parking lot areas. Any person found outside of this designated shelter/event space with an alcoholic beverage may be ticketed and subject to prosecution.
- This permit may be revoked by Michigan State Police and Conservation Officers and/or Park Officers upon Park Manager, Park Supervisor and/or Park Ranger's request due to violations of the above conditions and/or any other Michigan State Park Rules and Regulations and/or Michigan State Laws.
- All public events where alcohol is sold, furnished or given away must obtain a special liquor license from the Michigan Liquor Control Commission.
- Permit holder agrees to indemnify and hold the City of Detroit, the State of Michigan, their departments, boards, agencies, commissions, officers, and employees harmless from all liability because of injury to persons or property arising out of the use of alcohol for which this permit is granted.
- A valid ID for the Permittee must be submitted with the permit request.
- The permit and a non-refundable alcohol permit fee of \$100 is due upon submission.
