Fire Marshal Sehlmeyer: Was contacted regarding the passing of Chief Dave Duffield from the Otsego County Fire Department.

V. STATE FIRE MARSHAL'S REPORT:

- a) Certification Specialist Position Filled: Fire marshal introduced Liam Carroll as the new Certification Specialist at the Bureau of Fire Services. Liam is coming from Schoolcraft College.
- **b)** Revised Course Summary (*Handouts*): Fire marshal provided council with handouts for FY21 to give an idea of how courses are going so far this year.
- c) Fatal Fires: As of April 13th, 2021, there have been 44 fatalities in 39 fires.
- d) MI Prevention Update: The disability project is almost complete with a 31 minute video that talks about how firefighters interact with those experiencing disabilities. The video also explains a new Disability Network program being rolled out where the state has 15 networks and there is a representative from MI Prevention for each zone in the event someone is in need of a bed shaker or a strobe, or any assistance, they can reach out to their representative.
 - Sonic Alert Home Aware devices are available in limited quantity through MI Prevention. Organizations can work with MI Prevention to obtain these devices for people in their community. More information can be found at www.MIPrevention.org.
- e) Fire Officer III Video Component: BFS put out a memo for subject matter experts for a video component of the Fire Officer III curriculum. Deadline to apply is April 15th, 2021. Send an email to: LARA-BFS-SMOKE@michigan.gov. Include your name, department/agency, and chapter or topic.
- **f) NFA Course Call Memo:** Dan Hammerberg is sending out grant letters. Responses are due back to Dan by April 23rd, 2021 at 5:00 pm.
- **g) Draft FFTC Rules Update:** The public hearing was held on March 24^{th,} 2021. The next step is a work session needs to be held so council can go over all submitted public comment, which is part of the JCAR process.

VIII. OLD BUSINESS:

a) Updated Course Codes for McNeil's Driver's Training Program (New Version): Councilperson Blomstrom updated council that the curriculum committee has received the new test and is being reviewed and that the student manual has been completed. A copy was sent to Dave Purchase and the Fire Marshal. Based on the old questions and the new questions, a new version of the drivers training exam is possible. Councilperson Blomstrom is hopeful that he can bring it to council for a vote for the June meeting. Councilperson Blomstrom asked Fire Marshal Sehlmeyer that since this is not a certification exam if instructors are going to be giving it or if it will be going online. Fire marshal stated the instructor will still continue to deliver the exam.

IX. <u>NEW BUSINESS:</u>

- a) Payment to Training Coordinators During Instructor I: Councilperson Blomstrom brought up concerns on how training coordinators that are teaching the old Instructor Orientation during Instructor I are being paid. Councilperson Blomstrom asked Fire Marshal Sehlmeyer to put out a memo as to what needs to be done specifically for the payment to the training coordinators, so the fire service is on the same page. Fire Marshal Sehlmeyer mentioned that in the coming months the IGAM will be getting updated to address this issue.
- b) Payment of Prep Time for Multi-Week Courses (Course Codes E and H): Councilperson Blomstrom asks council to look at Instructor I, Instructor II, and the Fire Officer classes instructor rates of pay to also incorporate prep time prior to the class to ensure that instructors are being

paid adequately for their service. Prep time prior to the course takes time outside of the 40 hours that are paid for the class. Using Instructor I as an example, building the paperwork, building the schedule, emailing students, setting up Navigate, and doing all the pre-course checking of the homework, take time outside of the 40 hours that are paid for the class. If there are 16 students in a class, it will run right through that 40 hour timeframe. When there were federal grant classes, it allowed for one (1) hour of prep time for every four (4) hours of instruction. Councilperson Blomstrom did not call for a motion but asks that council think of a possible formula to provide additional compensation for these classes for the instructors.

c) New Wildland Courses: Dan Hammerberg proposed two (2) new Wildland courses that were provided in the meeting packet and were requested by a couple of Wildland U.S. Forest Service instructors. One is the S-200 Initial Attack Incident Commander and the other is FI-110 Wildland Fire Observations and Origin Scene Protection for First Responders. The S-200 class is a 19 hour class and the FI-110 is a 6 hour class. Both would be on the regular curriculum catalog under an "L" Couse Code and would only be able to be taught by either Michigan DNR Fire Instructors or US Forest Service Instructors who are authorized to teach it by the National Wildland Coordinating Group.

Before public comment **Fire Marshal Sehlmeyer** mentioned that council needs to discuss how to disperse money that is being spent on mental health. There are two (2) regional areas, or four (4) counties, that did not claim their money, so the Bureau has that money plus there is money being returned for courses being cancelled. Fire marshal is looking for guidance from council on how should this money be redistributed. If a region returned money does council give them money again, to have them turn it back or as council moves forward, as long as the county continues to spend the money on mental and behavioral health courses, they continue to get money. Council discussed that money shouldn't continue to be given to counties that do not use it. Only counties that actively are doing something with mental and behavioral health are eligible to receive additional funds.

Liam Carroll, Schoolcraft College RTC: As my last official comment from the outside world, it's been a blast to sit out here. I'm truly impressed by the way the amount of work actually gets done. The Training Council, Bureau of Fire Services, and the fire fighters of the state of Michigan, the fire chiefs of the state of Michigan do a wonderful job of making sure the citizens are well protected. From a person who has been educating students for the past 5 years here and 15 years prior elsewhere, I'm happy to know that I'm sending fire fighters into a great occupation and a great career with people that are represented in these meetings here. I look forward to working with most of you in the very near future. Thank you all very much.

X. COUNCIL COMMENT:

Chairperson Tackett: Just to echo from what Kevin said. We just went back down to a level 2 on our ops plan, so no visitors, no in-person meetings, that kind of thing. I'm sure it's going to be a yoyo for the next few months, but hopefully we can continue the virtual ones because they have helped out quite a bit. I don't really have anything else I'd like to add, I think everyone else kind of hit good topics and good discussion points. I know it's not on the agenda, but I do want to give time for Andrea, Hollie, Robert and Dan, if you guys have anything you'd like to share or add, feel free. I appreciate everyone's hard work, council and BFS included.

Councilperson Blomstrom: Thank you for a good meeting today. Again I hope we continue to do this on Zoom moving forward. It does assist with us having the public see what we are doing on a meeting to meeting basis. Thats all I have for today.

Councilperson Styles: Aileen thank you for attending, it was a pleasure to have you in the class. I'm proud to say I've got 22 more to go, that have been scheduled as it is right now. There has been an overwhelming response to meet with people after one of my recent ones. It's almost humbling but it's also scary because we've let it get this far. So let's continue the mission and I hope you all enjoy your summer and I'll see you when I see you.

Councilperson White: Ditto what everyone else has said about the mental health of firefighters. I just want to say it was really nice to have a non-stressful meeting for once in how many years, since we've started the rules. It was a great meeting. Welcome Liam.

Councilperson Blackmer: I think the mental health thing is important. We had an EMS worker commit suicide over here within the last couple weeks. It sent shock waves through everybody that had a chance to know this young lady. It's happening more than what we realize, so whatever we can do to try to attack that and try to push back. Right now it's just as dangerous to our fire fighters as anything fire related. Whatever we can do to help assist that and keep moving that idea ahead I think is huge. Just bringing it out in the open in this forum, I think is a big deal and it's one of those things for years no one wanted to talk about or discuss and if we can bring it out as leaders in the fire service and let people know that it's okay to discuss these issues instead of holding on to them, maybe we can start to make some progress, I think we have, but we're all going to have to keep working together to keep making a difference. Other than that, I hope everyone has a wonderful afternoon.

Councilperson Janik: Congratulation Liam for joining BFS and being part of the team, I really look forward to working with you. It's interesting when you look at the Q Courses that have been brought on this agenda, 4 out of the 5 by nature, are what this council has been emphasizing in 2021. It's

really interesting to look at it from a data or quantitative perspective. The awareness created by the council, which was done originally by Aileen and just look what it has generated as far as courses that have come across our table. I think that's pretty interesting. That's what I had to share. Thank you.

Councilperson Steichen: Wants to recognize the BFS staff and congratulations Liam for joining that team. It seems like it's been a long time coming but you guys got the team together, now you can really get down to work. I do want to encourage folks out there looking to use the behavioral health money, CISM Intervention Certification Course is a good way to use it. I just took one here locally and our behavioral health unit we had it last week. It was a 24 hour course. The instructors Sue Alben (sp?) and Scott Norris have been doing it for about 30 years. I encourage everyone to look into that class, it is a Q Course. Thank you for your time and thank you for attending.

Councilperson Pettinger: Congrats to Liam, welcome to the BFS team. I also wanted to say that I attended Councilmember Chief Styles HAYO Class, that is outstanding and thank you for sharing such a powerful class. If any of you guys have not taken it, I highly encourage it. I appreciate him sharing it with us. I also would like to commend the rest of council; I think we approved some great classes today and there are a lot of options on the whole list to help the rest of the fire service. I know I'm going to be taking some of these classes. I just think that we're making some progress and it's good to see it.

Fire Marshal Sehlmeyer: To kind of echo off what everybody is saying, folks are reaching out to our office, they are excited about having the opportunity to go to a lot of these mental health classes. The topic is definitely timely, and I think back in January, council did a great thing when they decided to earmark these funds this way. I hope that as we move forward that all 83 counties see where this is relevant. I've been hearing a lot of good things about these courses. It's good to see that the money is being well spent. I would like to echo also that I'm excited to have Liam come on the team and I think that BFS is rounded out and we're ready to get to work and get things done. I still think there is a lot of talent throughout the state, to give you an example the Fire Officer III videos, I'm going to throw that out again, please think about it, if there is a topic that's on there, please reach out. These videos are meant to compliment Fire Officer III and drive home the curriculum and what needs to be done. Let's keep 2021 going strong. We're moving in a great direction. We need to get a work session scheduled. I would like to do this virtually since it allows the rest of the fire service to see it. One of the things I am a little nervous about if the Zoom meetings go away is that the rooms that we have available in Lansing are not going to allow for a whole lot of seating and we still have a lot of fire departments that aren't opening their buildings up. So we could get to a point that if we go back to in person meetings that we might only have a capacity in a room that we can only fit 20 people in, and council take up about a dozen of those seats, so we wouldn't be able to have a lot of folks there to participate. I think these Zoom meetings have been a good thing that the fire service has been engaged. Stay safe everyone. Thank you.

It has been a tumultuous undertaking but feels it will best serve the Michigan fire service if there was a mandatory delay to go through the rules one last time.

Terry Chesney, Michigan Professional Fire Fighters Union: Everyone did a great job today. Concern is that if council comes back and has another meeting and other changes are made, then each council member will have to go back to their groups and talk before they can approve the new changes, if any. Today council could have come to this meeting with no changes and moved it along and nothing would have went back to the other groups. You are here to represent your groups and you should have an understanding of how your groups feel and you should know that ahead of time. Changes were made but there was nothing that came out of the clear blue that you shouldn't be able to act on. I think you did the right thing by moving on and I look forward to having JCAR approve this. Thanks for all your hard work.

VI. COUNCIL COMMENT:

IV. COMMUNICATIONS:

Fire Marshal Sehlmeyer spoke to Chairman Tackett, who sent his apologies to the council for missing the June 8th meeting. He shared the Tackett Family recently welcomed a new addition to their family and that he truly appreciated the kind words that many have sent since the arrival of their baby boy.

Councilperson White: None.

Councilperson Steichen: While he had no formal communications to share, Councilperson Steichen mentioned he had been working with several of the Behavioral and Mental Health sections in the northern region and felt there had been great communication and collaboration between them.

Councilperson Pettinger shared her only communications had been regarding the Behavior and Mental Health classes as well. She encouraged fire service members to take advantage of this free training and advised fire departments that were interested in hosting a behavioral and mental health class to contact the instructor and their Behavioral and Mental Health fiduciary.

Councilperson Janik recently attended one of Chief Styles behavioral and mental health classes. He thought it was a great class and noted there were a lot of young recruits there. He also encouraged fire service members to attend the behavior and mental health classes available to them.

Councilperson Blackmer had no formal communications to share.

V. STATE FIRE MARSHAL'S REPORT:

- 1) Revised Course Summary: A revised course summary was given to council providing an update on FY21 courses through June 7, 2021. As requested by council, the course names had been added to the list.
- 2) Draft Fire Fighters Training Council General Rules Update: Fire Marshal Sehlmeyer shared the JCAR Briefing Report had been completed by staff and submitted to the Office of Policy and Legislative Affairs (OPLA) for review. Once the report has been reviewed and approved by OPLA, the next step in the process is to send it to the Michigan Office of Administrative Hearings and Rules.

- **3) Behavioral and Mental Health Funding Update:** As of June 8th, a total of \$38,270 of behavior and mental health funds had been distributed to the districts statewide. Moving forward, the bureau will fund requests for behavior and mental health classes as they are received.
- **4) NFFF Courses:** Fire Marshal Sehlmeyer provided an overview of the NFFF courses, Leadership So Everyone Goes Home and Attributes of Leading, that were added to the agenda under new business.
- 5) Fire Officer III Video Component: The Fire Marshal shared that a contract between the Department of Licensing and Regulatory Affairs and the recording company is currently pending. Once the contract has been finalized the bureau can move forward with the video component of this project.
- 6) Fatal Fires: As of June 8, 2021, there had been a total of 57 deaths in 53 residential fires. This is a 13% decrease in deaths and a 4% decrease in fires from this time last year. So far this year, male victims (67%) continue to be the trend with 29% of them reported as disabled.

7) MI Prevention Updates:

- 1) The Fire Marshal shared that MI Prevention continues to work with the Disability Network of Michigan and that our firefighter and caregiver videos are nearing completion. Both videos focus on how to interact with individuals experiencing disabilities.
- 2) Also, MI Prevention Program Manager Kymberly Pashkowsky has been working with our IT staff to update the MI Prevention webpage. Fire Marshal Sehlmeyer encouraged everyone to visit the updated webpage as there is a lot of great content available. Kymberly also posts content several times a week on MI Prevention's social medial platforms (Facebook, Instagram, Twitter, and LinkedIn).
