**FINAL ORDER**

1. This matter came before the Department of Licensing and Regulatory Affairs, (the "Department") under the Private Security Business and Security Alarm Act, MCL 338.1051 *et seq.* (the "Act"), and its associated administrative rules.
2. The Director of the Corporations, Securities & Commercial Licensing Bureau (the "Director") received the Proposal for Decision ("PFD") and the entire hearing record on behalf of the Department in accordance with the Michigan Administrative Procedures Act, MCL 24.201 *et seq.*
3. The Director considered the Statement of Facts not in Genuine Dispute and Conclusions of Law in the PFD of Eric J. Feldman, Administrative Law Judge, dated April 9, 2019, and the complete hearing record.
4. The PFD is incorporated by reference.

**THEREFORE, IT IS ORDERED** that the following penalties authorized by MCL 338.1060 are imposed:

- A. Respondent's license issued under the Act is revoked, effective on the date mailed.
- B. Under MCL 338.1060(3), within 48 hours after notification from the Department of the revocation of its license, Respondent shall surrender its license and the identification card issued under MCL 338.1064. A person who violates MCL 338.1060(3) is guilty of a misdemeanor punishable by imprisonment for not more than 93 days or a fine of not more than \$500.00, or both.


