FINDINGS AND CONCLUSIONS: The Board acknowledged receipt and reviewed the material on this matter at the meeting on the above noted date. Mr. Brandon Farmer attended the meeting and provided testimony and pay stubs to document his work experience for the Board's review. Following discussion, the Board moved to approve Mr. Farmer's appeal to sit for the journeyman electrician examination with the condition that Mr. Farmer submits proof of the completion of the required 8,000 hours of experience and that those hours are approved by staff.

THEREFORE, it is the order of the Board to approve Mr. Brandon Farmer to sit for the journeyman electrician examination upon providing proof deemed acceptable by staff of completion of the required 8,000 hours of experience in accordance to MCLs 339.5709(a) and 339.5715(1).
