MICHIGAN FIRE FIGHTERS TRAINING COUNCIL SPECIAL MEETING

I. CALL TO ORDER AND DETERMINATION OF QUORUM:

The MMFTC September Work Session meeting was called to order at 9:09a.m. by Brian Blomstrom. Roll call was taken by Kevin Stone, contractor to the Bureau of Fire Services. A quorum was determined present.

II. APPROVAL OF AGENDA: SEPTEMBER 24, 2018 SPECIAL MEETING:

A MOTION was made by Councilperson Pettinger and seconded by Councilperson Janik to approve the meeting agenda for September 24, 2018 as presented. MOTION CARRIED.

III. PUBLIC COMMENT

None.

IV. NEW BUSINESS:

a. Fire Fighter Training Council General Rules Councilperson Blomstrom begins by discussing R29.408c stating that he does not believe NFPA has a required amount of years' experience for someone to be a Fire Instructor I. Blomstrom believes that sections B and C cannot be in there due to nothing in the NFPA standards saying they need to be in there. TJ Richardson then cites NFPA 1041 - 1.3.3 (Fire Service Instructional Professional Qualifications) as a solution to the current dilemma. State Fire Marshal Sehlmeyer shares that this is also the perfect opportunity to look at the pre-requisites of each Instructor level, stating that current prerequisites could lead to Instructor I actually being Instructor II, etc. The Fire Marshal stresses that this is not designed to take away anyone's previous certifications, but if they want to be more than their current Instructor level. they'd have to do more training. Due to the amount of time needed to change things in these specific sections suggests revisiting section 3 on both R29.408c and R29.408d at a later time as a work group and moving on to the rest of the rules. The Council agrees to table the discussion.

While discussing R29.408e it is agreed on by the Council that "Certified Instructors or Associate Instructors" should be added into the language on section 3. R29.408f is to be revisited once the Bureau of Fire Services' new reciprocity form is completed. While discussing R29.409, the council agrees to section 3 should include an annual submittal of the information they're keeping to the Bureau of Fire Services with suspension of instructor's certification pursuant to section 11A as a penalty. The council agrees to examine R29.410 after the other rules are revised. R29.411 and R29.412 are not expanded upon. R29.413 is revised with section 6e now stating that Incident Command and Resource Management will be used for Fire Service and section 6g being removed altogether. The heading for R29.414 revised to now read as "Training council approved courses; requirements". Finally, R29.415 was revised with clearer wording to Rule 15, section 1,2, and 2 c respectively.

V. COUNCIL COMMENT

Councilperson Steichen informed the council that he will not be able to attend next month's October 9-2018 meeting due to a week-long workshop in Lansing scheduled during the same week.

VI. ADJOURNMENT Councilperson Blomstrom adjourned at 12:05 p.m.
