FIRE FIGHTERS TRAINING COUNCIL

GENERAL RULES

Filed with the secretary of state on

These rules become effective immediately upon filing with the secretary of state unless adopted under section 33, 44, or 45a(6) of the administrative procedures act of 1969, 1969 PA 306, MCL 24.233, 24.444, or 24.245a. Rules adopted under these sections become effective 7 days after filing with the secretary of state.

(By authority conferred on the fire fighters training council by section 16 of 1966 PA 291 MCL 29.376, and Executive Order Reorganization No. **1997-2**, 2003-1, **and 2011-4**, MCL **29.451**, 445.2011 **and 445.2030**)

R 29.401, R 29.402, R 29.403, R 29.405, R 29.410, R 29.413, R 29.414, and R 29.415 of the Michigan Administrative Code are amended, and R 29.405a, R 29.405b, R 29.405c, R 29.405d, R 29.405e, R 29.405f, R 29.405g, R 29.405h, R 29.405i, R 29.405j, R 29.405k, R 29.405l, R 29.405m, R 29.405n, R 29.405o, R 29.405p, R 29.405q, R 29.410a, R 29.410b, R 29.416, R 29.417, and R 29.418 are added to the Code, and R 29.404, R 29.408, R 29.408a, R 29.408b, R 29.408c, R 29.408d, R 29.408e, R 29.408f, and R 29.409 of the Code are rescinded, as follows:

PART 1. GENERAL PROVISIONS

R 29.401 Definitions.

Rule 1. As used in these rules:

(a) "Act" means the firefighters training council act, 1966 PA 291, MCL 29.361 to 29.377.

(b) "Authority having jurisdiction (AHJ)" means an organization, office, or individual responsible for enforcing the requirements of a code or standard, or for approving equipment, materials, an installation, or a procedure.

(c) "Bureau" means the bureau of fire services, in the department of licensing and regulatory affairs.

~~(b) "Council" means the fire fighters training council as defined in the act.~~

(d) "Cadet" means a fire fighter who is participating in a training course, is between 16 and 18 years of age, and participates in a council registered and approved cadet program offered by a fire department.

(e) “Current edition” means the respective professional qualifications in the current and appropriate national fire protection association (nfpa) standard.

(f) “Curriculum work group” means a group of fire service members appointed by the chairperson of the council. The curriculum work group reviews curriculum making recommendations for new or updated curriculum to the bureau and the council. The curriculum work group assists in the validation of the various classification examinations offered by the bureau.

~~(e)~~ **(g) “Department” means the department of licensing and regulatory affairs, bureau of fire services.**

~~(d)~~ **(h) “Emergency medical services and instructor coordinator license, or ems/ic license,” means a license issued by the department of community health pursuant to the public health code, 1978 PA 368, MCL 333.20901 to 333.20979.**

(i) “Equivalent” means certifications from another state’s certifying agency, which meet the current nfpa standard for the classification.

~~(e) “Fire fighter” means a member, including a volunteer member and a member who is paid on call, of an organized fire department that is responsible for, or is in a capacity that includes responsibility for, the extinguishment of fires, the directing of the extinguishment of fires, the prevention and detection of fires, and the enforcement of the general fire laws of this state. Fire fighter does not include a person whose job description, duties, or responsibilities do not include direct involvement in fire suppression.~~

(j) “Explorer” means a fire fighter who is participating in a training course, is between 16 and 18 years of age, and participates in a council-approved fire department boy or girl scouts of America explorer program.

(K) “Information management system” means the bureau’s system used to track an individual’s fire department membership, council-approved training, and certification.

(k) “Materially false statement” means a false writing or document that contains any materially false, fictitious, or fraudulent statement or entry.

(l) “Pre-service student” means an individual who is taking fire fighting classes through an approved regional training center who is not a member of a registered Michigan fire department.

(l) “Q course” means a course developed by individual subject matter experts and is the property of the instructor who developed the approved course. The fire fighters training council shall approve a Q course and the instructor or instructors who teach the course shall be approved by council. Q courses cannot be developed to circumvent council-approved curriculum courses in which council provides certification.

(m) “RRTN” means a regional response team network for a hazardous materials response.

(n) “RTC” means a regional training center.

(o) “RTC student” means an individual who is taking fire fighting classes through an approved regional training center and who may or may not be registered with a fire department. Service time at a regional training center

does not count toward fire department service time unless the individual is registered as a fire department member during the time at the RTC.

(q) “Revoked” means removal of certification by this state or another state.

(r) “Revocation” means the bureau revoked an individual’s certification as part of a disciplinary process approved by the council.

(s) “Third party authorization” means any course owned by a private curriculum provider and which an instructor is required by the developer to meet the developer’s requirements to teach the course.

R 29.402 Council approved course; instruction hours; recognition of training by council.

Rule 2. (1) The council approved course shall be evaluated by the curriculum work group based upon all of the following:

(a) The time required to adequately cover the subject material.

(b) **Whether the curriculum meets the established goals and objectives.**

(c) **Whether the curriculum is relevant** to the needs of the fire service in this state.

(2) An instruction hour shall consist of 50 minutes of instruction time and 10 minutes break time, totaling 1 actual hour.

R 29.403 **Certification examinations; development; passing scores.**

Rule 3. (1) **Pursuant to section 9(2)(b) of the act, MCL 29.369(2)(b), the state fire marshal, with the approval of a majority of the council, shall develop and administer certification examinations for all of the following fire service disciplines:**

(a) Fire chief.

(b) Fire inspector.

(c) Fire service instructor.

(d) Fire investigator.

(e) Fire officer.

(f) Public safety director.

(g) Plans examiner.

(h) Fire fighter.

(i) Hazardous materials responder.

(j) Technical rescue responder.

(k) Airport rescue fire fighter.

(2) ~~shall be approved by the council and~~ **The examinations** shall be reviewed by department **bureau** staff to ascertain if there is adequate comprehension of the subject material tested in the examinations.

(3) The examination for firefighter I and II may be combined into 1 part of the examination to test the knowledge and skill requirements in the **current edition** of standards for fire fighter professional qualifications, national fire protection

association, nfpA, standard 1001, “**Standard for Fire Fighter Professional Qualifications,**” as adopted in R 29.410.

~~(2) The examination requirement for fire fighter I and II shall be waived for a veteran who served in and is separated from the armed forces and provides a form DD214 or DD215, or another form that demonstrates that the candidate was separated from service with an honorable character of service or under honorable conditions general character of service. The veteran must have completed firefighter training while serving in the armed forces of the United States, that meets the standards for fire fighter I and fire fighter II set forth in NFPA 1001 “standard for fire fighting professional qualifications,” as adopted in R 29.410.~~

~~—(3) The state fire marshal shall waive the examination requirements and extend reciprocity to a firefighter from another state if the firefighter was certified in the other state after successfully completing a program that meets or exceeds the standards for fire fighter I and fire fighter II set forth in “standard for fire fighter professional qualifications”, national fire protection association standard no. 1001 by an international accreditation fire service organization. A reciprocity request shall be submitted on a form prescribed by the bureau.~~

~~—(4) A minimum of 70% average is required to successfully pass the examinations, unless otherwise specified in the course objectives.~~

R 29.404 ~~Attendance at training sessions; certificates.~~ **Rescinded.**

~~—Rule 4. (1) A trainee shall attend all sessions unless he or she has a valid reason for his or her absence. The instructor may, for valid reasons, excuse not more than 10% of the total hours of instruction. An absentee from a scheduled class session shall make up the absence as required by the instructor.~~

~~—(2) Upon successful completion of the course, the state fire marshal or the council may award a certificate for that course.~~

PART 2. CLASSIFICATIONS

R 29.405 ~~Classification for fire fighters~~ **fire fighter I with hazardous materials operations; fire fighter II; fire fighter I and II with hazardous materials operations; requirements; reciprocity.**

Rule 5. (1)The following are the classifications for fire fighter I **with hazardous materials operations**, and fire fighter II, **fire fighter I and II with hazardous materials operations**, pursuant to section 9 of the act, MCL 29.369: .

(a) A fire fighter I is a ~~person~~ **an individual** who successfully passes the council-approved fire fighter I **with hazardous materials operations** exam, which covers the skill and knowledge requirements for fire fighter I in **the current edition of** nfpA 1001, “Standard for Fire Fighter Professional Qualifications”, as adopted by reference in R 29.410.

(b) A fire fighter II is a fire fighter I who meets the requirements of subdivision (a) of this rule and successfully passes the council approved fire fighter II exam, which covers the skill and knowledge requirements for fire fighter II **specified in**

the current edition of nfp 1001, standard, "Standard for Fire Fighter Professional Qualifications", as adopted by reference in R 29.410.

(c) A fire fighter I and II with hazardous materials operations is an individual who passes a council-approved fire fighter I and II with hazardous materials operations exam, which covers the skill and knowledge requirements for fire fighter I and II in the current edition of nfp 1001, "Standard for Fire Fighter Professional Qualifications", as adopted by reference in R 29.410.

(2) An individual who attends a course for fire fighter I with hazardous materials operations, fire fighter II, and fire fighter I and II with hazardous materials operations shall be 18 years of age or older on the date of the final written and practical examinations except for any of the following:

(a) An individual who is sponsored by a fire department cadet program or fire department boy or girl scouts of America explorer program.

(b) A fire department cadet or explorer who is between 16 and 18 years of age, and is still attending high school as a full time student.

(3) A cadet or explorer is only allowed to participate in fire fighter I with hazardous materials operations, fire fighter II, or fire fighter I and II with hazardous materials operations programs and the incident command and resource management program for the fire service.

(4) A request for an exception to subrule (2) of this rule, such as a cadet or explorer program, shall be submitted to the bureau region coordinator on letterhead from the chief of the sponsoring fire department and include a dated copy of the charter or resolution of the local unit of government authorizing a fire department cadet or explorer program within the fire department.

(5) An individual shall participate in a registered fire fighter I with hazardous materials operations or fire fighter I and II with hazardous materials operations course to be eligible to take the state written and practical certification exams.

(5) An individual who attends a council-approved fire fighter course or courses to qualify for the certification examinations shall comply with both of the following:

(i) An individual shall not be absent from more than 10% of the total lecture hours of an entire course as validated by the course manager. A course manager may provide flexibility in attendance as needed in fire fighter courses due to the length of the course and an individual's employment obligations. An individual who is provided flexibility in attendance shall make up missed hours and classes prior to the scheduled ending date of the course. An individual shall meet 90% of the lecture hours and 100% of the practical skills hours. A course manager shall enforce the bureau make up policy.

(ii) An individual who completes make up training at his or her fire or public safety department shall complete the bureau's make-up training form, **BFS** 255, for each make-up session authorized by the course manager. The fire chief or public safety director shall sign the form and

return the form to the course manager for inclusion in the final course paperwork submitted to the bureau via email.

(6) An individual who is currently certified in this state and who meets continuing education requirements for a fire fighter I, as specified in R 29.418, shall be allowed to take the fire fighter II written and practical examinations without attending the fire fighter II course. These examinations shall be completed at an examination site registered in the bureau's information management system.

(7) An individual shall complete the requirements in the MIOSHA occupational health standard part 451 respiratory protection, R 325.60051 and R 325.60052, while participating in either the council-approved fire fighter I with hazardous materials operations course, the fire fighter II course, or the fire fighter I and II with hazardous materials operations course. An individual who participates in council-approved courses that require respiratory protection or equipment to be worn shall be completely free of facial hair that comes between the sealing surface of the facepiece and face or that interferes with valve function or any condition that interferes with face-to-face piece seal or valve function.

(8) An individual shall apply to the bureau on the bureau's application form, BFS-205, for certification prior to taking the state certification examination.

(9) An individual who is certified in another state's certifying agency and is applying for reciprocity certification from this state shall be a member or employee of a Michigan fire department and entered into the bureau's information management system. An individual who has certifications from another state's certifying agency or who has armed forces certification that was granted under honorable conditions and that meets the current edition of nfpa 1001, "Standard for Fire Fighter Professional Qualifications", shall complete the bureau's request for reciprocity form, BFS 258, and submit the form to the bureau.

R 29.405a Classification for fire chief; requirements; reciprocity. What is the process??? Discussion with FFTC

Rule 5a. (1) The following is the classification for fire chief pursuant to section 9 of the act, MCL 29.369.

(a) A fire chief is **a person an individual** who is certified as a fire fighter II and successfully passes the **council-approved fire officer curriculum prior to October 1, 2019 or passes the bureau-approved certification examination which covers the skill and knowledge requirements for fire officer II or fire officer III as stated provided in 29.405a subrule(1)(b) and (c) of this rule** and in the current edition of nfpa 1021, "Standard for Fire Officer Professional Qualifications", as adopted by reference in R 29.410.

(b) A fire chief in a service jurisdiction covering a census population of less than 10,000 shall be certified to the fire officer II level 24 months from the date of hire and **will shall** receive Michigan fire chief certification.

(c) A fire chief in a service jurisdiction with a census population of 10,000 or more shall be certified to the fire officer III level 36 months from the date of hire and ~~will~~ shall receive Michigan fire chief certification.

(d) ~~Individuals~~ An individual who was certified at the fire chief level for ~~their~~ his or her jurisdiction prior to October 1, 2019 ~~are~~ is considered to have met the requirements of 29.405a subrule (1)(b) and (c) of this rule.

(2) ~~Every~~ An individual ~~must~~ shall apply to the bureau on the bureau's ~~make an~~ application, BFS 205, for certification prior to taking the state certification exam. *{Should the date still be October 1, 2019?}*

(3) An individual who is certified by another state's certifying agency and is applying for reciprocity recognition in this state shall ~~Individuals must~~ be a member or employee of a Michigan fire department and entered into the bureau's information management system. ~~to apply for reciprocity.~~
~~Individuals~~ An individual who ~~have~~ has certifications from another state's certifying agency ~~must~~ shall complete the bureau's ~~BFS 258~~ request for reciprocity form, BFS 258, and submit the form to the bureau to obtain Michigan fire chief certification.

R 29.405b Classification for fire inspector; requirements; reciprocity.

Rule 5b. (1) The following is the classification for fire inspector pursuant to section 9 of the act, MCL 29.369.

(a) A fire inspector is ~~a person~~ an individual who is certified as meeting the requirements of the bureau's fire inspector certification rules, R 29.501 to R 29.508, and ~~who has~~ successfully ~~completes~~ completed the bureau-approved fire inspector ~~certification~~ process, which covers the skill and knowledge requirements for fire inspector in the current edition of nfp 1031, "Standard for Professional Qualifications for Fire Inspector and Plan Examiner", as adopted by reference in R 29.410.

(b) ~~Every~~ An individual ~~must make an~~ shall apply to the bureau on the bureau's application form, BFS 205, for certification.

(c) ~~Individuals must~~ An individual who is certified by another state's certifying agency and is applying for reciprocity recognition in this state shall ~~be~~ be a member or employee of a Michigan fire department and entered into the bureau's information management system. ~~to apply for reciprocity.~~
~~Individuals~~ An individual who ~~have~~ has certifications from another state's certifying agency ~~must~~ shall complete the ~~BFS 258~~ the bureau's request for reciprocity form, BFS 258, and submit the form to the bureau to obtain Michigan fire inspector certification.

R 29.405c Classification for fire service instructor I; ~~fire service instructor II, fire service instructor III, certified and certified associate fire service instructors~~; requirements; reciprocity.

Rule 5c. (1) The following ~~are~~ is the classifications for fire service instructor I pursuant to section 9 of the act, MCL 29.369: .

(2) A fire service instructor I is ~~a person~~ an individual who is certified as a fire fighter II and has a minimum of 3 years of experience, not including

pre-service, cadet, or explorer **experience**, from ~~their~~ **his or her** first fire fighter certification prior to beginning the fire instructor I requirements.

(3) Additionally, the student must complete A fire instructor 1 shall have **completed** 6 hours of lecture and 6 hours of practical skills **training** in an instructional setting with a certified fire service instructor I or higher present within 24 months of completing the nfpa 1041 fire service instructor I course which covers the skill and knowledge requirements for fire service instructor I in the current edition of nfpa 1041, “Standard for Fire Service Instructor Professional Qualifications”, as adopted by reference in R 29.410. *{This sentence was moved from subdivision (c).}* **on a BFS-253 Mentoring Form.** *{This sentence is incomplete. It should be revised or removed from the text.}*

(4) A fire service instructor I shall have who has successfully passed the council-approved nfpa 1041 “Standard for Fire Service Instructor Professional Qualifications” fire service instructor I written examination with a score of 70% or higher and passed the **fire service instructor 1** practical examination. ~~Additionally, the student must complete 6 hours of lecture and 6 hours of practical skills in an instructional setting with a certified fire service instructor I or higher present within 24 months of completing the nfpa 1041 fire service instructor I course which covers the skill and knowledge requirements for fire service instructor I in the current edition of nfpa 1041, “Standard for Fire Service Instructor Professional Qualifications”, as adopted by reference in R 29.410. on a BFS-253 Mentoring Form.~~

(5) A fire service instructor I who is certified after October 1, 2019, and who has passed a council-approved train-the-trainer **course** may instruct that course provided ~~they maintain~~ that he or she maintains authorization from the third-party. *{Who or what is the “third party”? This needs to be clarified.}*

(6) A fire service instructor I who was certified prior to October 1, 2019, may continue to instruct the courses **that he she or she had been previously authorized to teach.**

(7) A fire service instructor I is authorized to only instruct only a council- approved curriculum, **which and** does not apply to council approved **“Q” Q** courses.

(8) A fire service instructor I Fire service instructors who is certified under this classification ~~must shall~~ meet the MIOSHA **occupational health standard part 451 respiratory protection, R 325.60051 and R 325.60052.** When **instructing teaching** any council-approved course, **an instructors** shall be completely free of facial hair that comes between the sealing surface of the facepiece and face or that interferes with valve function or any condition that interferes with face-to- facepiece seal or valve function.

(9) Exception for individuals completing **An individual who completes the requirements** fire instructor I ~~to only shall~~ meet the **only requirement** for nfpa 1021 “Standard for Fire Officer Professional Qualifications , as adopted by reference in R 29.410, **must shall** be certified as a fire fighter II,

and shall have a minimum of 3 years of service, not including pre-service, cadet, or explorer service, from their his or her first fire fighter certification prior to beginning the fire instructor I requirements. *[This doesn't make sense to me.]* An individual must shall successfully pass the council-approved nfp 1041 "Standard for Fire Service Instructor Professional Qualifications" fire instructor I written examination with a score of 70% or higher and passed the practical examination. These individuals will This individual shall not be required to comply with the continuing education requirement for fire service instructors.

(10) ~~Every individual must make an~~ An individual shall apply to the bureau on the bureau's application, BFS-205, for certification prior to taking the state certification course. An individual must shall be certified at the previous certification prior to taking the next level of certification per pursuant to nfp 1041 "Standard for Fire Service Instructor Professional Qualifications".

(11) ~~Individuals must~~ An individual who is certified by another state's certifying agency and is applying for reciprocity recognition in this state shall be a member or employee of a Michigan fire department and entered into the bureau's information management system. ~~to apply for reciprocity. Individuals An individual who have has~~ certifications from another state's certifying agency ~~course must~~ shall complete the bureau's BFS 258 request for reciprocity form, BFS 258, and submit the form to the bureau to obtain Michigan fire instructor I certification.

R 29.405d Classification for fire service instructor II; requirements; reciprocity.

Rule 5d. (1) The following is the classifications for fire service instructor II pursuant to section 9 of the act, MCL 29.369.

(2) A fire service instructor II is an individual who is certified as a fire service instructor I and has a minimum of 5 years of service, not including pre-service, cadet, or explorer service, from his or her initial fire fighter certification prior to beginning the fire service instructor II requirements and 40 hours of documented and verifiable instructional hours.

(3) A fire service instructor II shall have successfully passed the council-approved nfp 1041 "Standard for Fire Service Instructor Professional Qualifications" fire instructor II written examination with a score of 75% or higher and passed the practical examination, which covers the skill and knowledge requirements for fire service instructor II as specified in the current edition of nfp 1041, as adopted by reference in R 29.410.

(4) A fire service instructor II who was certified prior to October 1, 2019, may continue to instruct the courses that he she or she had been previously authorized to teach.

(5) A fire service instructor II who is certified after October 1, 2019, is authorized to instruct any council-approved course that the fire service instructor has completed and passed provided the course does not require third-party authorization.

(6) A fire service instructor II who has attended and passed the council-approved nfa 1041 “Standard for Fire Service Instructor Professional Qualifications” fire service instructor I certification course and has completed the bureau’s nfa 1041 fire instructor I train-the-trainer course is authorized to instruct the council-approved nfa 1041 fire service instructor I certification course.

(7) A fire service instructor II who has taught 2 fire instructor I courses, attended and passed the council approved nfa 1041 fire service instructor II certification course, and completed the bureau’s nfa 1041 “Standard for Fire Service Instructor Professional Qualifications” fire service instructor II train-the-trainer course is authorized to instruct the council-approved nfa 1041 fire service instructor II certification course.

(8) An individual shall apply to the bureau on the bureau’s application, BFS-205, for certification prior to taking the state certification course. An individual shall be certified at the previous certification level prior to taking the next level of certification pursuant to nfa 1041 “Standard for Fire Service Instructor Professional Qualifications”.

(9) An individual who is certified by another state’s certifying agency and is applying for reciprocity recognition in this state shall be a member or employee of a Michigan fire department and entered into the bureau’s information management system. An individual who has certifications from another state’s certifying agency shall complete the bureau’s request for reciprocity form, BFS 258, and submit the form to the bureau to obtain Michigan fire instructor II certification.

R 29.405e Classification for fire service instructor III; requirements; reciprocity.

Rule 5e. (1) The following is the classifications for fire service instructor III pursuant to section 9 of the act, MCL 29.369.

(2) A fire service instructor III is an individual who is certified as a fire service instructor II and has a minimum of 7 years of service, not including pre-service, cadet, or explorer service, from his or her initial fire fighter certification prior to beginning the fire service instructor III requirements and 80 hours of documented and verifiable instructional hours.

(3) A fire service instructor III shall have successfully passed the council-approved nfa 1041 “Standard for Fire Service Instructor Professional Qualifications” fire service instructor III written examination with a score of 75% or higher and pass the practical examination which covers the skill and knowledge requirements for fire service instructor III in the current edition of nfa 1041, as adopted by reference in R 29.410.

(4) A fire service instructor III is authorized to instruct any council-approved course that the instructor has completed and passed provided the course does not require third-party authorization. *{Rule 5c requires third-party authorization, but this subrule doesn’t require the authorization. Is this language correct?}*

(5) A fire service instructor III who has instructed 2 council-approved nfpa 1041 fire service instructor II certification courses and completed the bureau's nfpa 1041 fire service instructor III train-the-trainer course is authorized to instruct the council approved nfpa 1041 fire service instructor III certification course provided this individual has attended and passed the council approved nfpa 1041 fire service instructor III certification course.

(6) An individual shall apply to the bureau on the bureau's application, BFS-205, for certification prior to taking the state certification course. An individual shall be certified at the previous certification level prior to taking the next level of certification pursuant to nfpa 1041 "Standard for Fire Service Instructor Professional Qualifications".

(7) An individual who is certified by another state's certifying agency and is applying for reciprocity recognition in this state shall be a member or employee of a Michigan fire department and entered into the bureau's information management system. An individual who has certifications from another state's certifying agency shall complete the bureau's request for reciprocity form, BFS 258, and submit the form to the bureau to obtain Michigan fire instructor II certification.

R 29.405f Certified fire service instructors; certified associate fire service instructors; requirements.

(4) As of September 30, 2019, a certified associate fire service instructor who is approved by the bureau, according to qualifications established prior to 2015, shall maintain his or her status as a certified associate fire service instructor. *{See previous comment about associate instructors.}*

(5) A certified fire service instructor and a certified associate fire service instructor may teach all courses he or she was authorized to instruct prior to October 1, 2019 unless a third-party certification is required as of the effective date of these rules. *{This draft rule has language about "effective date of these rules", September 30, 2019, and October 1, 2019. - (a) Having been convicted of a felony in any state of the United States.
- (b) Making a materially false statement.
- (c) Causing a materially false statement to be made.
- (d) Committing fraud when applying for any classification certification.
- (e) Wrongfully disclosing in any format, such as electronically, verbally, or in writing, any information about an examination, ~~in any format,~~ that the department uses in the examination certification process.
- (f) ~~Violation of~~ Violating the act or the bureau's rules, policies, directives or bulletins. *{Is this enforceable?}*

(g) ~~Violation of~~ Violating the annual instructor memorandum of understanding (MOU).

(2) Upon the bureau receiving notification ~~to the bureau~~ that an individual who is certified pursuant to the act and these rules has violated the act or 1 or more of the rules, policies, or bulletins, ~~has been violated~~, the state fire marshal ~~will shall~~ direct bureau staff to investigate the allegation or allegations. The investigation ~~will shall~~ include ~~interviewing the accuser an~~ interview or interviews of the individual who made the allegation and any witnesses who ~~might may~~ support or negate the allegation or allegations against the individual in question.

(3) If the allegation or allegations are substantiated, ~~the accused the~~ individual who is accused of allegedly violating the act, or the bureau's rules, policies, directives, or bulletins, ~~shall will~~ be interviewed by bureau staff, ~~and or~~ the state fire marshal, or both. Upon completion of the investigation, the bureau staff or ~~designee~~ *{Designee of whom?}* ~~will shall~~ submit a final report to the state fire marshal for official action. The report ~~will shall~~ include findings of the investigation, ~~as well as~~ all statements given made during the investigation, and ~~the penalty to be assessed a~~ recommendation of the disciplinary action to be taken.

(4) Upon completion of the investigation, the state fire marshal ~~will shall~~ make disciplinary recommendations to the council at the next regularly scheduled council meeting.

(5) The council ~~will shall~~ vote to ~~uphold confirm~~ or deny the state fire marshal's recommendation at the ~~next~~ regularly scheduled council meeting.

(6) An individual who has 1 or more classification certifications suspended as the result of a disciplinary process shall meet all of the conditions detailed in the suspension including, but not limited to, retraining provisions to reinstate his or her classification certification or certifications.

(7) The decision of the council to suspend or revoke a classification certification ~~will shall~~ be final. An individual ~~appeals may appeal the~~ decision to the council within 30 days of being notified by the council of the suspension or revocation of a certification or certifications. An individual who appeals the decision shall submit a letter of appeal ~~shall be sent~~ to the bureau's region coordinator. *{What happens after the region coordinator receives the letter?}* Any suspension other than permanent revocation of classification certification or certifications ~~will shall~~ specify ~~contain established~~ *{Not sure what is meant by "established"}* requirements that ~~must be completed~~ the individual shall complete to reinstate the classification certification or certifications after the terms of the suspension are met.

(8) ~~The An~~ individual ~~wishing to appeal the state fire marshal's recommendation can~~ may appeal the state fire marshal's recommendation at a regularly scheduled council meeting. The individual being investigated shall be notified ~~of their his or her~~ appeal hearing at least 2 weeks prior to

(b) The state fire marshal, or his or her designee, ~~will give shall present~~ a summary of the findings of the investigation and of the recommended ~~disciplinary action, recommended against the individual.~~ Any A council member or the individual under investigation ~~can may~~ direct questions to the state fire marshal, or his or her designee, at this time. *{The individual appealing the decision is limited to 20 minutes to make a presentation, but there is no limitation on the fire marshal. Should the fire marshal be limited to 20 minutes also?}*

(c) The individual appealing a disciplinary decision ~~will shall~~ present his or her statement; ~~the statement that~~ shall not exceed 20 minutes.

(d) The state fire marshal, or his or her designee, and any council member, may question the individual appealing a disciplinary decision during this hearing.

(e) The state fire marshal, or his or her designee, will shall have 5 minutes for to present a summary of the reasons for maintaining the council's disciplinary decision prior to the council vote.

(f) The individual appealing a disciplinary decision will shall have 5 minutes for to present a summary of the reasons to overturn the disciplinary decision prior to the council vote.

(g) The council chairperson will shall adjourn the closed session, *{In the OMA handbook, it is suggested that a motion is made to end the closed session with a majority vote needed for approval.}* return to open session of the council meeting, and request a roll-call vote to either uphold, deny, or modify the previous council decision. *{Will the vote have to be a majority of the members present and voting a two-thirds vote of those members?}*

PART 4. TRAINING

R 29.413 Regional training centers; facilities; approval.

Rule 13. (1) An applicant shall establish a regional training center (rtc) in a strategic location to serve the greatest number of fire departments that are unable to support their own training program. To establish a regional training center, an applicant shall do all of the following:

(a) Establish an advisory committee which includes appointing a the manager of training chairperson from the department rtc staff and may include any county training committee chairpersons from the counties that will be served by the rtc.

(b) Complete an application provided by the department. Submit a letter of intent to the appropriate bureau region coordinator to establish an rtc.

(c) Complete a needs survey which establishes the fire department training needs of the area and describes how the rtc plans to fulfill those needs. Collect any correspondence documentation of support for the need of the new rtc.

(d) Have and be able to maintain the capability to conduct fire fighter I and II courses and examinations.

(e) Work with the department bureau in training technology development.

(2) An applicant shall submit the ~~completed application~~ **letter of intent** and supporting documentation to the ~~department~~ **bureau** region coordinator assigned to his or her area who shall do both of the following:

(a) Contact ~~its~~ **1 or more rtc's** that border the proposed rtc for a letter information regarding **outlining their opinion regarding** the need and effect of a **potential** new rtc **on their-the existing facility**.

(b) Submit the ~~application~~ **letter of intent**, supporting documentation, and a report to the ~~department~~ **bureau** on the effect a new rtc will have on existing programs.

(3) If the application meets the requirement of subrules (1) and (2) of this rule, the state fire marshal ~~and the department manager of training~~ shall approve the application. A list of approved rtc's may be placed on the agenda of the next regular council meeting.

(4) An rtc shall keep contact information for the center and advisory board membership current with the ~~department~~ **bureau**.

(5) The rtc shall perform all of the following on an annual basis:

(a) Maintain capability to conduct fire fighter I and II courses and examinations.

(b) Comply with all ~~department~~ **bureau** rules.

(c) Cooperate with the ~~department~~ **bureau** in training technology development.

(d) Submit a report to the state fire marshal annually ~~on~~ **by December 1 (when does the report go to the LARA Director's office)** for the previous year October 1 to September 30. ~~The fire marshal shall submit a copy of each report to the fire fighters training council for review at the next scheduled meeting for purposes of completing the report required under section 7 of the fire fighters training council act, 1966 PA 261, MCL 29.367.~~ The annual report by **each** rtc shall include **all of** the following: **{MOAHR required "all of the following".}**

(i) The training activity from the previous year.

(ii) The use of approved county funds.

(iii) The budget and expenses from the previous year.

(iv) The rtc training plan for the upcoming year.

(6) The state fire marshal shall authorize a regional training center to conduct the following courses or other council-approved courses:

(a) Vehicle extrication.

(b) Advanced vehicle stabilization.

(c) Elevator training.

(d) Introduction to wild land firefighting.

(e) National incident management system: incident command **and resource management** system for the fire service.

(f) Clandestine drug lab awareness.

~~—(g) Building construction for fire suppression forces: principles, wood and ordinary construction.~~

~~—(h)~~ **(g)** Drivers training, classroom portion. An **rtc** shall have available rooms and facilities to efficiently carry out its program of instruction.

R 29.414 ~~Regional training centers; courses.~~ **Council approved curriculum; requirements.**

Rule 14. (1) The minimum class size for ~~training at a regional training center an~~ **approved course** is 15 students. Exceptions may be granted by ~~the a manager of training bureau~~ region coordinator or state fire marshal upon recommendation of department staff.

(2) The maximum class size ~~at a regional training center for an approved~~ **course** is 35 students. ~~Department-~~ **Bureau** staff may approve larger classes if special circumstances exist and adequate staffing is provided.

(3) Rtc students who are not members of a Michigan fire department shall be assessed a fee per student to cover the cost of providing the certification examination as established by the bureau by January 31 prior to the next fiscal year. Fees shall be remitted to the bureau 2 weeks after the course start date as provided under MCL 29.371 (1)(j). (How do we collect fees? Exceptions to the requirement in this subrule shall be made for individuals sponsored by a fire department cadet program, a fire department boy **or girl** scouts of America explorer program or a high school training program that is affiliated with a fire department pursuant to section 2 of the firefighter training programs act, **2011 PA 153, MCL 29.332 (check for updated language).** Participants in these programs must be 16 or 17 years old and may be 18 years old if still attending high school as a full-time student. All requests for the program exception shall be sent to the ~~department~~ **bureau** staff in writing from the fire chief of the sponsoring fire department.

(b) Fire department cadets, ~~department instructors~~ **fire department members, certified fire service instructors, contracted** training coordinators ~~who are retired members of a fire department,~~ **rtc staff members**, council members, and full-time ~~department~~ **bureau** staff.

(c) Explorer scouts and students of a fire department affiliated high school program pursuant to section 2 of the firefighter training programs act, 2011 PA 153, MCL 29.332.

~~—(5)~~ **(6)** Fire department cadets, explorer scouts and fire department affiliated high school students may participate only in fire fighter I, fire fighter II, fire fighter I and II, first responder operations, and incident command system courses.

R 29.415 Online training courses.

Rule 15. (1) The state fire marshal, with the approval of the council, may endorse the implementation of online learning courses.

(i) The initial delivery of an online training course shall be a pilot program and pre-approved by the council. ~~Department~~ **Bureau** staff may proctor the pilot program in order to provide an evaluation.

(ii) Upon ~~positive~~ **review of a report from the instructors and the course manager** evaluations by the department staff, **which includes written feedback from all of the instructor instructors, and a majority all of the students, and with a positive recommendation from the regional coordinator,** the state fire marshal shall **may** approve the **future** courses.

(b) All online training shall consist of the following:

(i) A written exam.

(ii) The same learning objectives as a face-to-face training format.

(iii) A maximum student-to-instructor ratio **for practical components of a course shall be not exceed** of 20 **10** students to 1 instructor.

~~—(iv) Post evaluations for a pilot course by the students, instructor, and department staff.~~

R 29.416 County training committee; selection of members; election of chairperson.

Rule 16. (1) A county shall establish a county training committee to receive the fireworks safety fees annually from the bureau, as provided in MCL 29.371(k), 29.374

(2) A county training committee shall be made up of **one-1** member from each organized fire department and public safety department in the county.

(3) A county training committee shall elect a chairperson each year. **Every Each** fire department and public safety department in a county shall have 1 vote when electing the chairperson. The chairperson shall serve for

the calendar year beginning January 2 and the term expires January 1 of the following year.

(4) A county training committee shall notify the bureau about **who was elected chairperson of that committee** by **submitting using** bureau form 240 by January 2 of each calendar year. ~~as to who was elected as chairperson of that committee.~~

(5) If a vacancy of the chairperson position occurs during a fiscal year, a county training committee shall elect a new chairperson within 7 days of the vacancy occurring and shall notify the bureau by **submitting** ~~submission of the~~ **BFS bureau form BFS-240.**

R 29.417 Training needs survey.

Rule 17. (1) A county training committee chairperson shall **annually** conduct a training needs survey in April of each fiscal year. The survey shall be presented on the **BFS bureau form BFS-243.**

(2) **The A** county training committee chairperson shall compile an aggregate report of the results of the training needs survey including, but not limited to, a list of the fire departments within the county and whether they participated or **did not participate** in the survey.

(3) **The A** county training committee chairperson shall submit a report to **the bureau region coordinator on the bureau form BFS-244** of the results of the training needs survey. ~~to the bureau region coordinator~~ **This report shall be submitted** by May 15 of each fiscal year.

(4) A county training committee that does not submit the results of the training needs survey **will shall** result in a delay of the October 1 release each fiscal year of the fireworks safety fees allocated for that county pursuant to section _____ of 2011 PA 256, the Michigan fireworks safety act, MCL _____. *{Please add the statutory citation for the section of the act that deals with the allocation of the fees.}*

(2) The continuing education process **will shall** apply to every member of the fire service in Michigan. The program **will shall** run in a 3-year cycle.

(a) The first 3-year cycle ~~will shall~~ begin on October 1, 2019 (FY20) and end September 30, 2021. (FY 22).

(b) The next 3-year cycle will begin October 1, 2021 and continue to occur after the completion of each 3-year state of Michigan fiscal-year cycle.

(3) Every A fire service member, regardless of ~~their~~ his or her rank, shall, at a minimum, meet the fire fighter continuing education requirements during the 3-year state of Michigan fiscal-year cycle, except as otherwise provided in this rule.

(4) All training that is conducted in a council-approved sanctioned course, Q course approved conference, approved Q course on-line training platform, *{What is an online training platform?}* or training conducted by an organized fire department in this state shall ~~will~~ count towards meeting the continuing education requirement if a training roster was completed, and signed by the instructor, and submitted to the bureau.

(a) For continuing education training to count toward a continuing education requirement, ~~the an~~ instructor ~~needs to~~ shall complete a fire department specific training roster or ~~may use~~ the BFS-200 the bureau's continuing education training roster, BFS-200, if the training is provided outside of a council-approved sanctioned course.

(b) If the continuing education training is part of a council-approved sanctioned course, the training ~~will shall~~ be tracked in SMOKE *{Instead of using SMOKE, should we say "the bureau's information management system? We've used this throughout the rest of the rules.}* and the student and instructor ~~will shall~~ sign the SMOKE roster ~~and both the students and instructor will sign the roster~~ for each training calendar day segment for the course. *{What is meant by a training calendar day segment?}*

(6) At the end of the 3-year cycle, each a fire service member ~~will shall~~ log into SMOKE and check the box validating that ~~they have he or she~~ has met the continuing education requirements on ~~their~~ his or her SMOKE profile. After a fire service member ~~Once~~ checks the box in SMOKE is checked to renew all classification certifications, ~~it is possible that a person could a~~ fire service member may be randomly audited by the bureau as part of a the bureau's quality assurance process. ~~by the bureau.~~ A fire service member who checks the box without having ~~met~~ completed the continuing education requirements for each classification certification or certifications in the 3-year cycle ~~will result in the revocation of~~ shall have his or her classification certification or certifications revoked due to making a materially false statement as outlined in R 29.410a. ~~A fire service member that have who has not completed the required continuing education within~~

the 3-year cycle will be afforded allowed a 90-day grace period to complete the continuing education requirements for the previous cycle.

(7) The following are the continuing education requirements for each classification of certification.

(a) Fire fighter: ~~Obtain~~ An individual who has been certified as a fire fighter shall obtain a total of 36 hours during the 3-year cycle with a minimum of 6 hours per year, commensurate to meet the specific duties and functions that the employee is expected to perform during the 3-year cycle as a member of a fire department. *{Should this also specify fire fighter I, fire fighter II, etc.??}*

(i) For a fire fighter who is a member of more than 1 fire department, the common training topic hours may be used at all the fire departments, if the training is commensurate with common duties and functions performed at each fire department. If 1 of the fire departments has specific duties or functions that exceed the other fire departments duties or functions, the member shall complete the additional training if identified by the AHJ where the member is rostered.

(ii) ~~Additional continuing education credits are needed for any member holding~~ A member who holds a classification certification above the fire fighter classification ~~continuing education requirement~~ shall obtain the required additional continuing education credits for that classification.

(iii) Fire fighter continuing education is required for all Michigan fire fighters in this state, including those who were exempted from fire fighter I or fire fighter II certification due to being employed by a fire department prior to October 1, 1988.

(b) Fire service instructor: An individuals completing who has completed the fire instructor I classification or a higher classification and who have made application applied to the bureau to be classified as a fire service instructor, and who has been have become certified as a fire service instructor shall complete 12 hours of fire service instructor continuing education by attending a council-approved fire instructor or MDHHS EMS *{Spell out}* conference during the 3-year cycle.

(i) Fire service instructor continuing education is in addition to other certification continuing education requirements.

(ii) An individual who completes the next level of fire instructor certification above the current instructor certification during that 3-year cycle or maintains an EMS instructor coordinator license issued by _____, pursuant to _____, shall have has met the continuing education requirement for fire service instructor. *{Does the state issue EMS instructor coordinator licenses? If it does, then the statutory citation should be noted.}*

(9) Fire officer: An individual who has been certified as a fire officer shall obtain 12 continuing education hours in subjects that include fire safety and health, leadership, incident management, or fire tactics while attending a council-approved course(s) or, training specific to the topics in this section at their department, or attend a professional development

conference in the 3-year cycle. A fire officer may complete either the next level of the nfa certified fire officer certification above you're-his or her current nfa certified fire officer certification during the 3-year cycle, attend the national fire academy during the 3-year cycle, or complete a college course with at least 3 credit hours related to the subjects specified in this subrule above during the 3-year cycle.

(10) Fire inspector: An individual who has been certified as a fire inspector shall complete all the requirements in Public Act 207 Rule set R29.506 (60 credits, 10 minimum per year, in the 3-year cycle). *{This language needs to be clarified.}*

(11) Fire investigator: An individual who has been certified as a fire investigator shall obtain 12 hours of continuing education in the subject of fire investigation in a 3- year cycle. A fire investigator may obtain the required hours of continuing education either by attending conferences, seminars, and a course sponsored by the international association of arson investigators, conferences, seminars, and courses or by attending council approved conferences, seminars, and courses. An individual also may attend during the 3-year cycle a fire investigation topic sponsored by the national fire academy. ~~during the 3-year cycle.~~

(12) Airport rescue fire fighter: An individual who is certified as an airport rescue fire fighter shall complete the continuing education as required by the federal aviation administration under Title 14 Code of Federal Regulations, Part 139 for initial training, 14 CFR 139 (Please add the year of the most current version of this CFR, as required by MOAHR. This information should be in parentheses.)

(13) Hazardous-material responder: An individual who is certified as a hazardous-material responder shall obtain 2 hours of continuing education per year for every fire service member trained to the operational level during the 3-year cycle. A fire service member who is trained above hazardous material operations certification shall meet the requirements of the AHJ (fire department, county hazmat team, RRTN MIOSHA Part 74). *{The language on AHJ etc. needs to be clarified.}* Hazardous-material responder continuing education hours ~~can~~ may count toward the fire fighter continuing education hours.

(14) Technical rescue responder: An individual who is certified as a technical rescue responder shall obtain 2 hours per year of awareness for all fire service members that could respond to an event outlined in nfa 1670 for a total of 6 hours during the 3-year cycle. *{The language on "awareness for all fire service members, etc. needs to be clarified. Not sure the readers will know what this means.}* A fire service member who has been trained above the awareness level per nfa 1670 ~~must~~ shall meet the training requirements established by the AHJ (fire department, local county or regional tech rescue team or training requirement required to be a member of Michigan Task Force 1). Tech rescue responder continuing education hours may count toward fire fighter continuing education hours. *{This language also needs to be clarified.}*

(15) Fire chief-public safety director: An individual who is certified as a fire chief or public safety director shall obtain attend-12 hours of continuing education training-at a council-approved leadership, management, and fire officer training, or complete the next level of council-approved nfpa 1021 fire officer certification during the 3- year cycle or attend the national fire academy during the 3-year cycle.

(a) If a fire chief or public safety director is a certified fire officer, the fire chief or public safety director shall only be required to meet only the fire chief-public safety director continuing education requirements.
