#### 5. STATE FIRE MARSHAL'S REPORT

Fire Marshal Miller introduces Gary Crum's replacement, T.J. Richardson, who gives a brief background of his experience.

Tuesday, August 18, at 12:00 pm will be the official launch date of SMOKE. At 5:00 pm Monday afternoon the IMS system will be turned off.

Councilperson Pettinger inquires about the status of the CEC credits in SMOKE. Currently, the SMOKE system is not keeping track of CEC credits, but Fire Marshal Miller will verify this information.

### 6. COMMITTEE REPORTS-Blomstrom

Councilperson Blomstrom follows up on various issues and discusses recommendations made by the Curriculum Committee. The question was asked if the Q courses will be tracked in SMOKE. The courses will have to be entered into IMS; however, the course will not be reflected in the students' record.

#### **FEMA Grant**

At the last meeting, Councilperson Blomstrom requested to review the FEMA grant, specifically the Narrative and Addendum that was sent to FEMA. The Initial Narrative and the request after that, if there is one, to use \$200,000 for computers were not included in the Award Packet provided by Fire Marshal Miller and the Council requests that all members get a copy of that.

### West Michigan RTC Reorganization Notification

A letter was sent from Robert Austin, Chair of West Michigan Regional Fire Training Center, summarizing their activity during the 2014 fiscal year, as well as their reorganization and reassessment of the role it would take in the five counties it currently represents. WMRTC has ended its long standing ties with Muskegon Community College, as the fiduciary. The Muskegon County Fire Chief's Association has taken on the role of the new fiduciary. The WMRTC has also entered into a trial agreement with Baker College of Muskegon to provide a pre-service academy beginning the fall of 2015. An updated Advisory Board form will follow the election of new officers.

Matt Majestic echoes Martin Erskine's inquiry. The logistics of approvals and recommendations were also clarified.

## 10. Council Comment

Vice Chairperson Blomstrom expresses appreciation for his vice chair nomination. Discussion of NFA courses and availability was brought up. Mike Greis was the previous contact with NFA, so the process of updating the contact is in place. The inquiry was made regarding County payments changing. Should notification be made that an organization needs to be established in every county due to no longer paying individuals? Fire Marshal Miller will provide clarification on this.

Councilperson Tackett welcomes the 2 new council members and also expresses his appreciation for the audience support.

Councilperson Blackmer expresses his gratitude for the opportunity to be a part of the Council and the assistance in getting up to speed.

Councilperson Hondorp states that he is looking forward to working with the Council.

Councilperson Pettinger also welcomes the new members, as well as TJ Richardson.

Chairperson James wishes good luck on the 18<sup>th</sup>, with the SMOKE transition. Expresses sincere appreciation to Liz Smalley for all of her assistance and wishes her well.
