

# LICENSURE REQUIREMENTS CHECKLIST

(Listed below are the minimum requirements needed to obtain licensure in the Speech-Language Pathology field.)

	Application for a Speech-Language Pathology License - Complete all fields, answer all questions and submit any supporting documentation.

	Application Fee (Must be paid by check or money order payable to The State of Michigan):
	Educational Limited – \$183.80 (Valid for 2 years from date issued) Educational Limited Relicensure – \$203.80 Limited Relicensure ( <b>Certified Teacher Only</b> ) – \$122.70 Speech-Language Pathologist – \$102.70 Speech-Language Pathologist Relicensure – \$122.70
	Application fees are valid for a year or less (unless otherwise stated) to get you into the renewal cycle for your profession.
	THE FOLLOWING REQUIREMENTS APPLY TO ALL APPLICANTS (EXCEPT RENEWAL)
	Criminal Background Check – Once the application is received, you will be mailed an Application Confirmation letter containing instructions to complete the Criminal Background Check (except those applicants seeking relicensure, if the license expired within the last three years.)
	Good Moral Character Questions – Documentation will be required if you answer "yes" to either question to show at the current time you have the ability to, and are likely to, serve the public in a fair, honest and open manner, that you are rehabilitated, or that the substance of the former offense is not reasonably related to the occupation or profession for which you are seeking a license.
	Human Trafficking – Beginning March 16, 2021, individuals seeking licensure must have completed training in identifying victims of human trafficking that meets the standards in Administrative Rule 338.604 prior to being issued a license. The training must only be completed one time.
	Social Security Number – An individual applying for licensure is required to provide his or her social security number at the time of application. If exempt under law from obtaining a SSN or do not have a SSN, a statement in writing is required at the time the application is submitted.
	Verification of Licensure – If you hold a current license or ever held a license as a speech-language pathologist, verification of licensure will be required to be submitted directly to this office by the licensing

	Verification of your American Speech Language Hearing Association (ASHA) OR the Canadian Association of Speech-Language Pathologists and Audiologists (CASLPA) current certification sent directly to this office. The verification must include your name, the date your certification was issued, the expiration date of your certification and it must specify that your certification was issued in speech-language pathology. 	➢ If the education was not taught in English, you must obtain either a score of 570 on the written TOEFL exam, 230 on the computerized TOEFL exam and a score of 50 on the TSE exam, or an overall score of 89 or above on the TOEFL iBT examination.

	Verification of your American Speech Language Hearing Association (ASHA) OR the Canadian Association of Speech-Language Pathologists and Audiologists (CASLPA) current certification sent directly to this office. The verification must include your name, the date your certification was issued, the expiration date of your certification and it must specify that your certification was issued in speech-language pathology. 	Have the final official transcripts, showing the date the degree was conferred, for a master's or doctoral degree forwarded directly to this office from your educational institution.

	If licensed less than 5 years, submit the Post-graduate Clinical Experience form verifying 9 months (1,260 hours) of supervised post-graduate experience.
	ADDITIONAL REQUIREMENTS FOR SLP RELICENSURE
	Proof of 20 hours of continuing professional development courses are required to be submitted, including 1 hours in pain and/or symptom management.
	If the license has been lapsed more than 3 years and the applicant is not licensed in another state, passing results of the PRAXIS Series II Exam is required.
	Certified Teacher Limited License Holder ONLY – Relicensure is only available up to 3 years after lapsing.
	ADDITIONAL REQUIREMENTS FOR EDUCATIONAL LIMITED LICENSURE FOR SLP
	Final, Official Transcripts – Transcripts must be submitted directly to our office from the school attended and meet the standards set forth by the Board. Renewal Cycle:
Speech-Language Pathologist – 2 Years Speech-Language Pathologist Ed. Limited – 2 Years (may renew a maximum of 2 times) Speech-Language Pathologist Limited – 2 Years
Good Moral Character Questions – Documentation will be required if you answer "yes" to either question to show at the current time you have the ability to, and are likely to, serve the public in a fair, honest and open manner, that you are rehabilitated, or that the substance of the former offense is not reasonably related to the occupation or profession for which you are seeking license renewal.
Disciplinary Question – Documentation will be required if you answer "yes" to having sanctions imposed against you by a similar licensure, registration, certification, or disciplinary board of another state or country you have not previously reported to the department.
Human Trafficking – Beginning in 2018, and all renewals thereafter, licensees seeking renewal must have completed training in identifying victims of human trafficking that meets the standards in Administrative Rule 338.604 prior to renewing their license. The training must only be completed one time.
Accept Renewal Attestation - By accepting the renewal attestation you as the licensee are certifying that you have met all of the following continuing education requirements during the 2-year period immediately preceding the application for renewal:
20 hours of continuing professional development courses approved by the board of which includes a minimum of 1 hour in pain and/or symptom management.
