Applicants with a BEI Credential

- An applicant must possess an associate's degree or higher from an accredited institution and provide a copy of final official transcripts confirming graduation submitted directly to this office from the educational institution **OR** provide proof that the applicant has maintained current state or national certification prior to July 7, 2014.
- If you took the BEI examinations in another State, have the exam scores sent to this office directly from the examining State.

Applicants with a RID Credential

- Submit a copy of your valid RID membership card showing the credential(s) you possess.

Applicants with an EIPA Credential

- Submit your passing EIPA performance scores of 4.0 or higher.
- Submit your passing EIPA written test scores.

NOTE: Upon approval of this application, an EIPA credentialed interpreter will receive a Michigan certificate to perform elementary and/or secondary education interpretation based on their EIPA credential. An educational endorsement is no longer required to perform interpreting in an educational setting.

CERTIFICATION
