- (ii) Was engaged in the private security guard or agency business for a period of at least 4 years as an employee of the holder of a certificate of authority to conduct a private security guard or agency business and has experience reasonably equivalent to at least 4 years of full-time guard work in a supervisory capacity with rank above that of patrolman.
- (iii) Was employed in law enforcement as a certified police officer on a full-time basis for at least 4 years for a city, county, or state government or for the United States government.
- (iv) Was engaged in the private security guard or agency business as an employee or on his or her own account or as a security administrator in private business for at least 2 years on a full-time basis, and is a graduate with a baccalaureate degree or its equivalent in the field of police administration or industrial security from an accredited college or university.
- (v) While on active duty as a member of the armed forces, served as a military police officer or in an equivalent job classification for at least 2 years; was honorable character of service or under honorable conditions (general) character of service from that military service; and provides with his or her application an affidavit signed by a commanding officer, supervisor, or military superior with direct knowledge of the applicant's service that he or she has, entry-level experience in or basic knowledge of each of the following:
  - (A) Enforcing rules, regulations, and guidelines.
  - (B) Providing security and physical protection.
  - (C) Area and site security operations.
  - (D) Overseeing prisoners and correctional facilities
  - (E) Reconnaissance and surveillance.

If you are applying for a security alarm system contractor license, you must have been lawfully engaged in either or both of the following: (check all that apply)

A security alarm system contractor business on his or her own account for a period of not less than 3 years.

A security alarm system contractor business for a period of not less than 4 years as an employee of the holder of a certificate of authority to conduct a security alarm system contractor business, and have experience reasonably equivalent to at least 4 years of full-time work in a supervisory capacity.
