Re: Announcement of Planned Action

To Whom It May Concern:

I am writing on behalf of Rainbow Child Care Centers ("Rainbow") to inform you that due to the recent merger between Rainbow and KinderCare Education, LLC ("KinderCare"), Rainbow will permanently reduce its workforce at its Home Office located at 1732 Crooks Road, Troy, MI 48084 ("Home Office"). This letter serves as an official 60 day notice under the federal Worker Adjustment and Retraining Notification ("WARN") Act, 29 USC § 2101 et seq.

We currently expect the permanent reduction will impact forty-three (43) Rainbow employees at the Home Office. While this number does not currently meet the "plant closing" or "mass layoff" definitions under the WARN Act, it is important to us that we be fully transparent and comply with the spirit of the law, which is why we are providing you with this advance notice.

The expected date of the first separation is January 4, 2019 and the reduction is expected to take place in three waves, with the second and third waves on April 5, 2019 and July 2, 2019, or within 14 days thereafter. There are no provisions in Rainbow's policies related to bumping rights and the affected employees are not represented by a union. As we learn more about how Rainbow and KinderCare will integrate, we may offer some affected employees the opportunity to transfer to another location or job.

We have already provided all affected employees with written notices about these plans and the planned separation dates. The job titles of positions that will be affected, with the corresponding number of affected employees in each job classification, is as follows:
