Re: WARN Notice – Detroit Entertainment, L.L.C. d/b/a MotorCity Casino Hotel

Dear Ms. Howard,

MotorCity Casino Hotel ("MotorCity") is providing the following information pursuant to the Federal Worker Adjustment and Retraining Notification Act of 1988 ("WARN Act") which requires employers to give notice to certain persons and government officials of a pending mass layoff or plant closing.

As you know, Michigan Governor Gretchen Whitmer has issued a number of Executive Orders directing that all casinos licensed by the Michigan Gaming Control Board ("MGCB"), including MotorCity's casino, and various related amenities, be closed to the public. These include:

Executive Order 2020-09 (ordering casinos closed through March 30, 2020)

Executive Order 2020-20 (ordering casinos closed through April 13, 2020)

Executive Order 2020-43 (ordering casinos closed through April 30, 2020)

Executive Order 2020-69 (ordering casinos closed through May 28, 2020)

Executive Order 2020-100 (ordering casinos closed through June 12, 2020)

Executive Order 2020-110 (ordering casinos closed indefinitely)

Based on the initial order, MotorCity's casino and various related amenities, located at 2901 Grand River Blvd, Detroit, MI 48201, were closed, and we temporarily furloughed most of our workforce on March 16, 2020. Associates on temporary furlough status continued to be paid through March 30, 2020.

At the time of those initial furloughs, we had no advance notice and were thus unable to provide Associates or others with advance notice, and, in any event, we were optimistic that we would be able to reopen our casino and related amenities relatively quickly. We did not then (or for quite some time thereafter) reasonably foresee any likelihood of the temporary furloughs extending beyond six (6) months; thus, we did not foresee any permanent layoffs.

Following issuance of the initial Executive Order, we began discussions with City and State officials regarding re-opening of our facilities. Those discussions continued, with the expectation on our part that reopening would soon be permitted. Unfortunately, because of extensions of the

closure pursuant to a series of Executive Orders (and issuance of various Executive Orders requiring individuals to stay at home), along with the unanticipated duration and severity in Michigan of the COVID-19 pandemic, we were unable to obtain a firm reopening date.

In early June, MGCB issued reopening guidelines for casino licensees. Those guidelines impose severe restrictions on initial operations, including: the number of guests in the casino cannot exceed 15% of our permitted occupancy levels; social distancing is required in a way that will limit the number of players at table games and result in about half of our slot machines not being available for play; the poker room, valet, and coat check cannot operate; and we cannot hold events in our Sound Board theater.

In recognition of the limitations under those guidelines, we concluded that our operational levels would be seriously reduced. Thus, we reached the conclusion late last month that only about half of our Associates would be needed when we re-opened, and we had no way to predict when we would be permitted to increase operations enough to make it feasible to bring everyone else back to work. Accordingly, and out of an abundance of caution, we provided WARN Act notices with respect to the Associates we then believed would not be returned to work for our initial reopening. Because we were still optimistic that reopening would occur by early July, we committed to continuation of benefits through the end of July, 2020 for all of our qualified Associates (and their qualified dependents), whether working for us or not.

Since that time, we have continued to work with City and State officials in an effort to obtain permission to reopen. Despite our repeated expressions of commitment to very conservative guidelines designed to protect Associates and guests, we have been unable so far to reopen our casino. Given the current status of the COVID-19 pandemic in Michigan and the growth of COVID-19 cases in other areas of the country, our Governor recently retreated from her late June public comments indicating that we would soon be able to reopen and publicly indicated, instead, a reticence to permit businesses such as ours to reopen any time soon. Although we remain optimistic about reopening soon, we do not know exactly when that will occur nor do we know exactly what limitations will be imposed on our operations. We also cannot predict at this point how many Associates we will be in a position to bring back to work initially or in the weeks following our reopening. In light of this new uncertainty, and the related economic realities, we have reached the conclusion that, to protect the long-term viability of our business, we must formally lay off Associates effective at the end of the day on July 31, 2020.

In light of those unanticipated circumstances, although we continue to be optimistic that these layoffs will just be temporary, we are no longer able to say with confidence that the loss of employment will not last more than six months. Accordingly, although we remain hopeful that all of our Associates will be returned to work in the very near future, for the reasons set forth above, as well as other reasons, it is now reasonably foreseeable that the temporary furloughs that occurred in March of 2020, and these newly scheduled corresponding layoffs as of the end of the day on July 31, 2020, may result in loss of employment beyond six (6) months and/or could become permanent for certain Associates. Because of that, this situation may constitute a covered event under the WARN Act. Thus, we are providing you with this notice. Please note that we are not conceding that the WARN Act applies or that notice is required.

A list of the job titles of positions affected and the number of affected Associates in each job classification is attached. Consistent with the forgoing explanation, the layoffs are currently

scheduled to be effective at the end of the day on July 31, 2020. Associates who are represented by unions may have recall and/or bumping rights under the collective bargaining agreement that covers them, and we will, of course, honor those rights. Those Associates who are not represented by unions do not have bumping rights.

There are seven (7) separate unions representing various employees at MotorCity. UNITE HERE Local 24, International Union of Operating Engineers Local 324, United Auto Workers Local 7777, and International Brotherhood of Teamsters Local 1038 represent employees as part of the Detroit Casino Council. Security Officers are represented by Security, Police and Fire Professionals of America (SPFPA) Local 1212. Surveillance Hardware Technicians and Surveillance Operators are represented by the United Government Security Officers of America (UGSOA), Local 265. On call employees who perform services for MotorCity within its theatre and convention center are represented by I.A.T.S.E. Local 38.
