 - » If more than one ownership transfer of the land covered by the agreement has occurred due to divisions into smaller parcels of land, provide all deeds, land contracts, and/or death certificates used for the land transfers and sales.
 - » If the land is owned by a trust, provide the certificate of trust.
- A copy of the death certificate, if the transfer is due to death.
 - » A copy of the deed is required if your name was listed on the current agreement.
- A copy of the latest property tax bill(s).
