#### Requests should be sent to the board at least 10 days before the start date of the event.

• Provide a full description of the request being made and the way wagers would be placed, and winning wagers would be determined.

 Provide an explanation that addresses the method by which wagers will be posted, wagering limits, and at the date and time acceptance of wagers will cease. For new league or new event requests, provide the types of wagers to be offered and wager and payout limits. • Provide a full description of any technology which would be utilized to offer the league, event, or wager types.

• Provide a description of the policies and procedures regarding the league, event, or wager's integrity. If this is a new league request, provide a copy of the league's integrity policy.

- Provide a listing of any known scandals, match fixing investigations, criminal investigations, or other incidents that could possibly compromise the integrity of any players, teams, leagues, tournaments, or exhibitions.
- Provide a description of any communication or cooperation made or attempted between the licensee and the organizer or governing body, including a copy of any written responses from the organizer or governing body to the notification by the licensee.

- Provide such other information or documentation which demonstrates that:
  - The event can be effectively supervised by a sport governing body or other oversight body.
  - There are integrity safeguards in place.
  - $\circ$   $\;$  The outcome can be documented and can be verified.
  - $\circ$   $\;$  The outcome can be generated by a reliable and independent process.
  - $\circ$   $\;$  The outcome is not affected by any wager placed; and
  - $\circ$   $\;$  The event is conducted in conformity with all applicable laws and rules.
  - Wagering on the event and acceptance of the wager type are consistent with the public policy of this state.
  - Include salary/pay/compensation scales for players, if professional level.

• For event categories other than athletic events, please provide any rules or voting procedures related to the event category.

• Will tier 2 wagers, as defined in the Sports Betting Act, be offered for the new league, event, or wager type?

• In what other jurisdiction(s) are the league(s), event(s), wager(s) approved? What jurisdictions have not approved this league/event?

• If existing Michigan Gaming Control Board (MGCB) approved House Rules do not adequately address contingencies of the league, event, or wager type, the licensee must submit amended House Rules for approval.

The board may require an appropriate test or experimental period and subject any technology that would be used to offer an event category or wager type to such testing, investigation, and approval.

The board reserves the right to prohibit the acceptance of wagers and may order the cancellation of wagers and require refunds on any event for which wagering would be contrary to the public policies of the State of Michigan.
