Chain S. Sandhu, Chairman of NYX Inc. is a testament to the results of an uncompromising work ethic and a desire to succeed. From humble beginnings in a small village in what is now part of Pakistan, Mr. Sandhu has become one of the most successful entrepreneurs in Michigan.

Mr. Sandhu's beginnings are not those typically associated with the type of success he has achieved. Growing up in a small village where education was typically not a priority and losing his father at the age of five, Sandhu later went to Guru Nanak Engineering College (GENC). After a successful college career, Mr. Sandhu went on to complete his masters in engineering and later on to work as an Assistant Professor at Punjab Engineering College in Chandigarh. However, in 1969, his ambition led him to leave his secure job and to come to the United States.

In addition to the opportunities that the United States showed, it also posed many new challenges. At General Motors, Sandhu held every position imaginable, including a stint as a janitor. But through his persistence, Sandhu was able to rise through the ranks to become one of the most successful engineers at General Motors.

Eventually, ambition led him to leave General Motors and buy a faltering company which eventually became the successful NYX. As Chairman of NYX, Sandhu grew the company from 50 employees to a total of 2000 and revenues from 2 million to 400 million in 2016. His business continues to grow, servicing major companies such as GM, Ford, Lear, Honda, VW and Tesla.

Sandhu's success as an entrepreneur (Ernst & Young's) "Entrepreneur of the Year" in 2000 is matched by his success as a humanitarian. He was awarded the "Humanitarian of the Year" by the MMBDC (Michigan Minority Business Development Council) in 1999, Sikh Heritage Achievement Award in 2001 and in 2003, a recipient of the Vision in American Award given by the Comcast / International Channels Network for outstanding contribution to the immigrant community. In 2003, 2004, 2005, 2006, 2007, 2008, 2014, 2015 and 2016 NYX was honored to receive the "GM Supplier of the Year" award given by General Motors.

Frank is a Detroit entrepreneur and the grandson of Mexican Immigrants. Early on, he capitalized on a winning raffle ticket by using the proceeds of a new Cadillac and following his grandfather's sage advice – "Do what your boss does not want to do!" – to launch his first company in 1979.

Today, The Ideal Group, a family-owned company, has evolved into eight nationally recognized companies with annual revenues approaching \$300 million and employing more than 700 people. Over the years, family members Loren (brother), Linzie (daughter), and Jesse (son) joined the Ideal leadership team as owners.

Based on the Venegas family core values, Ideal companies continually meet and exceed customer needs in construction, facilities management, manufacturing, indirect material management and surplus sales. Recently, General Motors awarded Ideal its 13th Global Supplier of the Year Award.

Two of Frank's notable commendations are from Dartmouth College: an honorary doctorate degree in humane letters (2016) and the Martin Luther King Social Justice Award for Ongoing Commitment (2015).

In 2012, the government of Mexico recognized Frank Venegas with the Ohtli Award; it's the highest award to a foreign citizen.

These degrees and awards are tributes to Ideal's corporate culture of membership, advocacy and philanthropic contributions to southwest Detroit schools and organizations that provide pathways for educational and career opportunities. A Syrian immigrant from Xicotencati, Mexico, she could not speak a word of English when she arrived in the U.S. in 1946. After growing up in Miami, she married James Elder in 1963 and moved with him to Michigan where he opened a Ford dealership in Troy, Michigan.

With no experience and three young children, this reluctant pioneer took over the business after her husband's sudden death in 1983. She defied the odds and built it into one of the largest woman-owned businesses in the country.

Over the last fifteen years Michigan's immigrant population, today totaling 650,000 foreign born residents, has grown 24.5%, while native born population has declined 1.5%.¹

In Michigan, 31,000 immigrants are self-employed, and immigrant-owned businesses employ over 150,000 other people.²

Immigrant owned businesses generated \$608 million in business income, putting more people to work and creating new jobs.³

76% of all patents issued to top research universities are owned or co-owned by an immigrant.⁴
