



Michigan Department of State Qualified Voter File Data Request Form and Instructions

This form is used to request information from the Qualified Voter File. All electronic data will be in CSV file format and provided on an encrypted flash drive. Electronic files have the option to be transferred via FTP, if FTP is set up and connecting information is provided to the Bureau of Elections. **Digital dropbox transfer is not available.** Due to personal privacy, electronic files will NOT be transferred via email. The option to pick the encrypted flash drive up at the Bureau of Elections, during regular business hours, is also available.

Information that is exempt from FOIA is:

- The record that a person declined voter registration
- The office that received a registered voter's application
- A registered voter's driver's license or state personal identification card number
- The month and day of birth of a registered voter
- The telephone number provided by a registered voter
- The email address provided by a registered voter
- The digitized signature of an elector that is captured or reproduced and transmitted to the Qualified Voter File
- The last 4 digits of a registered voter's social security number contained in a registration record

Format: All electronic data will be Fixed Length ASCII.

Each list will include complete name, residential address, mailing address (if available), year of birth, registration date, voter status, voter ID and voter history (when available and requested). As a part of your request, we will include an electronic list of jurisdiction codes, school codes, and county codes. You will also receive a file layout that contains key information about codes used in specific data fields (e.g. voter status contains the following codes: A = Active, CH = Challenged and V = Verify).

As a public body, MDOS is subject to the Michigan Freedom of Information Act (FOIA), MCL 15.231 et seq., and information such as a name or address may be disclosed in response to a FOIA request pursuant to law.
