**Vehicle eligibility:** The plates listed below may only be issued to a non-commercial vehicle, including passenger vehicles, motor homes, pickups, and vans. The vehicle must be owned or leased by the applicant for all plates except the Michigan Professional Fire Fighters Union (MPFFU) plate. For the MPFFU plate, the vehicle may be owned or leased by the organization member or an immediate family member.

**Expiration:** Special organization plate registrations expire on the vehicle owner's birthday.

## Plate type selection (select only one):

*If you are applying for an additional plate for another vehicle, please complete an additional application.*

You must be a **current member** of one of the five organizations listed. With the exception of the MPFFU plate, spouses and family members are not eligible for these plates.

For the following three plate types, **proof of membership must be submitted with this application:**

Grand Lodge of Free and Accepted Masons of Michigan

Michigan State Firemen's Association

Police Officers Association of Michigan

For the following two plate types, **the department verifies membership with the organization after application:**

Fraternal Order of Police

Michigan Professional Fire Fighters Union

## Fees:

Regular registration fee plus \$25 service fee. A current plate on the same vehicle may be canceled as credit for the regular registration fee. If you wish to cancel a current plate, provide the plate number and current expiration date:
