8	are very time-consuming endeavors. So we're probably
9	going to be starting that, in earnest, here very
10	shortly, right after the holidays. So I think we'll be
11	giving an update maybe at the next meeting on our
12	strategy for that. So

6	of \$28,000 per year.
7	467 was the purchase of five Chevy Tahoes in
8	the amount of \$182,000 for the police department
9	vehicle fleet.
10	485 was an agreement for janitorial supplies
11	with Arnold Sales, adding about \$8,500 to the existing
12	contract.
13	486 was a change order with WT Stevens for an
14	emergency water line replacement in the amount of
15	\$6,200.
16	487 was a Memorandum of Understanding to use
17	CDBG funds in the amount of \$240,000 for the
18	Brennan Center roof replacement.
19	488 was a budget amendment regarding the
20	health advisor budget in the amount of \$285,000. This
21	is a grant funded grant funded budget amendment.
22	Resolution 489 was the acceptance of a Health
23	and Human Services grant for mental health services in
24	the amount of \$972,000 for year one. This is a
25	possibility of a four-year grant project in the amount

13	reading was conducted at the prior meeting.
14	Resolution 497.2 was the public hearing that
15	was held on that specific ordinance adoption.
16	And then you have Resolution 511, which
17	Mr. Headen asked to be separated for additional
18	discussion. That is the acceptance of a grant from the
19	MDEQ. It's a budget amendment in the amount of
20	\$860,000 for water distribution optimization.
21	THE CHAIRPERSON: Given the absence of the
22	Chief Financial Officer this afternoon, I'm sure due to
23	the weather, we'll simply include Resolution 511 in
24	with the other two, 497 and 497.2, and I'll ask for a
25	motion that those resolutions be approved.

7	MR. FINNEY: No, nothing from me.
8	THE CHAIRPERSON: If not, we'll consider that
9	Budget to Actual Report to have been received.
10	There is no public comment. We do have the
11	Chief Legal Officer for the City here. As I indicated,
12	I think, to Mr. Finney earlier, Ms. Oakes did raise the
13	possibility of us considering a resolution that was
14	adopted by the City Council just this Monday night
15	regarding the possible settlement of a federal lawsuit.
16	Ms. Oakes, is that something that you wanted
17	to elaborate upon?
18	MS. OAKES: Yes, for the benefit of the other
19	RTAB members whom I have not had the opportunity to
20	speak with, we did receive on December on November
21	the 30th an order from the Eastern District at
22	4:45 p.m., in essence, calling for us to codify our
23	rental code. We were unable to get a City Council
24	meeting for lack of a quorum and they did have a
25	Special Council meeting on Monday, December 11, at

1	which they voted to approve the rental code. In
2	essence, the judge is requesting that this ordinance be
3	passed, in an effort to make a federal lawsuit moot,
4	where a resident has sued the City of Flint due to
5	rental inspections that he feels is not valid.
6	THE CHAIRPERSON: I did indicate to Chief
7	Legal Officer the Board's general distaste with taking
8	up items at the last minute that we've not had a chance
9	to read or review, which I think applies here.
10	But, as I indicated, out of courtesy, given
11	the fact that she's here and made an effort to come to
12	the meeting, I want to at least bring the issue to the
13	attention of the other three of you.
14	I'm going to leave this up to the Board to
15	decide whether we take this issue up this afternoon. I
16	will only indicate, as an individual member, I have
17	some discomfort signing off on a resolution, not
18	because of the subject matter but simply it's something
19	that I've not had a chance to read, our staff has not
20	had an opportunity to review it and to pose any
21	questions that they might have.
22	But I'll leave it up to to the Board to
23	decide whether or not we wanted to take this issue up
24	this afternoon.

Mr. Ferguson?

1	MR. FERGUSON: What are the pros and cons
2	about the merits of the resolution, you know, without
3	dealing with the technicality?
4	What's what does this do for you and why
5	is it necessary right now?
6	If we do this, what does it harm? You know.
7	MS. OAKES: Ultimately, the harm would be the
8	judge may see this as not taking advantage of an
9	opportunity that she has given the City to codify their
10	rental ordinance to make sure that this case can be
11	moot once it comes before her for a status conference,
12	that, with the which is before the next RTAB
13	meeting, as Mr. Headen has indicated. And, as I I
14	have here, the resolution was passed by City Council so
15	there it's not in dispute as it relates to City
16	Council.
17	MR. FERGUSON: So the City Council passed the
18	resolution?
19	MS. OAKES: City Council has passed the
20	resolution and, essentially, this is the next step, for
21	the RTAB to sign off on the resolution.
22	THE CHAIRPERSON: And does a status
23	conference occur before the 11th of January?
24	MS. OAKES: Absolutely, Mr. Headen, or I

6	Madam Attorney down there without that. But we have
7	said in the past that we wanted to hear from the Mayor,
8	saying, you know, that she would not veto it.
9	And all of these things conditional, again,
10	based on those issues, I think that's what I'd like to
11	add on there, getting, also, some sort of written
12	statement from the Mayor saying that she will, you
13	know, waive that right or to veto it, I think should
14	be added to it as we go forward.
15	But I also just wanted to caution everyone
16	that we're setting a precedent that that would happen
17	on a regular basis. And we've seen this already. It's
18	not like it's something new. We've seen various
19	attempts at this in the last six, eight months, nine
20	months. And so I just think that it will be continued.
21	THE CHAIRPERSON: Thank you. And I agree
22	with your your comments and I think we all have to
23	be careful to make sure that this is an exception and
24	not does not become the rule

Attached, please find the City of Flint's Budget to Actual Revenue and Expenditure Report and Cash and Investment Summary for the period ending November 30, 2016 for your review and submission to the RTAB. This financial information is provided in accordance with the City of Flint Emergency Manager Order 20 - Ambrose.

Please note that the reporting includes the City's fiscal year end June 30, 2016 along with the November 30, 2016 financial information. The June 30, 2016 activity shown in the attached reports is audited.

All 6/30/2016 operating fund, fund balances, during audit, and during final posting are in compliance with PA 2 of 1968 as amended as well as operating fund cash balances with the exception of the City's Grant Fund (274). The City is in the process of requesting reimbursement from the federal and state government for expenses incurred but not reimbursed within this operating fund. The cash reserve within the City's Grant Fund 274 has increased by \$461,985 (-\$1,070,524 to -\$608,539) since July 2016.

The audit work is required by Public Act 2 of 1968 as amended and City Ordinance #3855. The audited financial report was submitted to the State on 12/20/2016. The City's Single Audit report is still being worked on. It is anticipated that the Single Audit will be on file in compliance with State law so no later than 3/31/2017.

As stated earlier, the reporting also highlights the November 2016 activity for the new fiscal year. As you review the information, please know that revenues are seasonal and are ahead of monthly projections due to early fiscal year collection activities. Expense appropriation line items at this time of year should be approximately 42% spent. Almost all operating funds have spent between 20% and 37% of appropriation for the fiscal year to date.

Water Collection – PA 268 of 2016:

Public Act 268 of 2016 requires that the City demonstrate a water/sewer collection rate of 70% by 9/1/2016, in order to maintain water credits for Flint water customers. As of 11/30/2016, the City has reported to the State Treasurer a 52% customer collection rate. This is an overall one percent (1%) increase in water collection looking at collections from a month to month perspective. Within this 52% collection rate, commercial class of customers have an 82% collection rate and residential class of customers have a 31% collection rate. Please know that this is gross revenue billed to gross revenue actually collected and does not include the State credits being paid by the State.

Based on current work product the State Treasurer has granted a waiver to allow the credits to continue to City of Flint water customers through 12/31/2016. Water credits end on 12/31/2016 water usage, for all Flint water customers. The City has requested from the Governor's Office an extension of this credit program. Senate Bill 800 has passed the State House and State Senate. With this Bill, the water credit program is being extended to 3/31/2017. We are awaiting the Governor's signature on said Senate bill.

It's still the City's intent to follow the law and roll eligible outstanding water balances due to the July 2017 tax bill. Payment plans will be available to those businesses that can effectively demonstrate hardship.

City Treasury has moved to collect outstanding residential balances in the same manner that we are collecting commercial customers. This process is starting in early November 2016. Please know that the City will work with those who are indigent or the elderly with limited means, to insure that a fair payment is received for water purchases. Again, failure to make payment or come up with an acceptable payment plan will result in the City enforcing the local ordinance which includes charging interest and penalty with eventual water shut-off if necessary.

Delinquent Tax Roll – Delinquent Water July 2017 Tax Roll:

On 12/19/2016, the City met with the County Treasurer and her team to discuss delinquent water that becomes a property tax lien on the July 2017 tax bill. The County Treasurer stated that the County Treasury would not collect 2015 delinquent water placed on the July 2017 tax bill and turned over to the County Treasurer in March 2018 due to the water crisis. The County Treasurer has pledged that she will work with us on certain properties to accept delinquent water and all sewer charges from 2015. However, the County Treasury Office will not accept delinquent water charges from owner occupied homes. Please know that there was no 2014 or 2015 delinquent water placed on the July 2016 tax bill due to the County Treasurer not accepting those charges in February 2016.

City legal and County legal are to get together to iron out issues to try and get those delinquent owner occupied homes 2015 water charges that are delinquent collected by the County Treasurer if applicable.

That is all that is remarkable for this report. Please let me know if any additional information is necessary or if you have any questions.
