VHS of Michigan is pleased to present to the Legacy DMC Board of Directors it's second annual report. This report has been prepared and is being delivered for the calendar year period ending December 31, 2012 in accordance with section 12.17 of the Purchase and Sale Agreement by and among the Detroit Medical Center, Harper-Hutzel Hospital, Detroit Receiving Hospital and University Health Center, Children's Hospital of Michigan, Rehabilitation Institute of Michigan, Inc., Sinai Hospital of Greater Detroit, Huron Valley Hospital, Inc., Detroit Medical Center Cooperative Services, DMC Orthopedic Billing Associates, LLC, Metro TPA Service, Inc., Michigan Mobile PET CT, LLC, DMC Primary Care Services II and Healthsource, as Seller, and VHS of Michigan, Inc., VHS Harper-Hutzel Hospital, Inc., VHS Detroit Receiving Hospital, Inc., VHS Children's Hospital of Michigan, Inc., VHS Rehabilitation Institute of Michigan, Inc., VHS Sinai-Grace Hospital, Inc., VHS Detroit Businesses, Inc., VHS Detroit Ventures, Inc., VHS University Laboratories, Inc., VHS Physicians of Michigan and CRNAS of Michigan, as Buyer, and Vanguard Health Systems, Inc. dated as of December 31, 2010 (Purchase and Sale Agreement).

Indigent and Low Income Care (Section 12.2)

In conjunction with the closing DMC adopted the Vanguard Health Systems, Inc. "Charity Care Financial Assistance and Billing & Collecting Policies for Uninsured Patients" policy. The VHS policy provides more opportunity for higher income level patients to qualify for financial assistance under the Federal Poverty Guidelines. Eligibility guidelines are updated and changed periodically and Vanguard/DMC is working under the most recent and more benevolent VHS published 2012 guidelines.

To make sure patients are aware that financial assistance ("charity care") is available to uninsured and underinsured, Vanguard/DMC posts patient-care hotline signage at all of its hospitals and at outpatient clinics and the patient accounting office. The patient-care hot line is a toll free number which patients can call to obtain information about financial aid or assistance applying for financial aid. This includes assistance with completing Medicaid applications. In addition to the signage, a toll free number is displayed on patient bills and found on the Vanguard/DMC Public Web-Site.

To ensure patients have access to both Medicaid and financial aid, Vanguard/DMC continues to follow the process of taking both Medicaid and Vanguard/DMC Charity Care applications at an in-patient's bedside or upon admission. Obtaining the application up front assists the patient in the financial aid process. In the event Medicaid denies patient coverage and the patient chooses to pursue access to financial assistance, the patient application is completed and the patient is made aware of what requirements and information is essential to be eligible for Vanguard/DMC's Charity Care program.

By calling the patient care hot line number printed on every bill, patients that are seen on an out-patient basis also have access to assistance with the Medicaid and Charity Care application process.

Additional assistance is provided to patients who have been denied coverage or have experienced problems with their care. Vanguard/DMC has a team of patient care representatives that assist patients who call with problems or complaints. We have also officially appointed an independent Ombudsman to personally assist patients with any complaints or unresolved problems. The Ombudsman serves as the patient's advocate and will assist eligible patients acquire financial aid. Both the patient care representatives and Ombudsman review patient cases and work to resolve issues. The Vanguard/DMC Ombudsman reports to the Compliance/Governance Officer, responsible for the oversight of the patient call log.

The Vanguard/DMC Public Web-Site also provides a Patient Financial Assistance/Patient Rights & Responsibilities web page with a link to a patient rights statement for adult patients and a link to Vanguard/DMC Children's Hospital of Michigan web-page for the "kid-friendly" version. Posters are located in each of our facilities and patients have access to copies of our Patient Rights and Responsibilities document. Additionally, each patient is required to sign a Vanguard/DMC General Consent for Admission and Treatment form which describes how patients can obtain additional patient rights information.

With the exception of the Vanguard/DMC patient rights hot line and the official designation of the patient Ombudsman all of the processes described above were in place in 2010 continued in 2011 and are practiced today. Vanguard/DMC's commitment to provide care to all of our patients regardless of ability to pay has not wavered nor has it in any respect been compromised. Attached please find a series of charts that show patient volumes from 2010 and 2011 vs. 2012; for inpatient discharges, bad debt and charity care and uncompensated care and our case mix index 2011 vs. 2012. Again, these charts show clearly Vanguard/DMC's moral and ethical commitment to provide quality care to all Southeastern Michigan citizens regardless of ability to pay remains unchanged.

Commitments to Maintain the Hospitals and Provide Core Services (Section 12.3)

Vanguard/DMC continues to maintain each of its Hospitals as a general acute hospital licensed in the State of Michigan, with Rehabilitation of Michigan licensed as a rehabilitation hospital licensed in the State of Michigan.

We continue to provide the Core Services as listed on Exhibit D. Each calendar quarter Vanguard/DMC affirms to Legacy DMC that Core Services remain operational at its hospitals. These services are essential to the patients and citizens of metropolitan Detroit and we have no intention or desire to discontinue providing Core Services.

Routine Capital (Section 12.4)(a)

VHS of Michigan is expected to make routine capital expenditures in an average amount of at least \$70 million per year, but not less than \$50 million in the first year. The routine capital budget for the two year period ending December 31, 2012 was \$120.0 million. For the calendar year 2012, \$70 million of routine capital expenditures were budgeted. Certain portions of that amount were dedicated to specific capital projects and other amounts were made available for discretionary capital needs. During the period January 1 through December 31, 2012, \$63.3 million of routine capital expenditures was spent (Exhibit A). This was \$18.4 million higher than in 2011 but lower than the \$120.0 million budgeted for the first two years. Capital spending averaged \$5.3 million per month compared to the of 2011 average of \$3.7 million per month. The actual rate of routine capital spending increased with more than \$17 million dollars spent in the first quarter of calendar year 2012 and \$46 million spent in the remaining three quarters of 2012. The Routine Capital 2012 Expenditures chart is presented in Exhibit A listing all of the routine capital project spending for 2011 and 2012.

Please understand, certain projects required a greater amount of planning and lead time then initially predicted. Delaying launch on IT and construction projects specifically, ensured project scope was thorough and complete. This included projects such as the \$3.5 million Central Lab Master Plan which has been expanded. As a result, spend was slower than originally projected and deferred by approximately 3 months.

Other projects directly impacting the 2012 spend rate are specialty clinics. To ensure Vanguard/DMC is strategically and correctly positioning itself in the market the location of planned specialty clinics have been modified resulting in deferred project start dates. Vanguard/DMC provides calendar quarter reports to Legacy DMC reporting both committed and actual spend on routine capital. Each report also includes projections indicating the anticipated spend over the next calendar quarter. Spending is based on receipt of equipment and/or invoice from vendor or supplier, which directly impacts the period in which the spending is recorded.

Requests change throughout the year due to changing hospital needs or unexpected equipment replacement which directly impacts the timing of routine capital spend. Vanguard/DMC is working with the hospitals to better define and refine its capital requirements starting with the next budget year which begins July 1, 2013. Management has communicated the need to have all FY 2013 capital budget requests processed no later than April 1, 2013 to capture as much spend as possible by June 30, 2013. Capital budget planning kick off will be before the second quarter and has produced a more refined process for FY 2014 Capital Budget.

Specified Capital Projects (Section 12.4)(b)

Project timelines have been developed and fine tuned to avoid disruption to daily operations and on-going patient care at each facility. The overall central campus projects were reviewed to successively roll out the projects with minimal inconvenience to

patients and visitors. As a result, modifications from the original scope, cost and schedule presented in as Exhibit B - Schedule 12.4 Original to Current Scope, Cost and Schedule Comparison.

Vanguard/DMC provides calendar quarter updates to Legacy DMC reporting actual spend and known changes to scope and project time lines. A brief summary on the status of each Specified Capital Project follows. Also, attached Exhibit C summarizes the full-year spend for CY 2012 expenditures on each Specified Capital Projects.

Sinai-Grace ED/ICU/FAÇADE/Radiology:

The scope and schedule of these various projects have not changed since the last report and the completion date is scheduled for July 2015.

RIM 6th Floor Renovation:

This project was finished in October 2012 and is complete.

HVSH Private Room Renovations:

This project is complete. Renovated rooms were made available to patients in October 2011. This project met the original time line and came in under budget by approximately \$700,000. Savings were realized primarily from lower construction and equipment costs.

HVSH Additional ICU Beds:

Huron Valley Sinai Hospital is undergoing a Master Plan review for its facility. As a result, the ICU Beds project has been put on hold pending the outcome of the review.

Detroit Receiving Patient Care Unit Renovations:

Scope and schedule have not changed from the last update. The Observation Unit and ICU pod renovations are complete. Work is currently underway on the first two inpatient pods.

Detroit Receiving Additional OR with Pre & Post Op:

This project broke ground on February 16, 2012. No changes to scope, schedule or project time line has been made since the last update.

Children's Hospital of Michigan Pediatric Specialty Center:

Project construction is complete and opened in June 2012. The scope of the project was modified. The structure has one more additional floor and is constructed to allow for an additional floor of vertical expansion not originally included in the original project

specifications. These modifications added cost of approximately \$9.7 million dollars to the overall project.

Children's Hospital of Michigan Tower & Carl's Backfill Project:

Master planning continues for the Tower project. Completion of this project has been pushed to August of 2017 to allow sufficient time for planning. Work on the Carl's Building Project is continuing. The 5th floor renovations are complete. 4th floor renovations are underway. Planning for the third and second floor renovations continues.

HUH Surgical Services Renovation

Scope and schedule have not changed since the last update. The completion date is projected for October 2013.

HUH Unified Lobby

There has not been any change to the scope or schedule of the Unified Lobby. The time completion date is projected for October 2014.

HUH Ground Floor Master Plan

There has not been any change to the scope and schedule of the Ground Floor Master Plan project since the last update. The construction completion date remains September 2015.

Cardiovascular (CVI) & Outpatient Services Bldg (a/k/a Heart Hospital)

Construction of the New DMC Heart Hospital, which will house the Cardiovascular Institute, broke ground on January 17, 2012. Construction has been in full force during 2012 and will continue in 2013 with the completion date scheduled for August 2014. The scope and schedule have not changed since the last update.

HUH Harper Unit Renovations

Harper Unit Renovations are complete. 10WS units were completed in February 2012, with the 9WS units completed in October 2012.

HUH ED Expansion

Scope and schedule have not changed since the last update. The construction completion date is March 2013.

Corporate Relocation of Mack Parking Deck

Completion date for this project has been changed from December 2013 to March of 2014 due to complications with the demolition of the International Guest Housing building.

Specified Projects CapEx Shortfall

On February 13, 2013 Vanguard Health Systems wire transferred \$27,816,415 to the BNY Mellon, in its capacity as Escrow Agent. These funds represent the Capital Expenditures Shortfall for the second year Anniversary Date.

Capital Expenditures Shortfall was determined in accordance with generally accepted accounting procedures:

None of the funds deposited relate to the Children's Hospital tower project.

Ernst and Young LLP has been engaged by Vanguard Health Systems, Inc. to perform an independent review as required under Section 12.17. The review is limited to the agreed upon procedures set forth in Schedule 12.17 and Buyer's compliance with Section 12.4. This review is anticipated to be completed no later than February 28, 2013.

Warrant (Section 12.5)

At Closing, Vanguard delivered to the Escrow Agent an initial Warrant Certificate for the Warrant. In connection with Vanguard's initial public offering of its common stock in June 2011, Vanguard delivered to the Escrow Agent (in exchange for the Warrant Certificate then in the possession of the Escrow Agent) the Note in the original principal amount of \$500,000,000. In accordance with Section 12.5 of the Purchase and Sale Agreement, the principal amount of the Note is automatically reduced on a continuous basis by the amount of any reduction in the Remaining Capital Expenditures Commitment.

No Sale of Hospitals (Section 12.7)

VHS did not sell, transfer directly or indirectly assets which constitute one or more of the Hospitals or any equity interest in any Subsidiary of VHS to any person during 2012.

Commitment to Education Mission (Section 12.8)

VHS of Michigan, Inc is honored and proud to continue the DMC's education and research mission with a strong partner like Wayne State University as we share the enthusiasm of the community as we see results beginning to emerge from our commitment in new facilities technology, patient care and safety. Vanguard/ DMC continued to train medical and osteopathic residents in 2012 (1,023 FTEs) and continue to maintain our prior commitment to train students of medicine, osteopathy and allied health at the same level as prior years. In addition to medical education Vanguard/DMC continues its support of nursing education. Placements come from over 35 nursing training programs within Southeast Michigan.

Commitment to Research Mission (Section 12.9)

Vanguard/DMC continues to work closely with Wayne State University (WSU) in connection with ongoing groundbreaking research taking place at the Perinatal Research Branch located in Hutzel Women's Hospital. The importance of this research is highlighted by the following excerpt, released in April 2011:

"For years, Detroit has been known to have a high rate of premature birth and infant mortality. To address these important problems, Dr. Roberto Romero and Dr. Sonia Hassan, along with a team of brilliant researchers, conducted a groundbreaking study as part of the Perinatology Research Branch of the National Institute of Child Health and Human Development of the National Institutes of Health on the campus of the Detroit Medical Center at DMC Hutzel Women's Hospital and Wayne State University.

"On Wednesday, April 6, 2011, the world learned the results of a groundbreaking clinical study of a new method for preventing premature birth in millions of women each year. Published in the authoritative *Ultrasound in obstetrics & Gynecology*, the study shows that the rate of early preterm delivery in women (<33 weeks) can be reduced by 45 percent – simply by treating pregnant women at risk for preterm delivery with a low-cost natural progesterone gel" during the mid-trimester of pregnancy until term. This breakthrough will become a care protocol for all applicable DMC patients." *See* the website for the Perinatal Research Branch.

We continue to actively conduct, and work cooperatively with WSU in its conduct of, research activities at Vanguard/DMC facilities. In total there are more than 900 active and ongoing clinical research projects.

Karmanos Cancer Center (Section 12.10)

Vanguard/DMC continues its relationship with Karmanos Cancer Center which has not materially changed since closing of the deal.

Health and Wellness Initiatives (Section 12.11)

Vanguard/DMC continues its support and commitment to the community. Initiatives and accomplishments during 2012 include the transfer of ownership of a building located near the DMC Central Campus to the Detroit Community Health Connection (DCHC).

New initiatives for DMC during 2012 included partnering with the Detroit Coalition Against Diabetes (DCAD) aimed at combating and increasing awareness about diabetes, setting up a Northwest Detroit Farmers'Market to improve health and life expectancy, provided a 2012 Summer Employment Program's "Mobility Assist Team" in which filled 20 summer spots for young teens to get hands on experiences in the medical field by assisting nursing units with turning, lifting, and transferring patient to their beds, stretchers, and chairs. 400 families were fed through the Kem- Feed the Homeless Food Drive and we continued coordinating in dressing dolls for the Goodfellows Doll Giveaway. We provided more than 300 dolls for distribution to underprivileged children in Detroit. In addition to the Corporate Community Affairs, each hospital provides its own programs and events. Attached as Exhibit F is a description of hospitals "Community Affairs/Outreach Annual Report."

Supplier Diversity Program (Section 12.12)

Vanguard/DMC continues to support "Seller's Supplier Diversity Program"; there were no amendments or changes made to the Supplier Diversity Program Policy since closing. Overall diversity spending for FY 2012 was \$51.4 million dollars as compared to FY 2011 spending of \$40.6 million dollars.

Project Genesis (Section 12.13)

During the summer of 2012 Vanguard/DMC completed its 7th year sponsoring Project Genesis. We employed 100 students from the Detroit area high schools and colleges placing students in various departments through out the DMC, both healthcare and non-healthcare fields. Each student worked 30 hours per week for 8 consecutive weeks. The 2012 program has started with the distribution of applications to high school counselors. Typically more then 500 students apply for the 100 available positions. Project Genesis was created by the Vanguard/DMC in order to give students exposure to hospitals and careers in healthcare.

Detroit Based Systems (Section 12.14)

Vanguard/DMC continues to operate its hospitals as a Detroit-based system with its regional headquarters located in the City of Detroit, Michigan.

National Support Centers (Section 12.15)

Vanguard established a "Vanguard Information Technology Operations and Data Center" (National Support Center) in Troy, Michigan during 2012. Since the Vanguard Hospital System is spread over a wide geographic area, there has been an information technology need to transmit data between its many locations. The solution was to divide the Company into two Vanguard regions, Detroit, (Troy, Michigan) as the primary data center and San Antonio, Texas as the secondary data center. These two data centers will support all Vanguard regions as part of their national effort to improve technology infrastructure.

Naming Conventions (Section 12.16)

Vanguard/DMC continues to honor all naming conventions as designated in donor agreements.

The purpose of the retreat is to allow campers and their families a chance to relax and enjoy camp activities, share similar experiences, learn adaptations for recreational activities and find support among each other. Camp participants enjoyed crafts, boating, painting, swimming, dancing, talent shows and much more.

More importantly the camp gives them confidence to try a new activity or relearn an activity they thought they wouldn't be able to do again after their disability.

RIM Talks to Students about Brain Injury Awareness

March is National Brain Injury Awareness Month. On March 22nd DMC Rehabilitation Institute of Michigan's Inpatient Neuroscience Team co-sponsored a Brain Injury Awareness event with Wayne County Community College to educate high school students looking forward to Spring Break and Prom about the risks and prevention of brain injuries.

More than 100 students from Romulus and Belleville high schools participated. Students learned about brain injuries and then participated in hands-on activities that simulated how drunkenness or drug use causes impaired judgment and can lead to a potential brain injury. Students also got to hear from a former RIM patient who was drinking and driving, how his brain injury permanently changed his life.

Mentoring in Medicine Mentoring in Medicine, Inc. is a national organization that inspires and equips low-income students and underrepresented minorities with the experiences and resources to become healthcare professionals. In partnership with the Mentoring in Medicine, Sinai-Grace Hospital hosted the National Mentoring in Medicine Day on April 21. During the event, 150 middle school, high school and college students were given the opportunity to listen to guest speakers discussing healthcare careers and network with health care professionals in a fun and relaxed environment.

2012 Summer Employment Program's "Mobility Assist Team" The 2012 eight-week Summer Employment Program at Sinai-Grace Hospital was highly competitive; just 20 summer spots were available for 200 potential candidates to get hands-on experiences in the medical field. Two of the summer spots were given to Cory Newman and Darcy Dunham who were a part of the Mobility Assist Team under the guidance of nurses Meghan Smith and Joan Van Heck. Decked out with their Mobility Assist shirts and pagers, they assisted nursing units with turning, lifting, and transferring patients to their beds, stretchers, and chairs. In the end, they helped complete over 200 assists during their internship!

Northwest Detroit Farmers' Market
To improve health and life expectancy, Sinai-Grace embarked on a mission to make access to healthy foods easier in our northwest community. The Sinai-Grace Community Affairs group, along with the Health and Wellness Foundation of Greater Detroit, partnered with Grandmont Rosedale Development Corporation to create awareness and introduce more people to the local farmer's market. With funding from Sinai-Grace and Health and Wellness, the market employed a free shuttle service to pick senior citizens up from five local senior housing complexes and give them rides to the farmers' market. In addition, Sinai-Grace provided once-a-month cooking demonstrations by DMC's Chef Antonio and free health screenings.

Beam Topping Ceremony The final steel beam was raised at DMC Sinai-Grace Hospital to mark the completion of the structure for the \$77 million Emergency Room/ICU during a "beam topping ceremony" on November 2. With inscriptions and signatures from hospital staff, the beam will serve as a time capsule for many years to come. In addition, a live erected evergreen was erected, a construction industry tradition, which will eventually be planted on the Sinai-Grace campus. Many members of the community attended the event.

Say No to Soda Pop Initiative Adults who drink one or more sodas or other sugar-sweetened beverages each day are 27 percent more likely to be overweight or obese. Therefore, DMC Sinai-Grace Hospital President and CEO Reginald Eadie, M.D. launched a month-long campaign in November to say no to soda pop. Sinai-Grace Hospital hosted a campaign kick-off pep rally on October 31 in the hospital auditorium that included a health conversation with Dr. Eadie and inspiring testimony from Detroit City Council President Charles Pugh; state Rep. Thomas Stallworth II; Director of Wayne County Health-Human Service Edith Killins; Wayne County Commissioner Irma Clark-Coleman; Detroit City Councilman André Spivey, Dr. Benjamin Carson High School of Science & Medicine, and Cornerstone Health High School.

Some of the other partners included Detroit Public Schools, Whole Foods Market, DMC Detroit Receiving Hospital, and The Water Station.

Sinai-Grace Hospital/United Way Early Literacy Initiative DMC Sinai-Grace Hospital has partnered with the United Way for Southeastern Michigan to launch an Early Literacy Initiative. The effort will provide new families with the keys to their child's educational success, starting at birth. The 3 East staff at Sinai-Grace Hospital will be the pilot site for trained volunteers to introduce new mothers to helpful resources in a box. Signing up for the Early Literacy Initiative includes Imagination Library, promotes websites/smartphone app and follow-up to family literacy programming, and a free book for each participating child every month until the age of 5. This approach provides families with tools to help their child reach their full potential.

Pathway to Excellence Mentoring Program Provided 30 young men employment opportunities at Sinai-Grace as part of a partnership with lota Boulé and the Detroit Parent Network. The program's mission is to promote the development of successful African American young men by empowering them with the skills and knowledge needed to foster academic success; establish a support network; support the goal of graduation; and improve personal achievement by influencing leadership through representing unity and a commitment to collective betterment of the community.

<u>Christmas</u> Sinai-Grace distributed food baskets and giftcards to patients and members of the Community who were in need of a meal for Christmas.
