Under Section 313 of PA 22 of 2025, this Department is directed to submit a quarterly report regarding the lawsuit settlement proceeds fund. The specific language states:

The attorney general's office shall submit a quarterly on the lawsuit settlement proceeds fund that includes all of the following:

- (a) The total revenue deposited into the lawsuit settlement proceeds fund in the current fiscal year delineated by case.
- (b) The total amount appropriated from the lawsuit settlement proceeds fund in the current fiscal year delineated by appropriation.
