MICHIGAN CRIME VICTIM'S RIGHTS ACT

In Michigan, a victim is an individual who suffers direct or threatened physical, financial, or emotional harm as a result of the commission of a crime.

The [Michigan Constitution](#) and the [Crime Victim Rights Act](#) (MCL 780.751) grants you certain rights:

- To be treated with fairness and respect of your dignity and privacy throughout the criminal justice process.
- To be reasonably protected from the accused throughout the criminal justice process.
- To a timely disposition of the case following the arrest of the accused.
- To notification of court proceedings.
- To attend trial and all other court proceedings the accused has the right to attend.
- To confer with the prosecution.
- To make a statement to the court at sentencing.
- To restitution.
- To information about the conviction, sentence, imprisonment, and release of the accused.



HOW WE CAN HELP

Victim Advocates provide comprehensive services to assist victims through the criminal justice system.

Victim Advocates are here to:

- Provide court notification
- Provide crisis intervention
- Provide community referrals
- Assist with filing Crime Victim Compensation
- Accompany victims to court
- Prepare for testimony
- Offer restitution information and assistance
- Coordinate travel arrangements
