#### AFFIDAVIT OF LATISHA

Latisha , being first duly sworn, deposes and says as follows:

- 1. Hive in Man, Michigan.
- 2. I am writing this affidavit because Sierra Lending does not tell people the truth. My experience with Sierra Lending was that they provided incomplete and inaccurate information that was totally different over the phone than when it was typed up and emailed to me. They take money out of paychecks every few weeks and take out a huge amount of interest that they didn't tell me about. They tell you one thing over the phone, tell you not to read the contract, and then the contract is not the same as what they tell you.
- 3. I first contacted Sierra Lending in late December 2018. I had been getting a lot of emails telling me I was approved for a minimum of \$500 and a maximum of up to \$5,000. During a rough week when I needed some help paying my bills, I decided to look at what they were offering.
- 4. I went on their website and started the sign-up process. Then they called me to do the preapproval. Once they start calling you, they do not stop calling you. Even if you say you're thinking about it, they will call you all day every day until they get you to say yes. They told me I was approved for \$500 and I wound up accepting the \$500.
- 5. I believe two days later they put the money in my account. I received \$500 on December 31, 2018, per the bank statement provided as **Attachment 1**.
- 6. On January 18, 2019, Sierra Lending automatically took a payment of \$82.50 from my bank account. (Attachment 1, p 2.)

- 7. The next payment was due two weeks later. On February 1, 2019, Sierra Lending automatically pulled \$165 out of my bank account. (Attachment 1, p 2.)
- 8. I wondered why my second payment was so much more than my first payment, so I called Sierra Lending to find out. They told me they were adding a finance fee and some other fee. I asked them to break it down for me and when they told me where the money was going. I told them that's not what they told me over the phone. They said that it was and when I looked at my contract I saw a ridiculous payment schedule. A small amount of my payment maybe went toward my loan and the rest goes toward other things and they don't tell you that.
- 9. Another \$165 payment was automatically pulled out of my bank account on February 15, 2019. (Attachment 1, p 2.) Another \$165 was automatically taken from my bank account on March 1, 2019. (Attachment 1, p 3.)
- 10. I tried to pay off my balance early and they said I had to wait until the following week. But each week you don't pay the amount due goes up tremendously. So, if you owe \$500 one week, it could be like \$800 the next week. I wasn't able to pay off the amount due at that point, so I had to wait a few weeks to pay off my loan early.
- 11. I took out a \$500 loan and by the time I was done I would have given them \$2,500 if I had not paid it off early. Even though I paid it off early, I still paid approximately \$1,200-1,300 for a \$500 loan.
- 12. Now my loan is paid off and I am done with them. But they keep calling me asking me to get another loan. I've told them numerous times that I'm not interested, and I don't want to deal with them, but I keep getting calls and texts. I've

blocked some of these numbers and still keep getting calls and texts from new numbers trying to get me to take out a new loan.

- 13. After I figured out how they were ripping people off I decided to file a complaint with the Better Business Bureau.
- 14. I have personal knowledge of the facts stated in this affidavit and will testify about them if called upon to do so.
