**IT IS ORDERED** that upon request of the Petitioner, the hearing regarding Patricia E. Kefalas-Dudek, and Father Charles Blanchards' Petition to allow the first and final account shall be adjourned until Wednesday, December 14, 2022, at 2:00 PM.

**IT IS ORDERED** that Former Co-Conservator, Patricia E. Kefalas Duduk shall provide a detailed accounting and supporting documentation regarding her claim that she used \$16,000.00 of her own funds to pay bills owed by the Estate of Anthony Armor, and she shall provide a copy of said detailed accounting and supporting documentation to all interested parties at least one week prior to the December 14<sup>th</sup>, 2022, court date.

**IT IS FURTHER ORDERED** that that Former Co-Conservator, Patricia E. Kefalas Duduk shall immediately return the sum of twenty-one thousand (\$21,000.00) dollars to the successor Conservator, Elizabeth Misuraca pending full resolution of this matter.
