ORDER

At a session of this Court held in the

Petitioner, Patricia Dudek having filed a petition to allow an amended first and final account, Roger E. West having filed objections on behalf of Anthony A. Armor, Attorney Katharyn A. Barron having filed a Notice of Intervention and objections to Former Co-Conservators, Patricia E. Kefalas Dudek and Father Charles Blanchards' Amended Final Account, the court haven taken testimony from all parties, the court being otherwise fully advised in the premises, and having rendered a final decision in the matter:

IT IS ORDERED that the former Co-Conservator Patricia E. Kefalas-Dudek, and Father Charles Blanchards' Petition to allow the Amended first and final account is hereby allowed subject to the following conditions for the reasons set forth on the record of this court.

IT IS ORDERED that that Former Co-Conservator, Patricia E. Kefalas Dudek shall return the additional sum of eight thousand, seven-hundred eighty-seven (\$8,787.12) dollars and twelve cents to the successor Conservator, Elizabeth Misuraca within fourteen days of this court's order, and that former Co-Conservator Patricia E. Kefalas-Dudek shall notify the court immediately if she is unable to make said payment in a timely manner.

IT IS ORDERED that former Co-Conservator, Patricia E. Kefalas-Dudek Shall fully cooperate with counsel for Anthony Armor, and the successor Conservator, Elizabeth Misuraca, by providing , within fourteen days of this court's order, written documentation of all of Anthony Armors known outstanding debts and obligations as of June 16, 2022.

IT IS ORDERED that Former Co-Conservator Patricia E. Kefalas-Dudek Shall fully cooperate with counsel for Anthony Armor, and the successor Conservator, Elizabeth Misuraca, by providing information as well as any written documentation regarding any outstanding rental obligation owed to the Ferndale Apartments by Anthony Armor within fourteen days of this court's order.


