The complaining witness says that on the date above and on Gratiot Ave. near the I-94 entrance ramp, the defendant, contrary to law:

## COUNT 1: COMMON LAW OFFENSES

FELONY: 5 Years and/or \$10,000.00

## COUNT 2: ASSAULT WITH A DANGEROUS WEAPON (FELONIOUS ASSAULT)

did make an assault upon [REDACTED] with a dangerous weapon, to-wit: K-9 police dog, but without intending to commit the crime of murder or to inflict great bodily harm less than the crime of murder; contrary to MCL 750.82. [750.82].

FELONY: 4 Years and/or \$2,000.00; DNA to be taken upon arrest. A consecutive sentence may be imposed under MCL 750.506a if the assault was committed in a place of confinement.

Court shall order law enforcement to collect a DNA identification profiling sample before sentencing or disposition, if not taken at arrest.
