REVENUE OVERVIEW

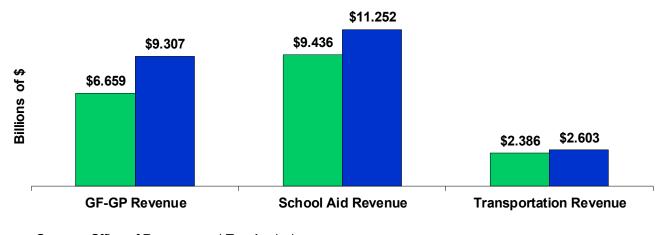

This Monthly Financial Report to the Legislature presents the Michigan State government's economic situation and cash collections for June 2021, representing some May and some June economic activity in Michigan.

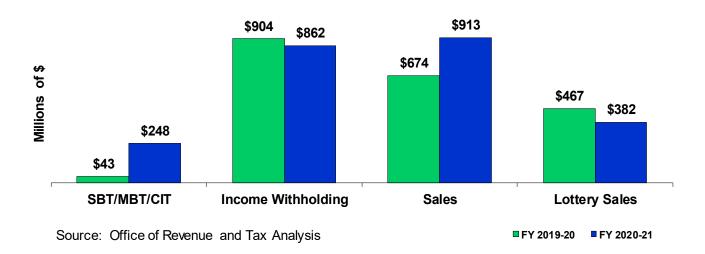
Due to the effects of the pandemic on revenues a year ago, growth rates are significantly different than usually observed. Total General Fund - General Purpose cash collections were \$376.5 million (37.9 percent) higher in June 2021 than in June 2020. The June 2021 School Aid Fund cash collections were \$243.1 million (24.8 percent) higher than in June 2020. June 2021 transportation collections were \$39.5 million (15.3 percent) higher than in June 2020 (see revenue summary table). June is the ninth month of the state's fiscal year (FY). Year-to-date collection totals generally provide a more accurate view of collections since they are less affected by the timing of payments. Year-to-date General Fund - General Purpose cash collections are up \$2,648.8 million (39.8 percent) from a year ago. School Aid Fund cash collections are up \$1,816.0 million (19.2 percent) and transportation collections are up \$216.6 million (9.1 percent).

The FY 2020-21 revenue projections presented in the revenue summary table on page 11 are from the Consensus Revenue Estimating Conference held on May 21, 2021. The revenue estimate for net General Fund – General Purpose revenue for FY 2020-21 is \$11,276.8 million and the net School Aid revenue forecast is \$15,032.4 million. The Transportation Funds revenue forecast is \$3,684.5 million. By law, the Consensus Revenue Estimating Conferences are held the second week of January and the third week of May.

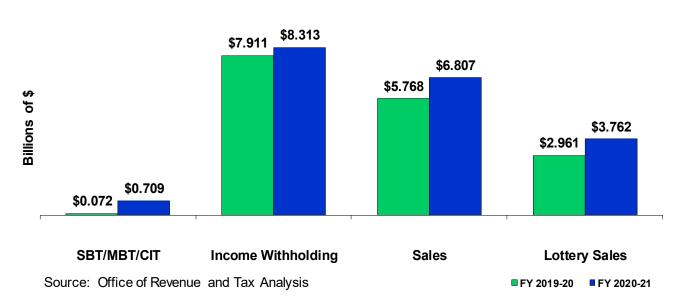
October through June Collections FY 2019-20 and FY 2020-21

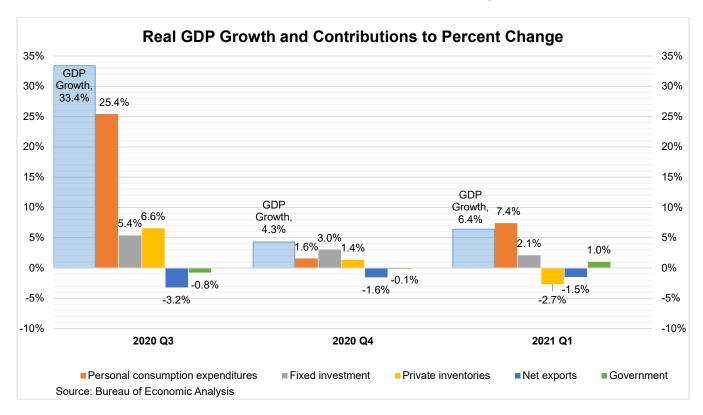

Economic Highlights (All data seasonally adjusted unless otherwise noted.) U.S. Economy

U.S. real *Gross Domestic Product* increased at a 6.4 percent annual rate in the first quarter of 2021, according to the most recent estimate, up from the 4.3 percent annual rate in the fourth quarter of 2020. The coronavirus (COVID-19) pandemic that hit the U.S. in 2020 drove the significant swings in GDP. The 2020 quarterly contributions to the percent change in GDP are shown in the graph below. Annual real GDP decreased 3.5 percent in 2020, a decline from the 2.2 percent growth of 2019.

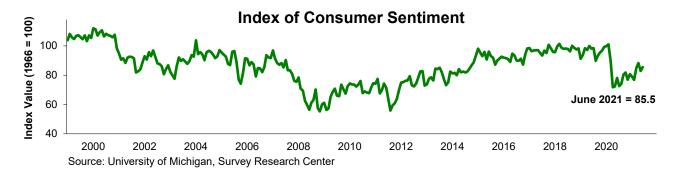


Personal consumption expenditures contributed significantly to the increase in GDP in the first quarter of 2021, along with fixed investment and government spending. Private inventories and net exports were both drags on the economy. Real final sales increased 9.2 percent in the first quarter according to the most recent estimate while on the inflation front, the implicit price deflator increased by 4.3 percent.

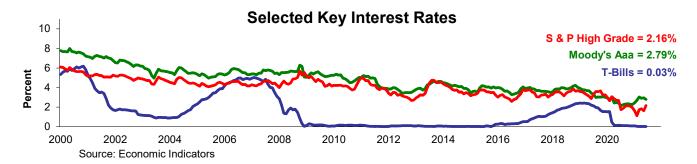
U.S. wage and salary employment increased by 850,000 jobs in June. Employment levels were still 6.8 million payroll jobs, or 4.4 percent, below the February 2020 level, prior to the pandemic. In June, sectors with the largest increases in employment include leisure and hospitality with 343,000 jobs, government employment with 188,000 jobs of which 155,200 were in the local government education sector, trade, transportation, and utilities with 99,000 jobs of which 67,100 were in retail trade, professional and business services with 72,000 jobs, education and health services with 59,000 jobs, and other services with 56,000 jobs.

In June, the U.S. unemployment rate increased slightly to 5.9 percent, up from May's 5.8 percent. Civilian employment remained flat, totaling 151.6 million in June, while the number unemployed increased slightly to 9.5 million. Of the unemployed, 1.8 million were reported as being on a temporary layoff in June, the same as May.

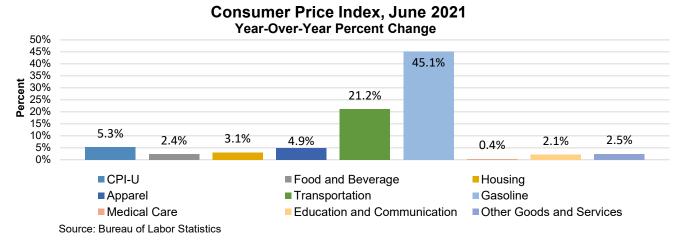
The *Index of Consumer Sentiment* increased 2.6 index-points from May, up to 85.5 in June. The year-over-year consumer sentiment is 7.4 index-points above June 2020 levels, which had plummeted from February 2020's high of 101.0 due to the pandemic.



Short-term *interest rates* increased slightly in June, as the 3-month Treasury bill (T-bill) rate increased to 0.03 percent, up 0.01 percentage points from May. Compared to one year ago, towards the start of the pandemic, the T-bill rate decreased 0.13 percentage points. The Aaa corporate bond rate decreased 0.17 percentage points to an interest yield of 2.79 percent in June but was up 0.38 percentage points from its year-ago level. The interest rate on high-grade municipal bonds increased 0.53 percentage points to 2.16 percent in June and was down 0.53 percentage points from a year ago.

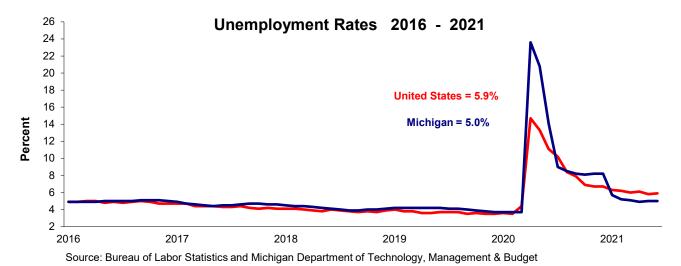


U.S. retail prices, as measured by the Consumer Price Index (CPI-U), are up 5.3 percent from June 2020 to June 2021. Gasoline experienced the largest year-over-year price increase (45.1 percent) due to the dramatic decline in gasoline prices at the start of the pandemic. Transportation was next in largest price increase (21.2 percent). Far lower year-over-year percent changes can be seen in apparel (4.9 percent), housing (3.1 percent), other goods and services (2.5 percent), food and beverage (2.4 percent), recreation (2.4 percent), and education and communication (2.1 percent).



Michigan Economy

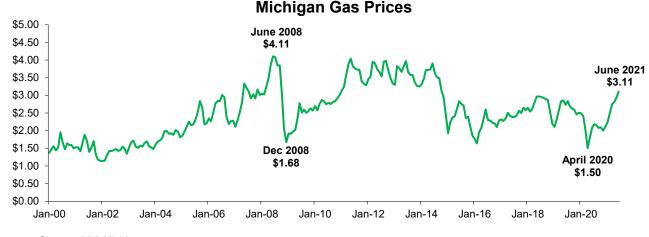
The *Michigan jobless rate* remained at 5.0 percent in June, the same as May's jobless rate. This is below the national unemployment rate which increased slightly to 5.9 percent. The civilian labor force increased by 9,000 in June, a 0.2 percent change from May. The number unemployed remained the same as May, while the number employed increased by 9,000, a 0.2 percent change from May to June. The number unemployed is 66.2 percent lower than in June 2020, when the pandemic was still in its early months in the U.S.



Michigan wage and salary employment increased in June by 14,000 jobs from May's revised estimate, and was up 273,000 jobs, or 7.1 percent, from June 2020. June is similar to May with most sectors having relatively flat employment changes. The sectors with the largest increases include government with 5,000 jobs gained, trade, transportation, and utilities with 3,000 jobs gained, and

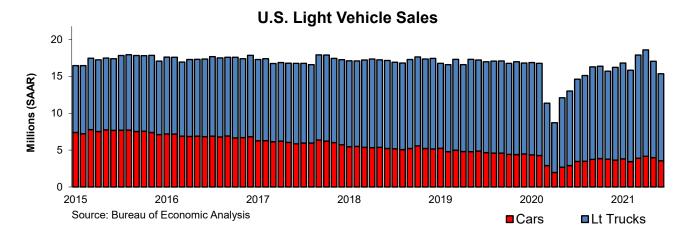
government with 5,000 jobs gained, trade, transportation, and utilities with 3,000 jobs gained, and leisure and hospitality services with 3,000 jobs gained. This is a reversal of May when trade, transportation, and utilities as well as leisure and hospitality services both lost jobs. In June, all other sectors gained or lost less than 2,000 jobs.

Michigan gasoline prices increased in June 2021 to \$3.11 per gallon, up 16.9 cents a gallon from last month's average. Year-over-year gasoline prices are up significantly from the \$2.09 per gallon in June 2020, when they declined sharply at the start of the pandemic. June 2021 gas prices are 37.3 cents a gallon higher than they were two years ago in June 2019.

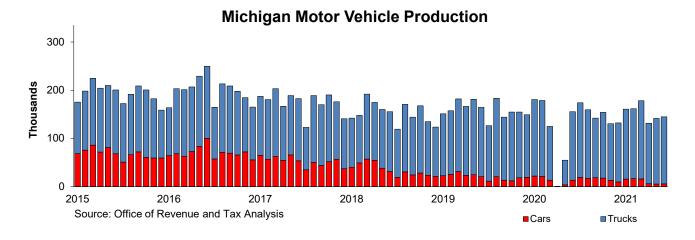


Motor Vehicle Sector

U.S. light vehicle sales (cars and light trucks) declined 9.8 percent in June from May, selling at a 15.4 million unit seasonally adjusted annual rate. Domestic car sales declined 11.2 percent and light truck sales declined 8.0 percent from May. Import car sales and light truck sales declined 9.2 percent and 14.5 percent, respectively, from May. Compared to June 2020, light vehicle sales were up 18.0 percent. Domestic car sales increased 22.1 percent while light truck sales increased 21.3 percent from the year ago levels. Import car sales were up 25.8 percent while import light truck sales were up 3.2 percent from last year. For June 2021, domestic light vehicles recorded a 75.1 percent share of a 17.0 million unit market, up 0.9 percent from May.



Michigan motor vehicle production was up in June, with 144,934 total units, 2.4 percent above May's production, but down 6.8 percent from a year ago. Nationally, motor vehicle production totaled 739,750 units, which was down slightly from a year ago. In June, Michigan's car production was 5,583 units while the state's truck production was 139,351 units. Michigan motor vehicle production data are not seasonally adjusted.
