Additional federal funds are available for the ARP farm to school grant. This increase is \$266,000 and will allow MDE to utilize 100% of the federal funding. This appropriation is being proposed as a work project and would allow the department to spend these one-time grant dollars over 4 years.

Child care caseload costs at the May 2023 Consensus Revenue Estimating Conference, CREC, were expected to be funded roughly 50% with COVID-19 stimulus dollars and 50% with regular CCDBG funding. However, as year end draws close there is not enough COVID-19 stimulus revenue available for the full amount of costs projected at the May 2023 CREC. Therefore a supplemental is needed in the child care caseload line to utilize regular CCDBG revenue to fill this gap. Also, caseloads have increased slightly since the May 2023 CREC.

Explanation

This supplemental seeks \$814,000 in federal authorization to support Great Lakes Remedial Action Plan Grants. Funding is made available through the Infrastructure Investment and Jobs Act. These grants will be used primarily for assessment of emerging contaminants, such as PFAS, to characterize existing conditions and potential source areas.

This supplemental request seeks \$210,000 in federal authorization to expand the Dam Safety and Coastal Management Programs. Funding is made available through the Infrastructure Investment and Jobs Act. Funding will be used to increase oversight of high hazard dams and increase outreach to dam owners, and to improve and increase habitat restoration and conservation to improve the resiliency of Michigan's coastlines.

This supplemental request seeks \$1 million in federal authorization for the Great Lakes Restoration Initiative Program. Funding is made available through a federal grant. The funding will be used to support two green infrastructure projects that will address polluted stormwater runoff in the Ox Creek Watershed.

Sec. xxx. (1) From the funds appropriated in part 1 for critical child welfare infrastructure, the department of health and human services shall allocate \$15,000,000.00 to create a grant program for nonprofit organizations to provide affordable and attainable housing for youth who are currently in foster care or youth who have already aged out of foster care and to increase capacity to address the placement crisis.

- (2) To receive the funds appropriated under this section, a nonprofit organization must apply for the grant program in a form and manner prescribed by the department of health and human services.
- (3) From the funds appropriated in subsection (1), the department of health and human services shall allocate \$7,500,000.00 to a nonprofit organization located in a county with a population between 1,000,000 and 1,500,000 according to the most recent federal decennial census in a charter township with a population between 44,000 and 45,000 according to the most recent federal decennial census for an infrastructure project for the construction, purchase, or renovation of facilities, whichever is most economically feasible, to provide affordable and attainable housing for youth aged 16 to 18 years who are currently in foster care or youth who have already aged out of foster care. The funds shall also include programming to support youth in the identified population. Before the funds appropriated under this subsection are distributed to the qualifying nonprofit organization, the nonprofit organization must provide an implementation plan to the department of health and human services. The department of health and human services may approve or reject the implementation plan. The implementation plan must include all of the following:
- (a) An identification of not less than a 10% private investment for the infrastructure project.
- (b) How the infrastructure project would assist youth aged 16 to 18 years who are currently in foster care or youth who have already aged out of foster care with employment, educational opportunities, housing, community life, personal effectiveness, and personal well-being.
- (c) How the nonprofit organization plans to cover the ongoing operational costs and ongoing maintenance of the infrastructure project.
- (d) How the nonprofit organization will track and report to the department of health and human services the operational outcomes and performance metrics that would show whether the nonprofit organization's program model could be replicated to other facilities across the state.
- (4) By September 30, 2023, the department of health and human services shall provide a report to the house and senate appropriations subcommittees on health and human services, the house and senate fiscal agencies, the house and senate policy offices, and the state budget office on the number of grant applications awarded, the approved implementation plan under subsection (3), and any performance metrics reported by the nonprofit organizations that were awarded grants.

Explanation

This supplemental request includes \$39.9 million in one-time federal authorization to recognize new grants awarded by the Federal Centers for Disease Control and Prevention (CDC). Specifically:

- --\$14.7 million to continue efforts to strengthen public health infrastructure, workforce, and data systems. Specific activities from this grant include: COVID-19 Data modernization enhancements (\$8.1 million), Non-COVID Data modernization enhancements (\$1.0 million) and Laboratory Digital Exchange (\$5.7 million). This funding is in addition to the COVID-19 related grant (\$80.1 million) provided in P.A 119 of 2023, Article 6, Section 564.
- --\$3.6 million through the Bridge Access Program for vaccine confidence activities. Funds will be used to maintain broad access to COVID-19 vaccines and treatment for all individuals regardless of insurance status. This funding includes both COVID-19 (\$3.3 million) and Non COVID-19 (\$336,500) grant.
- --\$7.4 million to support the Advanced Molecular Detection (AMD) Program in the ERP epidemiology and lab capacity genomic sequencing line item. Funds will be used to train staff, and modernize/build capacity in state and local public health technologies. They will also be used to enhance laboratory capability to investigate infectious disease. This funding is in addition to the grant (\$6.4 million) provided in P.A 133 of 2021.
- --\$4.2 million to continue the implementation data modernization efforts. Funds will be used to implement and achieve data modernization goals, assuring faster and more complete data sharing across the public health data ecosystem. Primary activities will include, but are not limited to, core data modernization, implementation of electronic case reporting, and modernization of the National Vital Statistics System. This funding is in addition to the grant (\$3.3 million) provided in P.A 133 of 2021.
- --\$3.7 million to support the National Wastewater Surveillance System (NWSS). Funds will be used to coordinate efforts with local partners to select water sampling sites, facilitate laboratory testing, submit data to the NWSS cloud-based portal, improve information sharing between NWSS partners and accelerate the implementation and use of wastewater surveillance for public health action.
- --6.2 million for the Healthcare-associated Infection and Antimicrobial Resistance Program (HAI/AR). Funds will be used to support and enhance laboratory capacity to detect, confirm, and characterize antibiotics resistant (AR) pathogens and novel resistance infections. This will improve response to outbreaks and containment of AR threats in healthcare. This funding is in addition to the grant (\$9.9 million) provided in P.A 133 of 2021.

The supplemental also re-appropriates grant funding included in PA 0194 Sec. 303 for the purposes of allowing the designated funds to be used for increasing capacity at residential child caring institutions, as well as for programming to support youth at The New Foster Care in Oakland County, Michigan.

Additionally, this supplemental appropriates \$168,500 in additional Federal American Recovery Plan grant funds to supplement existing work project funds. The additional funding recognizes new federal revenue for Supportive Services, Congregate Meals, Home Delivered Meals, and Family Caregiver support services.

- (a) The purpose of the work project is to provide seed funding for a new semiconductor research alliance which will establish a global center for advancing automotive microelectronics and materials.

Explanation

This supplemental requests \$20 million general fund to provide seed funding for a new semiconductor research alliance known as MISTAR, the Michigan Semiconductor Talent and Automotive Research, which will establish a global center for advancing automotive microelectronics and materials. Founding members of the alliance include Imec, the University of Michigan, Washtenaw Community College, KLA, General Motors and the MEDC. The alliance will use this seed funding over four years (\$5 million per year) to commence hiring, research projects, operationalize, and planning for competitive solicitations to the US Department of Commerce's CHIPS for America grant program, specifically targeting funding tranches under yet to be released Notice of Funding Opportunities establishing the National Semiconductor Technology Center (NSTC) and general research and development investment. Though not yet finalized, MISTAR estimates that it will seek federal funding in the range of \$100 million to \$200 million from this program.

This supplemental request also recommends new boilerplate language to appropriate interest earnings on the Strategic Outreach and Attraction Reserve (SOAR) Fund. These interest earnings are appropriated to the SOAR fund and are required to be spent in accordance with statute, MCL 12.254, which states that SOAR funding can only be expended after approval of a legislative transfer to the Critical Industry Program or the Michigan Strategic Site Readiness Program.

This first supplemental request for Military Training Sites and Support Facilities provides additional General Fund support for the Michigan National Guard to cover military leave and firefighter's compensatory time that are no longer eligible for federal reimbursement under the state's cooperative agreement with the DOD-National Guard Bureau. A similar adjustment is provided in FY2024 (2023 PA 119).

The supplemental request for the Michigan Veterans' Facility Authority (MVFA) provides \$14.5 million in additional General Fund support for the facility and MVFA operations. It reflects continuing (baseline) costs and revenue impacts related of the transition of members to the new facilities in Grand Rapids and Chesterfield and lower than anticipated restricted revenue, for which a similar baseline adjustment was provided in the enacted FY2024 budget (2023 PA 119). Additionally, it reflects increased payroll costs for nursing staff and other critical needs positions under increased base pay rates approved by the Civil Service Commission, as well as increased contractual costs for nursing services (pay rates and usage), and costs associated with training new contracted personnel.
