

COVID-19 Community Levels OR COVID-19 Community Transmission Rates?

CDC's new COVID-19 Community Levels recommendations **do not apply in healthcare settings, such as hospitals and nursing homes**. Instead, healthcare settings should continue to use <u>Community Transmission Rates</u> and continue to follow CDC's infection prevention and control recommendations for healthcare settings.



Know Your COVID-19 Community Level

<u>COVID-19 Community Levels</u> are a new tool to help communities decide what prevention steps to take based on the latest data. Levels can be low, medium, or high and are determined by looking at hospital beds being used, hospital admissions, and the total number of new COVID-19 cases in an area. Take precautions to protect yourself and others from COVID-19 based on the COVID-19 Community Level in your area.







Long-Term Care COVID-19 Plan

The state's long-term care facilities have faced immense challenges since Michigan recorded its first COVID-19 cases in March 2020. To respond to those concerns and provide essential protections to both residents and staff in residential care facilities, the State of Michigan leveraged authority granted by Executive Order and the Michigan Public Health Code. By designated authority, the Michigan Department of Health and Human Services (MDHHS) has acted to prevent and control the spread of COVID-19 by implementing a variety of strategies in the areas of infection control, diagnostic testing, data collection and reporting, and emergency staffing response.

Staff Masking Communities Moderate-to-Low

While still safest to implement universal source control, when levels are at low to moderate and staff are up to date with all recommended COVID-19 vaccine doses, CDC does state the following:

 Can choose to not wear source control (e.g., masks) or social distance when in welldefined areas which are restricted from patient access (e.g. staff meeting rooms, kitchen)

Patient encounters are safest with source control (e.g., staff masking)

• If resident is not suspected of SARS-CoV-2 infection, follow standard precautions

CDC Interim Infection Prevention and Control Recommendations for Healthcare Personnel

Staff Masking Suspected or SARS-CoV-2 Positive

Standard plus transmission-based precautions will be followed utilizing personal protective equipment:

- Gown, N95 respirator, eye protection, and gloves
- Aerosol generating procedures such as CPR should have staff wearing gown, N95 respirator, eye protection and gloves for safety as well

CDC Interim Infection Prevention and Control Recommendations for Healthcare Personnel

Resident Masking Communities Moderate-to-Low

While still safest to implement universal source control, when levels are at low to moderate and residents are up to date with all recommended COVID-19 vaccine doses, the CDC states the following:

• Do not need to wear source control when in communal areas of the facility

Residents not up to date or who are at increased risk for severe disease

• Source control and physical distancing should be considered

12. Are there any suggestions for how to conduct visits that reduce the risk of COVID-19 transmission? For example, should facilities have different policies for visitors, who are up-todate with all recommended COVID-19 vaccine doses and those who are not up-to-date with all recommended COVID-19 vaccine doses?

A: While we strongly encourage everyone to *be up-to-date with all recommended COVID-19 vaccine doses,* the facility must permit visitation regardless of the visitor's vaccination status (if the visitor(s) *has not had a positive viral test,* does not report COVID-19 symptoms or meet the criteria for quarantine). There are ways facilities can and should take extra precautions, such as hosting the visit outdoors, if possible; creating dedicated visitation space indoors; permitting in-room visits when the resident's roommate is not present; and the resident and visitor should wear a well-fitting mask (preferably those with better protection, such as surgical masks or KN95), perform frequent hand-hygiene, and practice physical distancing. Some other recommendations include:

- Offering visitors surgical masks or KN95 masks.
- Restricting the visitor's movement in the facility to only the location of the visit.
- Not conducting visits in common areas (except those areas dedicated for visitation).
- Increasing air-flow and improving ventilation and air quality.
- Cleaning and sanitizing the visitation area after each visit.
- Providing reminders in common areas (e.g., signage) to maintain physical distancing, perform hand-hygiene, and wear well-fitting masks.



QSO 20-39-NH

Face coverings and physical distancing during visits

- Visitors should wear face coverings or masks and physically distance when around other residents or healthcare personnel, regardless of vaccination status.
- If the nursing home's county COVID-19 community level of transmission is substantial to high, all residents and visitors, regardless of vaccination status, should wear face coverings or masks and physically distance, at all times.
- In areas of low to moderate transmission, the safest practice is for residents and visitors to wear face coverings or masks and physically distance, particularly if either of them is at increased risk for <u>severe disease</u> or are *not up-to-date with all recommended COVID-19* vaccine doses.
- Residents, regardless of vaccination status, can choose not to wear face coverings or masks when other residents are not present and have close contact (including touch) with their visitor.
 - Residents (or their representative) and their visitors, who are not up-to-date with all recommended COVID-19 vaccine doses, should be advised of the risks of physical contact prior to the visit.



QSO 20-38-NH

Routine testing of staff, who are not up-to-date, should be based on the extent of the virus in the community. *Staff, who are up-to date,* do not have to be routinely tested. *For HCP who work in the facility infrequently, see the CDC's testing guidance.*

Level of COVID-19 Community	Minimum Testing Frequency of Staff who
Transmission	are not up-to-date ⁺
Low (blue)	Not recommended
Moderate (yellow)	Once a week*
Substantial (orange)	Twice a week*
High (red)	Twice a week*

*Staff who are up-to-date do not need to be routinely tested.

*This frequency presumes availability of Point of Care testing on-site at the nursing home or where off-site testing turnaround time is <48 hours.




