

Data Update

Overview

- 401 Part A- Skilled Nursing Facilities enrolled
 - Clinics began 12/28/20
 - All first dose clinics scheduled and completed except for one facility who indicated they wanted a later clinic date
- 4,067 Part B- "Other" facilities enrolled
 - Many facilities have opted out recently
- Includes AFC, HFA, HUD 202, and more
 - Clinics began 1/4/21
 - 2,547 1st dose clinics scheduled
 - 640 1st dose clinics completed

- Total Vaccinations Administered: 80,954 doses
 - 52,203 resident doses administered
 - 28,751 staff doses administered



Additional Pharmacy Partner



Managed Health Care Associates (MHA) Pharmacy

- MDHHS has recently added an additional pharmacy partner to the Federal Pharmacy Partnership for Longterm Care Program
- MHA is largest network of independent long-term care pharmacies in the country
- Independent pharmacies in Michigan MHA will be utilizing include: Pharmacy Care Advocates (PCA), Genoa, Guardian, and Hometown pharmacies



MHA Pharmacy cont.

- Goal is to complete 1st dose clinics for all facilities as soon as possible
- MHA has previous partnerships with many residential, assisted living, and other long-term care facilities
- Approximately 1,100 facilities will be transferred from Walgreens to MHA
- No LTC facility will have a clinic scheduled date later than their originally scheduled clinic if they are transferred to MHA



Pharmacy Communications

LTC facilities transferred from Walgreens to MHA:

- If they have been contacted by initially by Walgreens, they should expect communication from both Walgreens and MHA informing them that their facility has been transferred.
- If they were assigned to Walgreens but have not been contacted yet, they can only expect communication from MHA.

- Want to ensure that all facilities that were enrolled have the opportunity to participate in the program


