# Sugar and Spice

## Lakeland Correctional Facility gingerbread house is an annual holiday tradition

**F**or the last year, Cesar Valladolid has been dreaming of the villa he'd build from the ground up.

But this dream home would be made with sugar and flour, rather than bricks and mortar.

"We tried to up the ante this year," said Valladolid, a prisoner in Lakeland Correctional Facility's food technology program who designed this year's gingerbread house, which has become a holiday tradition at the facility.

For more than 20 years, Lakeland's food tech

program has been constructing grandiose gingerbread houses for visiting children and families to enjoy each holiday season.

The tradition started when a pastry chef and tutor in the program suggested assembling a traditional gingerbread house for the holidays, said program head chef and instructor Jimmy Hill.

The project was a hit and each year the gingerbread house became larger and more impressive as Hill and students worked to expand and improve upon the previous year.

This year's gingerbread house, which is estimated to be approximately 3-feet tall and 3-feet wide, took between 150 and 200 hours to construct, Hill said.

Its bricks are bite-size candy bars that will be plucked off the house by visiting children the day after Christmas. Its shingles are rows of frosted cereal and the windows and doors are thin sheets of nearly-transparent rock candy. Underneath all

of it are sturdy blocks of fragrant gingerbread.

It also included a sleigh and five rice crispy treat reindeer dipped in chocolate.

“Every year it gets bigger and bigger,” said Hill, who was named the career and technical instructor of the year for 2018 by the department’s Offender Success Administration. “The kids love it.”

Once complete, the massive, sugar-laden treat is moved to the facility’s visiting room where prisoners and their visiting families can take photos with it.

It takes about four people to move the structure that is estimated to weigh more than 100 pounds, Hill said.

To remove the temptation to sneak candy from the house before Christmas, Hill and prisoners in the program assembled small treat bags for visiting children to enjoy.

“I want everyone to enjoy the house, especially the kids,” Valladolid said. “When we take it up to the visiting room, everyone stands still. It really brings everyone together.”

Lakeland Correctional Facility Warden Noah Nagy said giving prisoners in the program an opportunity to construct and decorate the gingerbread house allows them to build on their culinary skills.

“It allows them to push their limits in regards to what they can accomplish,” Nagy said.

“It increases their skill set to allow offenders participating in the food tech program the opportunity to compete for a job in the community.”

The gingerbread house is also a

facility tradition, Nagy said. “It demonstrates a selfless act of giving back and providing joy to those fortunate enough to enjoy it,” he said.

Christopher Dorch, a prisoner in the program, said he was excited for the opportunity to use his creativity and work alongside others passionate about creating something others can enjoy.

“It brings out the best in you,” Dorch said as he shaped and decorated chocolate reindeer to adorn the house.

“This program gives you an opportunity to show what your skills are and you get the opportunity to expand your abilities.”

This is the second year Devonte Goens, a prisoner in the program, has worked on the gingerbread house and he considers it a rewarding project.

“It’s great knowing someone is going to enjoy it,” he said. Valladolid said he enjoys seeing his vision come to life in the form of an immense gingerbread house for visiting families.

“I had some good guys around me to help make that vision a reality,” Valladolid said.

# Michigan Department of Corrections leaders receive Professional Excellence Award for assistance with cold case

Michigan Department of Corrections Director Heidi Washington and Saginaw Correctional Facility Warden Tom Winn and Assistant Deputy Warden Todd Massick were recognized for the MDOC's work to help Michigan State Police investigators bring a close to a cold case. Michigan State Police Lt. Colonel W. Thomas Sands presented each with a Professional Excellence Award

for their involvement in assisting MSP as they worked to locate the remains of Venus Stewart, who disappeared eight years ago. Stewart's former husband, Doug Stewart, was sentenced to life in prison in 2011 for her disappearance and death and is currently incarcerated at Saginaw Correctional Facility.

Investigators had not been able to locate Venus Stewart's body and had been meeting with Doug Stewart over the last six years in hopes he would provide information on the location of her remains.

Stewart made requests in exchange for sharing information with investigators. Some of those requests included items the department was already planning to provide to prisoners in Saginaw Correctional Facility's veterans unit, where Stewart is housed.

In October, Stewart identified the location where he buried Venus Stewart. Investigators were then able to bring the case to a close and provide closure to Venus Stewart's family.

# A look back at 2018

Director Heidi Washington was selected by Gov.-elect Gretchen Whitmer to continue leading the Michigan Department of Corrections. Under her leadership, the department has reached many outstanding achievements and has experienced a significant decline in the prisoner population. During her tenure the department has also invested in staff, launched innovative programs like the Vocational Village, improved public safety and focused on Offender Success.



In early 2018, the MDOC announced the recidivism rate had dropped to 28.1 percent — a historic low for the state and one of the lowest recidivism rates in the nation. Recidivism in Michigan had hovered around 30 percent in recent years, and it reflects a sharp drop from 1998 when the rate was 45.7 percent. In 2017, the recidivism rate was 29.8 percent. The declining recidivism rate shows the MDOC's efforts to boost education and training for prisoners is working.

The MDOC entered into an innovative partnership with Wayne State University for the oversight of prisoner health care. The agreement gives the department access to the university's network of medical experts and cutting-edge technology backed by health care leaders. Through the partnership, the university is also providing the department with a chief medical officer, chief psychiatrist and an assistant chief medical officer.

The department continued to recognize and support its veterans and was a finalist for the Secretary of Defense Freedom Award. The Freedom Award is presented annually by the Department of Defense's Employer Support of the Guard and Reserve program. The department also has attained Silver-level status as a veteran-friendly employer.

The MDOC broke ground on its third Vocational Village site, and first for women, in November at Women's Huron Valley Correctional Facility. The site will have the capacity to train up to 180 prisoners in fields that will include computer coding, carpentry, cosmetology, 3D printing and graphic design. Construction is expected to be completed in 2019.



# Partnership with Consumers Energy helps MDOC save nearly \$900,000 through energy efficiency improvements

The Michigan Department of Corrections, in partnership with Consumers Energy, has saved \$862,055 by completing energy efficiency upgrades, part of the energy provider's commitment to helping all customers across Michigan lower their energy costs.

people, the planet and Michigan's prosperity," said Patti Poppe, president and CEO of Consumers Energy. "We are proud to stand with the Department of Corrections to fulfill their mission of affordably serving the state and its residents."

The rebate incentive is the result of energy efficiency improvements to various prison facilities around Michigan including Jackson, Ionia, Muskegon and Adrian. The Department of Corrections completed 23 projects to their facilities, estimated to reduce enough electricity to power 244 houses and heat 496 homes. The 23 projects are expected to save the State nearly \$900,000 each year.

"Our mission at the Department of Corrections is public safety and to help create a better and safer Michigan. And we have been pleased to partner with Consumers Energy which helps us to not only protect the public, but protect the environment and provide real savings to taxpayers," said Heidi Washington, Director of the Michigan Department of Corrections. "These substantial energy saving projects are just some of the ways we have been working to green our prisons and our state and we look forward to going even farther in the future." Consumers Energy has helped Michigan customers save over \$1.5 billion through energy efficiency programs since 2009. Earlier this year, the company announced its Clean Energy Plan. In the plan, Consumers Energy announced the company will reduce carbon emissions by over 90 percent and no longer use coal to generate electricity by 2040.



# A Passion for Service

## Employment Counselor of the Year focuses on helping others

**L**isa Reed has a passion for helping others. Her drive to make a difference is what led her to a job as an employment



counselor at Saginaw Correctional Facility. “If I can make a difference in at least one person’s life, I feel I’ve done my job,” Reed said. “Prisoners are just like me and you. They are somebody’s mother, brother, father or sister and I want to make sure they are treated with respect. When you give respect, you get respect.” In October, Reed was named Employment Counselor of the Year by the Offender Success Administration. Reed joined the MDOC three years ago after spending the earlier part of her career working at schools and later helping returning citizens find jobs through a role at Michigan Works!

Reed said she is focused on helping prisoners achieve success once they reenter the community. Before they leave prison, she helps them obtain vital documents like their birth certificate and social security card. She also holds workshops for prisoners on interviewing skills and resume writing, and helps coordinate job fairs at correctional facilities across the state. “My biggest thing is encouraging them and giving them the resources they need, so they can be a productive person...when they get out,” Reed said. She works to connect prisoners with employers in the community, and talks to different employers about their workforce needs. She said she also attends job fairs and business events in the community to connect with more employers who might be interested in hiring returning citizens. Reed is also on the Workforce Development Committee and helps train other new employment counselors. She said she often tells new employment counselors to take the job one day at a time. “I let them know their role is to help prisoners get better... so they can be successful in society,” she said.

# Parole Board member Barbara Sampson, Warden Duncan MacLaren announce retirements

"We have to have pride in ourselves and honor our organization because we can change the way people look at us. We're officers that play an equally important role as officers on the street."

# The Extra Mile

MDOC staff go beyond the call of duty to help others



Serving the community as a volunteer firefighter is something Timothy Ball and his family are passionate about. Ball, a contract monitor for the MDOC, is a second-generation volunteer firefighter, who gives back through his work with the DeWitt Area Emergency Services Authority, along with his father and brother. He was named the 2017 Firefighter of the Year by the authority for his dedication, efforts to mentor new firefighters, and work as treasurer for the Firefighter Association and co-chair of the annual firefighter’s breakfast. His service to his community and bravery in risking his own safety to help others as a firefighter earned him the department’s Citizenship Award.

Gabriel Forkel was driving to work at Richard A. Handlon Correctional Facility in October when he noticed a light along the opposite side of the road. As he got closer, he realized it was a person lying on the side of the road and waving their cell phone, so they could be seen. Forkel, a welding instructor at the facility’s Vocational Village, stopped his car to assist the individual, who said he had been struck by a car and the driver left the scene. Forkel called 911 and rendered emergency aid, including checking the man’s vitals while speaking to emergency responders on the phone. He continued to provide medical assistance until emergency medical services arrived. His attentiveness and willingness to render emergency aid earned him the department’s Lifesaving Award.



Acting Health Unit Manager Dennis Smith was working at Alger Correctional Facility in January 2017 when he received a call for assistance with a prisoner who was found unresponsive in his cell. Smith and other staff arrived on scene to help and Smith found the prisoner had a strong heart rate, but shallow breathing. Air was provided to the prisoner through an Ambu-Bag, an I.V. was started and Narcan was administered. The prisoner then regained consciousness and Smith and other staff continued to render aid and monitor the prisoner until emergency medical services personnel arrived.

Smith’s efforts to help the prisoner earned him the department’s Lifesaving Award.

# The Extra Mile continued...

Corrections Officer Jeffrey Patrick and Registered Nurse Paul Zelenak were at work at Alger Correctional Facility in May when they received a call for assistance with a prisoner who was found unresponsive on his bunk.

When Zelenak and Officer Patrick arrived at the scene, Zelenak found the prisoner did not have a pulse. The pair worked together to place an airway and initiated CPR on the prisoner.

Zelenak provided breathing with an Ambu-Bag, while Officer Patrick performed chest compressions.

Both provided an excellent example of teamwork to ensure the prisoner was provided with care and kept alive until he could be transferred to a hospital for further treatment.

Their efforts and commitment to helping those in need in a time of distress earned Officer Patrick and Zelenak the department's Lifesaving Award.

Staff at correctional facilities around the state also participated in similar Shop with a Hero events.


Employees at Ionia Correctional Facility have taken part in Shop with a Hero for the last three years, said Lt. Kevin Zwiker.
