



MCCA College Grant Program

PA 144 (2022-23 Budget)

PA 144 appropriated \$5 million to the Corrections Officer Grant Program to be administered by the Michigan Community College Association. The program provides financial support to corrections officers employed by the MDOC who are required to meet the 15-credit hour education requirement.

Program Eligibility – Corrections Officers

Corrections officers employed by the Michigan Department of Corrections who are required to complete the 15-credit hour education requirement are eligible for the grant program.

The application system will verify employment and eligibility each semester.



MCCA College Grant Program

Program Eligibility- Community Colleges

The 31 community colleges that are members of the Michigan Community College Association are eligible to enroll students in the grant program.

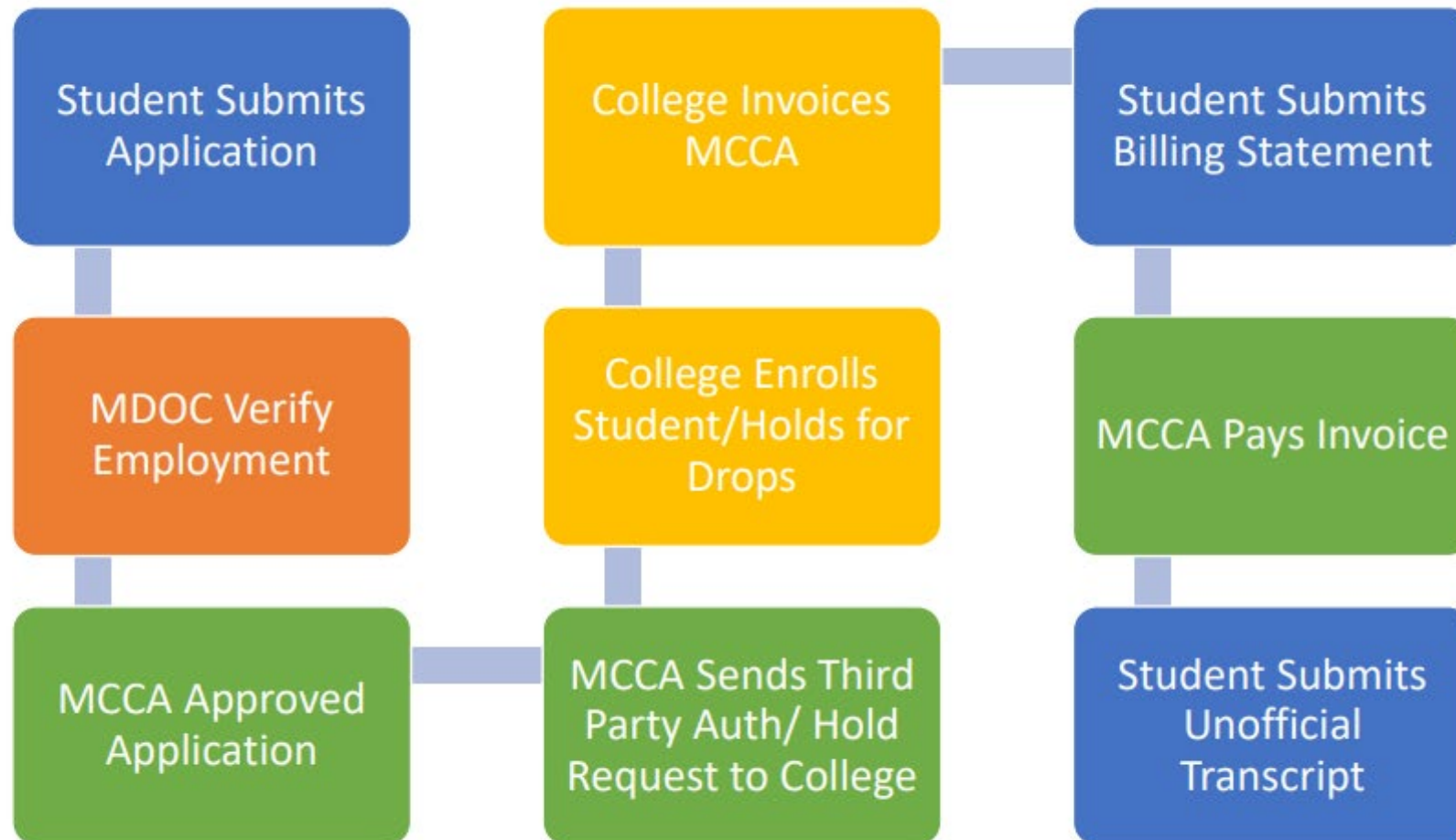
Public universities, private institutions, and out-of-state providers are not eligible institutions.


Program Length

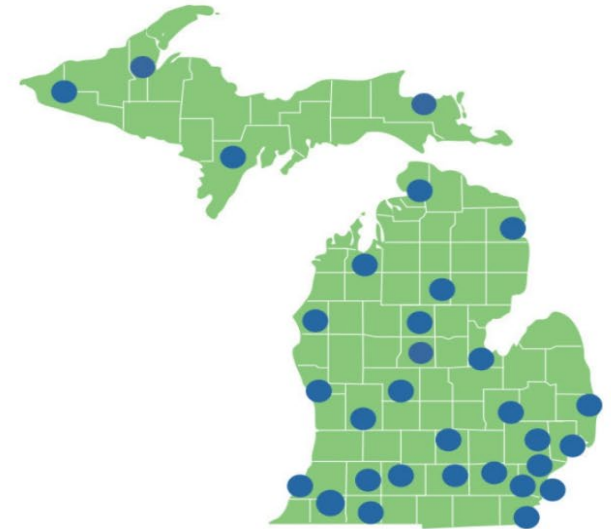

Michigan Corrections Officer Grant Program

The Michigan Department of Corrections (MDOC) requires that corrections officers earn 15 college credits within 24 months of employment. The Michigan Corrections Officer Grant Program established a fund to be administered by the Michigan Community College Association (MCCA) to support tuition and fees for corrections officers enrolled at a Michigan community college.

2. have not earned 15 college credits and are eligible for the grant program with the approval of the Michigan Department of Corrections.
3. Enroll at a community college in Michigan. Out-of-state community colleges, public universities, and independent colleges are not eligible institutions for this program.

Application

The application requests the following information. Please have this information ready before you begin the application.

1. basic contact information including name, address, phone number, and email address.
2. employee ID, and social security number.
3. employment and eligibility [verification form](#) signed by the facility human resources office -OR- the [email address of the facility human resources office](#).
4. the community college you plan to attend and in what semester you plan to enroll.

Once you register for classes, you will be required to submit additional information such as your billing statement from the college and your unofficial transcript once you complete the semester.

Note: for Fall 2022/Winter 2023:

Officers who attended classes and paid for classes out of pocket at one of the 31 eligible community colleges during Fall 2022 semester or Winter 2023 semesters qualify for reimbursement from MCCA. Select the semester you attended and paid for and prepare to provide your billing statement, proof of payment to the college, and an unofficial transcript to obtain reimbursement.

Michigan Department of Corrections Corrections Officer Grant Program Employment and Eligibility Verification

The Michigan Community College Association is managing the Corrections Officer Grant Program on behalf of the Michigan Department of Corrections. Corrections officers must complete an application to receive funding. Facility human resources offices must complete the Employment and Eligibility Verification to ensure that the corrections officer is eligible for the program.

Facility human resources offices are responsible for verifying eligibility. Return the completed form to the corrections officers so that the officer can submit the form with other application materials. For questions about how to complete this form, contact the MDOC Recruitment Office.

CORRECTIONS OFFICER INFORMATION

Provide requested information about the corrections officer. Verification must be completed each semester of enrollment to ensure that the corrections officer remains eligible for the program.

Student Submits Billing Statement

About 3-4 weeks after the start of the semester, MCCA will ask students to upload their billing statement. Although the MCCA will work directly with community colleges for invoicing and payment, this step allows MCCA to verify that students are enrolled as expected.

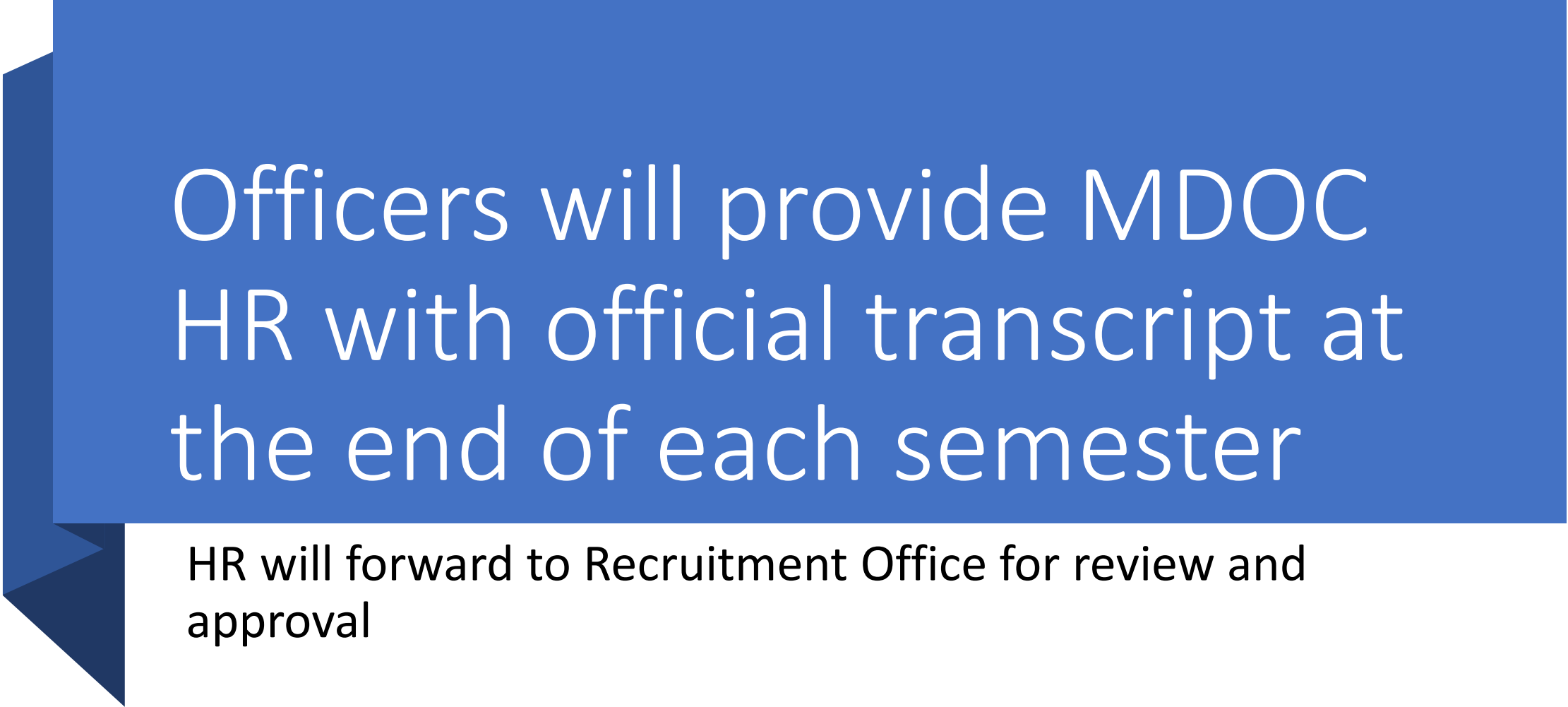
MCCA Issues Payment to Colleges

MCCA will promptly issue payment to community colleges. Payment documentation will include information about the students to ensure that accounts are properly credited.

MCCA will work with the billing contacts to ensure that we provide all of the necessary information with payment.

Student Submits Unofficial Transcript

At the end of the semester, students will be asked to submit an unofficial transcript. This will help MCCA with tracking credit attempts and completion for the purposes of approving grant applications for future semesters.

Corrections Officer Grant Program Policies

Corrections Officer Eligibility

Student/ Corrections Officer Eligibility: Corrections Officers (CO) who are employed by the Michigan Department of Corrections (MDOC) who have not earned 15 college credits are eligible for the grant program. COs must complete the education requirement with 24-months of employment with the MDOC or they will be separated. COs are notified by MDOC if they need to meet this requirement and corrections officers work closely with the MDOC and their facility human resources office to complete all the necessary requirements.

Other public safety officer eligibility: This program is only open to MDOC corrections officers who are required to meet the 15-credit requirement. Officers working in local jails or other facilities may be eligible for other programs, but not for this program.

Eligible Expenses

Expense eligibility: The grant will cover tuition and all fees including course fees, program fees, lab fees, and mandatory fees at the 31 approved community colleges in Michigan.

Out-of-district rates: The grant will cover out-of-district rates.

Required books and supplies expense coverage: The grant will not cover books and supplies.

Other Financial Aid: Since corrections officers are only required to complete 15 credit hours, most will not necessarily be degree-seeking students enrolled in programs that are federal financial aid eligible. The Corrections Officer Grant Program is a first-dollar program and should cover tuition and fees before any other aid.

Course Completion

Grade reporting: Corrections officers will be expected to submit unofficial transcripts to the MCCA for tracking purposes. Corrections officers are also expected to work directly with the MDOC and the facility human resources office to monitor progress toward completing the educational requirement. Once corrections officers complete all 15 credit hours, the corrections officer is required to submit official transcripts to the MDOC at MDOC-CO-Transcripts@michigan.gov.

Course withdraw/failure: MCCA will not seek a refund from students or colleges for withdrawal or failed courses. However, corrections officers are only eligible for a lifetime maximum of 15 credit hours paid by the Corrections Officer Grant Program. Withdrawal or failed courses will count toward the maximum of 15 credits.

Terminated Employment: If a corrections officer is terminated or separated from the MDOC during the semester of enrollment, the MCCA will not seek a refund from students or colleges. The CO will lose eligibility from the program until employment is reinstated and the corrections officer is approved by the MDOC.

Required Documentation: Corrections officers must provide billing statements and unofficial transcripts for each term through the application portal managed by the Michigan Community College Association.
