The proposed changes to the Industrial Hemp Rules for Marijuana Businesses rule set 2021-92 LR are intended to improve clarity/consistency to those working in both the medical and adult use markets. The rule set implements, administers, and enforces appropriate and updated standards for marihuana businesses and associated equipment and establishes regulations ensuring the safety, security, and integrity of the operation of marihuana businesses in relation to industrial hemp.

The Executive Director of the Agency is authorized to promulgate rules based upon, Section 206 of the Medical Marihuana Facilities Licensing Act, 2016 PA 281, MCL 333.27206, Sections 7 and 8 of the Michigan Regulation and Taxation of Marihuana Act, 2018 IL 1, MCL 333.27957 and 333.27958, Section 5 of the Michigan Medical Marihuana Act, 2008 IL 1, MCL 333.26425, The Marihuana Tracking Act, 2016 PA 282, MCL 333.27901, et al. and Executive Reorganization Order No. 2019-2, MCL 333.27001.
