The purpose of this public meeting is to hear complaints and receive the views of the public on MRA's administration of the authorities, powers, duties, functions and responsibilities under the Michigan Medical Marihuana Act, 2008 IL 1, Michigan Medical Marihuana Facilities Licensing Act, 2016 PA 281, Marihuana Tracking Act, 2016 PA 282, and Michigan Regulation and Taxation of Marihuana Act, 2018 IL 1. Specifically, the MRA is seeking public input on the following topic:

If cannabis or cannabis products fail the MRA's regulatory compliance testing, businesses must either complete the process of remediation or destroy the product. Remediation is the process in which a business corrects something undesirable or deficient in their product. Should businesses be required to notify consumers if products have been remediated? If so, by what method should consumers be notified? Which products should be included in the remediation notification process? What processes of remediation should require consumer notification, if any? Should products that have not failed a safety compliance test but have been exposed to a remediation method require identification?
