/ CONSENT ORDER AND STIPULATION

CONSENT ORDER

On January 21, 2025, the Cannabis Regulatory Agency (CRA) issued a formal complaint against the adult-use marijuana Class C grower establishment license (AU-G-C-000816) of Regency Specialties Inc. (Respondent) under the Michigan Regulation and Taxation of Marijuana Act (MRTMA), MCL 333.27951 *et seq.*, and the administrative rules promulgated thereunder. The formal complaint alleged Respondent violated Mich Admin Code, R 420.802(3)(f)(ii) and R 420.802(3)(f)(v).

The executive director reviewed the stipulation contained in this document and agrees the public interest is best served by resolution of the formal complaint. Therefore, the executive director finds that all of the allegations contained in the formal complaint are true and that Respondent violated Mich Admin Code, R 420.802(3)(f)(ii) and R 420.802(3)(f)(v).

Accordingly, for these violations, **IT IS ORDERED:**

1. Respondent must pay a fine in the amount of two thousand two hundred ninety two and 00/100 dollars (\$2,292.00). This fine shall be paid within 90 days of the effective date of this order by check, money order, or online through Accela Citizen Access (ACA). Instructions on how to make online payments can be found under the Tips for Licensees bulletin section at www.michigan.gov/cra. Check or money orders shall be made payable to the State of Michigan with enforcement number "ENF-25-00054" and license number "AU-G-C-000816" clearly displayed on the check or money order. 2. Within 90 days of the effective date of this order, Respondent shall submit to the CRA an updated standard operating procedure (SOP) that promotes compliance with the administrative rules regarding reporting of material changes.
3. If Respondent fails to timely comply with the terms of this order, Respondent's license shall be suspended until compliance is demonstrated.
4. Unless otherwise specified in this order, Respondent shall direct any communications to the CRA that are required by the terms of this order to CRA-CSS@michigan.gov.
5. Respondent shall be responsible for all costs and expenses incurred in complying with the terms and conditions of this consent order.
6. If Respondent violates any term or condition set forth in this order, Respondent shall be subject to fines and/or other sanctions under section 7(1)(c) of the MRTMA, MCL 333.27957, and Mich Admin Code, R 420.808.
7. Upon timely compliance of the terms of this order by Respondent, the matters set forth in the formal complaint shall be deemed resolved and closed subject to this Consent Order.

STIPULATION

The parties stipulate to the following:

1. The facts alleged in the formal complaint are true and constitute a violation of the administrative rules promulgated under the MRTMA.
2. Respondent understands and intends that by signing this stipulation, Respondent is waiving the right under the MRTMA, administrative rules promulgated thereunder, and the Administrative Procedures Act of 1969, MCL 24.201 *et seq.*, to require the CRA to prove the violations set forth in the formal complaint by presentation of evidence and legal authority, and to present a defense to the violations.
3. The parties considered the following in reaching this agreement:
 - a. On December 4, 2024, Respondent filed the reporting form for the material changes at issue.
 - b. Respondent was cooperative and wishes to resolve the allegations without the need for and expense of an administrative hearing.
 - c. Respondent has been licensed as a Class C grower since 2022 and has no prior discipline against its license.

FORMAL COMPLAINT

The Cannabis Regulatory Agency (CRA) files this formal complaint against Regency Specialties, Inc. (Respondent) alleging upon information and belief as follows:

1. The CRA is authorized under the Michigan Regulation and Taxation of Marihuana Act (MRTMA), MCL 333.27951, *et seq.*, and Executive Reorganization Order No.2019-2, MCL 333.27001, to investigate alleged violations of the MRTMA and the administrative rules promulgated thereunder, take disciplinary action to prevent such violations, and impose fines and other sanctions against applicants and licensees that violate the MRTMA or administrative rules.

2. Section 8(1)(d) of the MRTMA provides that the administrative rules must ensure the health, safety, and security of the public and integrity of the marijuana establishment operations.

FACTUAL ALLEGATIONS AND INTENDED ACTION OF THE CRA

3. Respondent holds an active state license under the MRTMA to operate an adult use marijuana class C grower establishment in the state of Michigan.

4. Respondent operated at 23685 Regency Park, Warren, Michigan 48089, at all times relevant to this complaint.

5. Following an investigation, the CRA determined that Respondent violated the MRTMA and/or administrative rules promulgated thereunder as set forth below:

- a. On October 8, 2024, a Bureau of Fire Services inspector conducted a fire safety inspection at Respondent's establishment and discovered that both the nursery Veg Room A and the Veg Room B had newer tier racking. Additionally, Respondent used a vertical two-level rolling rack steel scaffolding unit that did not have any guardrails and locking wheels to prevent falling.
- b. On October 18, 2024, a CRA Regulation Agent (RA) observed in Accela that Respondent failed to submit a reporting form for the changes made at the establishment.
- c. On November 25, 2024, the CRA RA conducted a follow-up onsite inspection at Respondent's establishment and met with general manager G.G., who confirmed that changes were made.
- d. On December 3, 2024, the CRA RA sent an email to D.D. and requested an explanation why a reporting form was not submitted regarding the new tier racking.
- e. On December 4, 2024, D.D. responded by email and provided the reporting form that was submitted to the CRA for November 18, 2024. However, D.D. was not listed on the license record or the prequalification record as an onsite or other contact, therefore, the reporting form was rejected by the CRA.

Count I

Respondent's actions as described above in paragraphs a, b, c, d and e demonstrate a violation of Mich Admin Code R 420.802(3)(f)(ii), which states licensees shall report to the agency any proposed material changes to the marijuana business before making a material change. is any action that would result in alterations or changes being made to the marihuana business to effectuate the desired outcome of a material change. Material changes, include, but are not limited to, the following: (f) Any change or modification to the marihuana business before or after licensure that was not preinspected, inspected, or part of the marihuana business location plan or final inspection, including, but not limited to, all of the following: (ii) Additions or reductions in equipment or processes.

Count II

Respondent's actions as described above in paragraphs a, b, c, d and e demonstrate a violation of Mich Admin Code R 420.802(3)(f)(v), which states licensees shall report to the agency any proposed material changes to the marihuana business before making a material change. A proposed material change is any action that would result in alterations or changes being made to the marihuana business to effectuate the desired outcome of a material change. Material changes, include, but are not limited to, the following: (f) Any change or modification to the marihuana business before or after licensure that was not preinspected, inspected, or part of the marihuana business location plan or final inspection, including, but not limited to, all of the following: (v) Changes that impact security, fire safety, and building safety.

THEREFORE, based on the above, the CRA gives notice of its intent to impose fines and/or other sanctions against Respondent's license, which may include the suspension, revocation, restriction, and/or refusal to renew Respondent's license.

Pursuant to Mich Admin Code, R 420.704(2), any party aggrieved by an action of the CRA suspending, revoking, restricting, or refusing to renew a license, or imposing a fine, shall be given a hearing upon request. A request for a hearing must be submitted to the CRA in writing within 21 days after service of this complaint. Notice served by certified mail is considered complete on the business day following the date of the

mailing.

Respondent also has the right to request a compliance conference under Mich Admin Code, R 420.704(1). A compliance conference is an informal meeting at which Respondent has the opportunity to discuss the allegations in this complaint and demonstrate compliance under the MRTMA and/or the administrative rules. A compliance conference request must be submitted to the CRA in writing.
