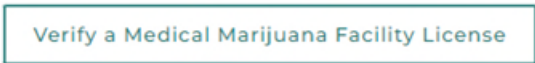
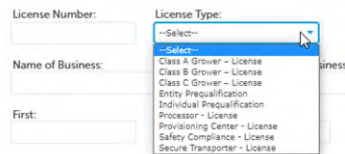


## Instructions to view Disciplinary Actions on ACA site

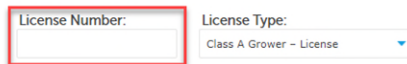
- Please select the module of the licenses you wish to view (Medical Facility Licensing or Adult-Use Establishment Licensing)
