### Compliance Action – Citation

19533 W. Warren  
DBA Tango Healthy Cannabis:

Following an investigation, the Marijuana Regulatory Agency (MRA) determined that 19533 W. Warren DBA Tango Healthy Cannabis (“Respondent”), license no. PC-000024, violated the Medical Marihuana Facilities Licensing Act (MMFLA), and/or administrative rules promulgated thereunder as follows:

1. On August 8, 2019, Respondent had over 350 transactions in the statewide monitoring system (METRC) where the words “papers” or “paperwork” were entered into the patient identification number field.
2. On August 28, 2019, Respondent admitted it allowed people who had paperwork completed by their doctor for a medical marihuana registry card application and government ID to purchase medical marihuana. MRA staff educated Respondent about the requirement for verification of patient and/or caregiver status prior to sales.
3. On October 7, 2019, Respondent had over 200 sales transactions in METRC between August 29, 2019 and October 4, 2019, where the words “papers” or “paperwork” was entered into the patient identification number field.
4. On October 8, 2019, Respondent admitted it allowed people who had proof of mailing their paperwork for a medical marihuana patient card, along with a copy of the money order showing proof of payment to purchase marihuana products.
5. Based upon the above, Respondent allowed access to the dedicated point of sale area to individuals other than registered qualifying patients and registered primary caregivers with valid registry cards in violation of Mich Admin Code, R 333.231(2)(d).
6. Based upon the above, Respondent sold or transferred marihuana product without verifying in METRC that the registered qualifying patient or registered primary caregiver holds a valid, current, unexpired, and unrevoked registry identification card in violation of Mich Admin Code, R 333.274(1)(a).

Mich Admin Code, R333.219, provides that a licensee found in violation of the MMFLA and/or administrative rules may be subject to sanctions, including fines. For the above violations, the MRA intends to impose a fine of \$4,000.00.
