**Compliance Action – Citation**

Great Lakes Natural Remedies, Inc.:

ERG No.: 000452  
License No.: GR-C-000209

Following an investigation, the Marijuana Regulatory Agency (MRA) determined that Great Lakes Natural Remedies, Inc. (“Respondent”), license no. GR-C-000209, violated the Medical Marihuana Facilities Licensing Act (MMFLA), and/or administrative rules promulgated thereunder as follows:

1. On October 15, 2019, C.M. from Respondent’s facility sent an email to the MRA requesting to remediate five product batches that were in final packaging:
  - a. 1A405010000170D000000010 MKX Blue Raz Cart 983 each;
  - b. 1A405010000170D000000019 MKX Strawberry Lemonade Cart 983 each;
  - c. 1A405010000170D000000068 MKX Blue Raz Cart 4005 each;
  - d. 1A405010000170D000000070 MKX Forbidden Fruit Cart 3038 each; and
  - e. 1A405010000170D000000077 MKX Strawberry Lemonade Cart 3138 each.
  
2. After receipt of the email, MRA staff reviewed the testing data in the statewide monitoring system (METRC) for the above listed packages. All five packages had failing test results entered into METRC, were submitted for retesting, and had failing retest results entered into METRC.
  
3. Respondent had five product batches in final packaging retested in violation of Mich Admin Code R333.246(3)(a).

Mich Admin Code, R 333.219 provides that a licensee found in violation of the MMFLA and/or administrative rules may be subject to sanctions, including fines. For the above violations, the MRA intends to impose a fine of \$2,000.00.

If you agree to resolve this citation as set forth in the citation agreement below, you must sign and return the attached citation agreement within 30 days after receipt of the citation. The fine must be paid within 30 days after you receive the citation agreement signed by the enforcement director. Return the signed agreement and submit payment by:

5. Respondent agrees to timely pay the fine set forth in the citation.
6. Respondent does not admit the truth of the allegations in the citation but agrees that the MRA may treat the allegations as true for purposes of resolving the citation.
7. The MRA reserves the right to consider this agreement in the context of subsequent disciplinary proceedings and license application or renewal decisions.
