	 CONSENT ORDER AND STIPULATION

CONSENT ORDER

On November 3, 2021, the Cannabis Regulatory Agency (CRA) issued a formal complaint against the medical marijuana processor facility license (PR-000027) of CLDD, LLC ("Respondent") under the Medical Marihuana Facilities Licensing Act (MMFLA), MCL 333.27101 *et seq.*, and the administrative rules promulgated thereunder. The formal complaint alleged Respondent violated Mich Admin Code, R 420.210(2) and R 420.212(1).

The executive director reviewed the stipulation contained in this document and agrees the public interest is best served by resolution of the formal complaint.

Therefore, the executive director finds that all of the allegations contained in the formal complaint are true and that Respondent violated Mich Admin Code, R 420.210(2) and R 420.212(1).

Accordingly, for these violations, IT IS ORDERED:

1. Respondent must pay a fine in the amount of Six Thousand and 00/100 dollars (\$6,000.00). This fine shall be paid within 60 days of the effective date of this order by check, money order, or online through Accela Citizen Access (ACA). Instructions on how to make online payments can be found under the Tips for Licensees bulletin section at www.michigan.gov/cra. Check or money orders shall be made payable to the State of Michigan with enforcement number "21-00323" and license number "PR-000027" clearly displayed on the check or

money order. Respondent shall mail the fine to Department of Licensing and Regulatory Affairs, Cannabis Regulatory Agency, PO BOX 30205, Lansing, Michigan 48909.

If Respondent fails to timely comply with the terms of this order, Respondent's license shall be suspended until compliance is demonstrated.

 Unless otherwise specified in this order, Respondent shall direct any communications to the CRA that are required by the terms of this order to <u>CRA-LegalHearings@michigan.gov</u>.

4. Respondent shall be responsible for all costs and expenses incurred in complying with the terms and conditions of this consent order.

Respondent shall provide an updated standard operating procedure for its storage of marijuana within 30 days of the effective date of this order.

 If Respondent violates any term or condition set forth in this order, Respondent will be subject to fines and/or other sanctions under section 407(1) of the MMFLA, MCL 333.27407(1), and Mich Admin Code, 420.808.

 Upon timely compliance of the terms of this order by Respondent, the matters set forth in the formal complaint shall be deemed resolved and closed subject to this Consent Order.

This order shall be effective 30 days after the date signed by the CRA's executive director or his designee, as set forth below.

The parties stipulate to the following:

- The facts alleged in the formal complaint are true and constitute a violation of the administrative rules promulgated under the MMFLA.
- 2. Respondent understands and intends that by signing this stipulation, Respondent is waiving the right under the MMFLA, administrative rules promulgated thereunder, and the Administrative Procedures Act of 1969, MCL 24.201 et seq., to require the CRA to prove the violations set forth in the formal complaint by presentation of evidence and legal authority, and to present a defense to the violations.
- 3. The parties considered the following in reaching this agreement:
 - There is no concern of unregulated product with this noncompliance.
 The product in question was discovered while the CRA was onsite.
 - Respondent was cooperative and wishes to resolve the allegations without the need for and expense of an administrative hearing.
- 4. The CRA's operations director or his designee must approve this proposed agreement before it is forwarded to the CRA's executive director or his designee for review and issuance of the above consent order. The parties reserve the right to proceed to an administrative hearing without prejudice to either party, should the CRA's operations director, executive director, or their designees reject the proposed consent order.

FORMAL COMPLAINT

The Marijuana Regulatory Agency ("Complainant") files this formal complaint against CLDD, LLC ("Respondent") alleging upon information and belief as follows:

1. The Marijuana Regulatory Agency (MRA) is authorized under the Medical

Marihuana Facilities Licensing Act (MMFLA), MCL 333.27101 et seq., and Executive

Reorganization Order No.2019-2, MCL 333.27001, to investigate alleged violations of the

MMFLA and the administrative rules promulgated thereunder, take disciplinary action to

prevent such violations, and impose fines and other sanctions against applicants and

licensees that violate the MMFLA or administrative rules.

2. Section 402(12) of the MMFLA provides that the expiration of a license does not

terminate the MRA's authority to impose sanctions on the license.

3. Section 206(c) of the MMFLA provides that the administrative rules must ensure

the health, safety, and security of the public and integrity of the marihuana facility

operations.

4. Respondent's conduct as described below is a risk to public health and safety

and/or the integrity of marihuana facility operations.

FACTUAL ALLEGATIONS AND INTENDED ACTION OF THE MRA

5. Respondent holds an active state operating license under the MMFLA to operate

a medical marihuana processor facility in the state of Michigan.

Respondent operated at 1255 Falahee Rd., Jackson, Michigan 49203, Michigan,

at all times relevant to this complaint.

7. Following an investigation, the MRA determined that Respondent violated the

MMFLA and/or administrative rules promulgated thereunder as set forth below:

8. ENF: 21-00327

a. Respondent produced a medical marijuana product, Monster Mango

Gummies (statewide monitorina system METRC tag

#1A40501000029CD000000527), that was later sold by a medical

marijuana provisioning center to a patient on December 24, 2020.

b. Respondent incorrectly labeled the product with a test analysis date of

January 6, 2020.

c. According to METRC, the product was tested on January 14, 2020,

February 15, 2020, and March 6, 2020.

d. Respondent labeled the product with an incorrect test date, which is a

violation of Mich Admin Code, R 420.504(1), which states before a

marihuana product is sold or transferred to or by a marihuana sales location,

the container, bag, or product holding the marihuana product must be

sealed and labeled with all of the following information: (i) Name of the

laboratory that performed any test, and any test analysis date.

e. Respondent attached a product label that contained a deceptive, false, or

misleading test analysis date, which is a violation of Mich Admin Code, R

420.507(2), which states marihuana product must not be advertised in a

way that is deceptive, false, or misleading. A person shall not make any

deceptive, false, or misleading assertions or statements on any marihuana

product, sign, or document provided.

9. ENF: 21-00323

a. While conducting a random spot check on July 8, 2021, the MRA discovered

unsecured and untagged marijuana product within a large, unlocked

container outside of Respondent's facility in violation of Mich Admin Code,

R 420.212(1), which states all marihuana products must be stored at a

marihuana business in a secured limited access area or restricted access

area and must be identified and tracked consistently in the statewide

monitoring system under these rules.

b. Respondent's possession of untagged marijuana product is also a violation

of Mich Admin Code, R 420.210(2), which states except for a designated

consumption establishment or temporary marihuana event licensed under

the Michigan regulation and taxation of marihuana act, a marihuana

business must not have any marihuana product without a batch number or

identification tag or label pursuant to these rules. A licensee shall

immediately tag, identify, or record as part of a batch in the statewide

monitoring system any marihuana product as provided in these rules.

THEREFORE, based on the above, the MRA gives notice of its intent to impose fines

and/or other sanctions against Respondent's license, which may include the suspension,

revocation, restriction, and/or refusal to renew Respondent's license.

Under MCL 333.27407(4) and Mich Admin Code, R 420.704(2), any party aggrieved

by an action of the MRA suspending, revoking, restricting, or refusing to renew a license,

or imposing a fine, shall be given a hearing upon request. A request for a hearing must

be submitted to the MRA in writing within 21 days after service of this complaint. Notice

served by certified mail is considered complete on the business day following the date of

the mailing.

Respondent also has the right to request a compliance conference under Mich Admin

Code, R 420.704(1) A compliance conference is an informal meeting at which

Respondent has the opportunity to discuss the allegations in this complaint and demonstrate compliance under the MMFLA and/or the administrative rules. A compliance conference request must be submitted to the MRA in writing.
