North Coast Cultivators LLC is proud to participate in the Social Equity Program as outlined under the Michigan Regulation and Taxation of Marihuana Act (MRTMA). North Coast Cultivators LLC is committed to promoting, encouraging and supporting participation in the marijuana industry by people from communities that have been disproportionately impacted by marijuana prohibition and enforcement. With our help we will work together to impact those communities in the most positive manner.

North Coast Cultivators LLC has the ability to directly contribute to people and communities in the Social Equity Program as made possible through a provision under the MRTMA. Section 8 required the Marijuana Regulatory Agency (MRA) to promulgate rules including “a plan to promote and encourage participation in the marihuana industry by people from communities that have been disproportionately impacted by marihuana prohibition and enforcement and to positively impact those communities” (MCL 333.27958, 2018 IL 1).

North Coast Cultivators LLC will make it a priority to seek out and locate qualified, willing Social Equity Program participants, focusing specifically on the following 184 communities that have been identified as qualifying for the Michigan Social Equity Program as of October 23, 2020,:

This mentoring will include assistance with completing application forms, sharing of resources and general operational guidance.

We look forward to our participation in this program to help level out the playing field and to ensure all qualified individuals are able to reap the rewards of the cannabis industry.
