## Notification of Marijuana Product Recall

The Marijuana Regulatory Agency (MRA) is issuing this health and safety advisory bulletin due to unapproved testing and sampling of infused edible products by a licensed processor. The affected packages of infused edible products were manufactured by **3843 Euclid LLC (License Nos. (PR-000098 and AU-P-000106) in Bay City** and were dispersed to many marijuana sales locations throughout Michigan.

All recalled products will have a label that indicates the license number of the marijuana business that sold the marijuana product as well as tag number assigned to the product in the statewide monitoring system.

**Note: An MRA investigation is still on-going and may result in additional future recalls.**
