Cannabis Regulatory Agency Notifies Consumers of Marijuana Product Recall

In the interest of public health and safety, the Cannabis Regulatory Agency (CRA) is recalling 1,098 units of infused pre-rolls produced by Flavor Galaxy LLC (license no. AU-P-000373), located at 21015 John R Road, Hazel Park, MI 48030.

In its investigation, the CRA discovered that Flavor Galaxy did not submit certain infused pre-rolls for testing in their final form. The statewide monitoring system (Metrc) indicated that the infused pre-rolls only had safety compliance testing for raw marijuana flower and potency and were not tested after Flavor Galaxy added cannabis distillate and/or terpenes to the product.

Consumers who purchased a Flavor Galaxy produced infused pre-roll (with AU-P-000373 on the package label) between November 25, 2023, and May 6, 2024, at the following retail locations should check the list of Metrc tags below to determine if the product is subject to this recall:

Consumers should discard or return these products to the marijuana sales location for proper disposal.

Retailers have two options for the returned product and the product in their physical inventory: (1) discard/waste the product or (2) return the product to Flavor Galaxy LLC by repackaging, following the instructions in this [bulletin](#).

The retailers mentioned above must display this recall notice on the sales floor, visible to all consumers, for 30 days from the date of this notice.

Consumers who have experienced adverse reactions after using these products should report their symptoms and product use to their healthcare providers. Consumers are encouraged to also report any adverse reactions to marijuana product to the CRA via the [Adverse Reaction Form](#) or by phone at 517-284-8599. A licensee that becomes aware of any adverse reactions to a marijuana product must notify the CRA and enter the information into METRC within one business day.
