IT IS ORDERED that the bulletins listed below are withdrawn, together with any bulletins that they rescind, withdraw, or supersede.

- 77-1 Interim Filing Procedures for Rates Subject to Section 500.2027 MCL (The bulletin is obsolete, it explains an interim filing procedure and is no longer necessary.)

- 77-3 Foreign Insurers - Statement of Qualifying Assets and Liabilities as Measured by Section 901 of the Michigan Insurance Code (The bulletin is obsolete. This issue is adequately covered in Sec. 500.438 of the Insurance Code.)

- 77-10 Requirements Regarding Life and Annuity Policy Loan Interest Rates (The bulletin is obsolete, MCLA 500.4023 makes this bulletin unnecessary.)


- 78-7 No-Fault Auto Insurance: Creation of Catastrophic Claims Association (The bulletin is obsolete. It is a request for filing data - a one time requirement that has expired.)

- 78-18 Regulation of Credit Accident and Health Insurance Rates for Credit Unions (The bulletin is obsolete. It is a one-time informational bulletin and Credit Rules 550.210 & 550.214 make it unnecessary.)

- 78-20 Arson: Responsibility of Insurers to Report Suspicious Fires (The bulletin is obsolete, it is a one-time informational bulletin that is no longer necessary.)

- 78-24 No-Fault Auto Insurance: 1978 Amendments (The bulletin is obsolete. It is an informational bulletin that is no longer necessary.)
- 78-27 Alleged Violation of Uniform Trade Practices Act: Discrimination Based on Sex or Marital Status (The bulletin is obsolete. This issue is adequately covered in the Essential Insurance Act (Chapter 21).)
- 79-3 Products and Municipal Liability Insurance Financial Reporting Requirements (This bulletin is no longer necessary, the Insurance Code and Form INS 118 include all pertinent data.)
- 79-13 Confidentiality of Trade Secrets Under the Michigan Freedom Of Information Act (The bulletin is no longer necessary, sections of the Insurance Code provide confidentiality protection.)
- 79-16 Group Life Insurance: IRS Section 79 Insurance Plans (The bulletin is no longer necessary, IRS Disclosure Requirements adequately cover this issue.)
- 79-19 Prohibited Transactions Between Agents and Uninsured Multiple Employer Trusts (The bulletin is obsolete. It has been superseded by the enactment of 1986 PA 121 which added Chapter 70 to the Code.)
- 80-6 Replacement Cost and Repair Cost Homeowners Policies (The bulletin is obsolete, referenced section 500.2604 of the Insurance Code has expired.)
- 80-11 Automobile Insurance and Home Insurance (Chapter 21): Exemptions (The bulletin is obsolete. It is a request for a filing - a one time requirement that has expired.)
- 80-12 Limited Tort Liability for Collision Damages Under Essential Insurance Act (The bulletin is obsolete. It is a request for a filing - a one time requirement that has expired.)

The Commissioner retains jurisdiction of the matters contained herein and the authority to enter such further order or orders as he shall deem just, necessary and appropriate.


