The NMU National Guard Grant covers up to 45% of NMU tuition, university fee and student activity fee.

Application Deadline: First day of classes for each semester.

I understand the following eligibility criteria:

- Must be admitted to a degree-granting program, or eligible certificate program.
- Must be a Michigan resident prior to July 1, 2022.
- Must meet NMU's Satisfactory Academic Progress (SAP) policy standards. www.nmu.edu/finaidsap
- Must not be in default on Federal student loans.
- The total of all tuition assistance programs that I receive may not exceed the tuition, university fee and student activity fee cost of NMU. I understand other tuition/fee sensitive awards, such as Chapter 33-Post 9/11 G.I. Bill, Michigan Competitive Scholarship, Michigan Achievement Scholarship, Army Continuing Education System (ACES), Michigan National Guard State Tuition Assistance Program (MING-STAP), Michigan Indian Tuition Waiver, Tuition Incentive Program, NMU Tuition Advantage Program, NMU Faculty/Staff/Dependent Tuition Waiver, Police Academy Scholarship, etc. will only receive the combined awards up to the total tuition, university fee and student activity fee. If this situation should occur, the amount of my NMU National Guard Grant for tuition and mandatory fees or my Chapter 33 tuition/fee payment will be reduced.
- Recipients of the NMU ROTC Room/Board Scholarship will not receive the NMU National Guard Grant or any other NMU funded scholarships/grant.
- Must certify enrollment for monthly Veteran's Benefit with the Veteran Student Services Office. Only students receiving the following benefits are eligible for the NMU National Guard Grant: Title 38 U.S. Code Chapter 30 – Montgomery Bill; Title 10 U.S. Code Section 1606 – Selected Reserve Montgomery Bill; or, Title 10 U.S. Code Section 1607 – Increased Reserve or Chapter 33 – Post 9/11 G.I. Bill. All other benefit types are ineligible. The NMU National Guard Grant cannot be awarded until this requirement is completed.
- Upon receipt of the NMU National Guard Grant Application, the Financial Aid Office will review all financial aid received. In the case of overawards, adjustments to student loans, Federal Work-Study or grants may occur.
- This grant does not cover the cost of tuition for courses that are repeated, this includes withdrawals.
