Chair Elliott opened the meeting at 9:01 a.m. and began with information items.

Tom Bissett, Urban District Supervisor, began by congratulating Erika Compton who recently accepted a position as an Accounting Tech with the Resource, Protection and Promotion Section, and to Cynthia Boggerty-Craft who accepted a position to Lead Office Assistant at Belle Isle.

Tom continued with information about the food truck concession, which is now up for bid again. The contract is available at:

Michigan.gov/stateparkconcessions and bids will be accepted through January 8. They are also accepting opportunities to be a vendor at the park. Anyone interested should reach out to the office, specifically to Cynthia Boggerty-Craft (boggertycraftc@michigan.gov). They will host an online session on November 27 for anyone who has questions about the process. There will be another opportunity for a session in December. The Sunset booth will be the only booth open right now. If the booth is not staffed, you can purchase a Recreation Passport at the kiosk, the drop pipe, or at the headquarters.

Gail Fitch, Park Supervisor, announced that the Scott Fountain is being shut down for the season. All restrooms are shut down for the winter, with the exception of the public side of the Flynn, Bus Stop Shelter 7 and the vault toilet by the parking lot near the Yacht club.

Chair Elliott officially called the meeting to order at 9:12 a.m. and began roll call.

Chair Elliott then asked for a motion to approve the October 17, 2024 meeting minutes. The motion was moved by Member Curis, seconded by Member Lugo-Thomas, and passed unanimously.

Chair Elliott mentioned the November 7, 2024 special meeting had over 170 people in attendance, one hundred in person and 70 online, and it was a great conversation. She combined all of the public comments and put them into a spreadsheet and asked the team doing the development and the MDNR to answer the questions so as to post them online. Chair Elliott then called for a motion to approve the November 7, 2024 special meeting minutes. The motion was moved by Member Lugo-Thomas, supported by Member Curis, and passed unanimously.

The next item on the agenda was the Law Update. Lt. Todd Szyska, along with Sgt. Owens, DNR Law, announced the 6<sup>th</sup> annual Stuff a Truck program, a partnership with the Detroit Police Department, to help support the children of Detroit. The program will have bins placed at the Outdoor Adventure Center, Belle Isle Park headquarters and Maybury State Park headquarters. Donations of new, unwrapped gifts will be accepted Monday through Friday, 8 a.m. to 4:30 p.m. November 30 they will host in-person at the Outdoor Adventure Center with a conservation officer and Mr. and Mrs. Santa Claus present for photos.

Tom Bissett continued with the infrastructure update, which included an update on where they are at right now with the boathouse discussions. He then displayed a presentation of the various projects around the island, such as the Conservatory, Ralph C. Wilson, Jr. Trail, the MDOT micro-surfacing, Shelter #9, athletic shelter, and other ARPA projects.

Chair Elliott shared that the multimodal study is in its final stages. There is not a date yet for posting the update on the website, but it will be coming soon and publicized. They are also in the early stages of the island-wide development plan, which will build off the multimodal study in terms of participation and filling those gaps. She asked for people to let her know of any groups that may want to be involved.

Amy Emmert, Director of Education and Engagement, Belle Isle Conservancy, then gave an update on the bird banding program that has begun again on the island, led by Mr. Allen Chartier. The birds are collected and clasped around the leg with a metal band, which allows research to be done on species and migration patterns. #### **Public Comment**

Rosebud Bear Schneider – Spoke of the large community of indigenous people in Detroit, many of whom use the island and care deeply for it, and about the Detroit Indigenous Peoples Alliance, a collective of many who work together and were instrumental in Detroit history.

David Carleton, Stuart-Pittman - He is from the development firm who submitted the boathouse proposal. Spoke of his excitement to attend the public meetings, finding out more about the island, and to hopefully be successful in the development of the boathouse.

Amy Hubbard – Asked about the boathouse timeline and if there will be another public meeting.

Lisa DiChiera, Deputy Director of Historic Designation Advisory Board under City Council – Spoke about the boathouse and asked about winterizing the roof.

#### Member Comment

Angela Lugo Thomas – Said it was important to have someone from the indigenous community attend the meeting as they have a large presence in Detroit, and that hopefully they can adjust the time of the meetings so more people can attend.

Michael Curis – He thinks there should be an exception for indigenous people so that they do not have to pay to enter the island. He also spoke on the boathouse and expressed that there will be some difficult decisions to be made with financing it, among others, and that there will need to be a process in place to decide these issues before we get too far into the process.

Sommer Woods – Echoed the comments about morning meetings being difficult to attend and having more than one evening meeting, the importance of including the indigenous community, and asked about the vendor sessions and if a separate communication could be sent to her to distribute to her networks.

Chair Elliott – Will send a survey to see what times make sense for the BIPAC meetings to occur in 2025.

Chair Elliott asked Tom about the next boathouse public meeting. Tom Bissett replied that the developer and DNR are first looking into a few things, among them funding and how the model will work as far as vendors and opportunities. Next steps are unclear at this time as they still need to coordinate with the city. They will look at more public meeting opportunities after the holidays. 
#### **Project Status**



- Microsurfacing for roadway from Picnic Way to Bridge entry and exit.
- New pavement markings for vehicles and 2-way cycle track and on street parking.
- Special markings for cycle track at intersections
- Installation of new ADA ramps along the Strand.






Zoo site visits have taken place to prepare for surveying and testing in coordination with removal plans.

# **Demonstration Green Infrastructure Parking Lot**The Nature Conservancy Grant

#### Project

- To coordinate with the zoo structure removal.
- New lot will also align with recommendations from mobility study.
  - Migrate parking to where it is needed to reduce traffic congestion and improve park visitor experience.
  - Install sustainable new infrastructure.
  - Replace parking that does meet need for popular places and contributes to stormwater in park combined sewer overflow.



Recommendation from mobility study for migrating parking throughout park will be implemented on coordination with zoo removals.
