### **Opening Comments**

Committee member Ann Conklin called the meeting to order at 2:02 p.m. and asked for a roll call. Public comment was moved to the beginning of the agenda.

### **Public Comment**

Bobby Pratt, Director of Education, Great Lakes Surf Rescue Project, spoke on their efforts to prevent drownings, from working with families of drowning victims to public education. The interest today is to introduce himself to the committee, provide some information, and to promote water safety on the Great Lakes.

Dave Paul Benjamin, CoFounder and Executive Director, Great Lakes Rescue Project wanted to make sure that everybody is well aware that the beach flag system is a tool for lifeguards to use and not a replacement for lifeguards and that there needs to be dedicated beach staff to manage and monitor the flag system.

### **Approval of the Minutes**

Committee member Conklin asked for a motion for approval of the October 12, 2022 minutes. The motion was moved by Julie Clark, supported by Mike Foote, and passed unanimously.

It was agreed to move ahead with 2023 meeting dates in the same time format as last year. It was later suggested to try and hold one or two inperson meetings that include a tour of some facilities.

### Action

Deb Jensen presented the Aloha State Park GMP. Aloha has a long history, dating back to 1920, lots of repeat visitors and a strong community connection. Public input was good, with a large response to the online survey with over 1,000 responses. Action goals include determining the use for recently acquired property along Pioneer Road, implementing a tree replanting program, and to complete a natural resource stewardship plan. General Management Plan is attached.

Committee member Conklin asked for a motion of support for approval of Resolution No. 12-2022-04 to recommend approval of the Aloha State Park General Management Plan. Committee member Graham motioned, with

committee member Pitcher seconding. The resolution was passed unanimously.

Deb Jensen presented the Gete Mino Mshkiigan GMP. The property, a relatively small site at 147 acres north of Indian River, is located on the 17,000-acre Mullett Lake, with 1,500 feet of undeveloped lakeshore. The name was suggested by members of the Little Traverse Bay Band, which translates to "Ancient Good Wetlands." General Management Plan is attached.

Committee member Clark thanked the team for working closely with the tribes, along with the stakeholders and different user groups, and getting their input for the plan.

Resolution No. 12-2022-05

Committee member Conklin asked for a motion of support for approval of Resolution No. 12-2022-05 to recommend approval of the Gete Mino Mshkiigan General Management Plan. Committee member Graham motioned, with committee member Clark seconding. The resolution was passed unanimously.

### **Information Only**

Parks and Recreation, Ron Olson, Chief

Some cabinet changes were announced a few days ago, including the temporary moving of Director Eichinger to the Department of Environment, Great Lakes and Energy. Deputy Shannon Lott will be stepping in as acting director in the interim. Changes will take place January 1.

The camping and recreation trends are leveling off and still well above 2019. The budget is well underway, and efforts are being made to add more positions and formalizing short-term worker pay, which hopefully helps with recruitment.

A Land and Water Conservation Grant for \$3M was secured for restoration of the Cheboygan Lock.

Committee member Conklin suggested that as budget talks commence, to consider someone on the beaches to monitor the flags.

Advisory Boards Public Meeting Format Protocol, Ron Olson, Chief

Committees that fall under statute or that follow OMA are required to hold inperson meetings. Non-OMA committees will be migrating to in-person as well, but a hybrid option will be offered. He asked the committee what their preference would be. Suggestions included no winter travel but perhaps a few summer in-person meetings with possible site-seeing/tours, and possibly holding some in conjunction with NRC meetings. It was also stated that virtual meetings are efficient as well.

Flint State Park Update, Ron Olson, Chief

The 130-acre land lease has been approved unanimously by the Flint City Council. The lease is for 30 years with an option for two 30-year extensions. Land donations – General Motors land parcel approved. Private parcel donation and the County land (Chevy Commons) in process. Park development plan in-river details is being finalized.

### **ARPA Projects**

Brittany Ruff and Greg Kinser gave a general update on the ARPA project process. Nine projects are starting and actively in construction and a vast majority are in various stages of engineering. The complete report is attached. Updates were also given on the ongoing progress, including trail section staff changes, progress tracking, and future planning.

### **Generator Policy**

Jason Fleming updated the committee on the process that has been worked on while incorporating the state forest campgrounds from FRD to PRD. Workgroups were formed to look at the entire system and pull together an overview of what they were seeking to accomplish. Part of this process was surveying and coordinating with different groups. What was seen was a significant increase in state forest campground and rustic campground use and visitors bringing in their own amenities such as generators. A difficulty has been how to consistently manage generator use, so a Land Use Order will be drafted.

There was some discussion, and it was agreed to bring this before the Stewardship Subcommittee early next year to gather more input.

Summer Youth Employment – Postponed to the next meeting




