Addressing biological and/or social concerns







# **Tentative Fish Orders in Play**

- F.O. 200 Trout and Salmon
  - Stream designations
- F.O. 204 Spawning Closures
  - Closure adjustments
- F.O. 206 Special Regulations for Warmwater Species
  - Northern Pike and Largemouth Bass
- F.O. 210 Designated Trout Streams
  - Removals from list
- F.O. 215 Statewide Warmwater Species
  - Northern Pike Slot limit
- F.O. 254 Inland Trout Lakes
  - Designation changes

# Steelhead Update

- F.O. 200 Amendment

  Trout and Salmon
  - Reduced spring bag limit on limited streams this year
- Coldwater Resources Steering Committee February 22
  - Present November 2021 NRC presentation
- Develop angler survey regarding Steelhead Management
  - Targeting September
- Design creel surveys: Muskegon and Manistee Rivers
  - Likely October 2022 through May 2023
- Design research projects
- Continue angler conversations regarding Steelhead

#### Steelhead Research

- What is causing decreased recruitment of adult steelhead?
- Hypothesis: juvenile survival has decreased
- Study Proposal: evaluate the fate of juveniles during outmigration, compare among watersheds
- Spring 2022: feasibility test of survival, tag retention of surgically implanted "predation" tags in yearling steelhead
- If successful, submit funding proposals for 2023
- Project duration, 2 or 3 years.
- MDNR, INDNR, WDNR, CMU, USGS

#### **Additional Steelhead Questions**

- What is the fate of spawning run adult steelhead?
- Can we confirm our understanding of repeat spawners?
- What is the angling mortality on spawning steelhead?
- How often are spawners recaptured?
- What is their timing, movement and distribution?
- Utilizes acoustic telemetry tags and receivers
- Potential multi-year project
- Involves the angling community

# Saginaw River Walleye Update

- F.O. 206 Amendment-
  - Expanding angler opportunity 6 additional weeks
- Walleye will be abundant in the river
- Bay and river will have the same regulations in 2023
  - 8 fish DPL and 13" MSL
- Bay and river will be managed as single "stock"



## Saginaw River Access

- 12 miles of publicly accessible shore fishing
- 10 public launches
- 541 parking sites
- 40 launch lanes
- 19 publicly accessible shore fishing sites
- 6 weeks of creel
- Enhanced LED needs




# Saginaw River Outreach

#### **Future Committee Discussions**

- Regulation's discussions
  - Enhance NRC outreach
  - Move notification up 5 months
    - F.O. 210 Designated Trout Streams
  - Opportunity for in-depth conversations
- Research
  - Informs management
  - Costly to properly execute
  - Limited resources
  - Research takes time
  - Research asks can be difficult
