Subject: Parks and Recreation Division Management of State-Owned Lands – Metal  
Detecting  
Land Use Order of the Director Amendment No. 6 of 2023  
FOR INFORMATION ONLY

Authority:

The Natural Resources and Environmental Protection Act, 1994 PA 451, authorizes the Director to issue orders to implement land use rules.

Discussion and Background:

Periodically, the Parks and Recreation Division reviews the Land Use Orders that govern the lands it administers to determine whether any updates are necessary due to operational needs, statutes and/or clarifications to existing Land Use Orders. This proposed Land Use Order of the Director Amendment is a result of such efforts.

The Parks and Recreation Division has long recognized metal detecting as a recreational activity at appropriate locales. However, there is concern that metal detectors facilitate illegal removal of archaeological and historic resources and the following laws apply:

Public Act 451, [324.74102](#) mandates the protection of historic resources within State Parks.

[Public Act 238 of 1957](#) provides a means of disposing of personal property lost or abandoned on state property and is governed under DNR Policy 04.04.01.

Public Act 451 of 1994, [Part 761 Aboriginal Records and Antiquities](#), prohibits a person from removing, exploring, or excavating any relic or aboriginal antiquities and abandoned property of historical or recreational value found upon or within the lands owned by or under the control of the state.

The Parks and Recreation Division has had a policy for many years that prohibits metal detector use in areas that are known to have artifacts and designated historic or archaeological sites. These sites include those listed on the State or National registers of historic places or indicated by the State Archaeologist in the State Historic Preservation Office.

This proposed amendment would provide clarification on metal detector use that aligns with information readily available to the public on a department-managed website at <https://www.michigan.gov/dnr/places/state-parks/metal-detecting>. Although education and generating voluntary compliance will remain the primary enforcement tool, establishing these

prohibited activities will also provide necessary authority for prohibiting these activities in unwanted areas.





# **LAND USE ORDERS OF THE DIRECTOR**

## **Amendment No. 6 of 2023**

By authority conferred on the Director of the Department of Natural Resources by Section 504 of the Natural Resources Environmental Protection Act, 1994 PA 451, MCL 324.504, and in accordance with R 299.921 to R 299.933, the Director of the Department of Natural Resources orders the following:

### **5.26 Metal detector use in state parks and recreation areas, prohibited conduct.**

**Order 5.26. A person shall not do any of the following in any state park (SP) or recreation area (RA):**

**(1) Use a metal detector outside of a designated area illustrated as open on the access map as published on the department website by April 15<sup>th</sup> of each calendar year, without written authorization of the unit supervisor or manager.**

This order shall be posted on or after the 15th day of December 2023.
